- 3. Scenario 3 Revised boundaries between Canadian Martyrs Catholic Elementary and St. Alfred Catholic Elementary Schools

Superintendent Baldasaro provided background information pertaining to the identified schools in the St. Catharines Attendance Area Review from the April 23, 2013 Board Report, including an excerpt from Appendix B - Long Term Accommodation Review Resource Document by Watson & Associates Economists Ltd. detailing observations and projections of St. Catharines Attendance Area Review schools.

Superintendent Baldasaro also provided background information from the January 31, 2012 Board Report regarding the Closure of Michael J. Brennan Catholic Elementary School.

Potential attendance area scenarios were presented for discussion and consideration. School information was provided regarding current projected enrolment, utilization and surplus spaces for the St. Catharines Attendance Area Review identified schools.

A lengthy discussion took place between staff acting as resources to the Committee and the Committee regarding the potential attendance area scenarios. The Committee asked that the following information be brought back to the next meeting being held on September 25, 2013:

- 1. List of grandfathered students and their grades for the consolidated Michael J. Brennan/St. James Catholic Elementary School.
- 2. Scenario with larger area of change from the consolidated Michael J. Brennan/St. James Catholic Elementary School to St. Ann Catholic Elementary School.
- 3. Maps showing current catchment with overlay in different colour of proposed area of change.
- 4. Scenario showing plan to increase utilization at Our Lady of Fatima Catholic Elementary School and rationale.
- 5. Projections for French Immersion program at Our Lady of Fatima Catholic Elementary School.
- 6. List showing catchments where current French Immersion students at Our Lady of Fatima Catholic Elementary School come from.

- 7. Show enrolment, utilization and surplus space charts for scenarios together for Committee to see how scenarios change utilization in identified schools.
- 8. List of out of boundary students in over-enrolled schools in review area.
- 9. Secondary school projections for scenarios provided (Holy Cross and Saint Francis) for discussion by Committee.
- 10. Confirmation of intention for decision on grandfathered students confirm through minutes of public meetings.
- 11. List of grandfathered students in boundary who would be entitled to transportation as per Board policy.
