1. Review of Options Presented at October 9th and October 10th, 2013 Public Consultation Meetings

Kathy Levinski, Manager of Facilities Services reviewed information relating to attendance area Options 4, 8B and 10 which were presented for consideration and feedback at the October 9th and October 10th Public Consultation meetings.

Each of the proposed options was presented with extensive data including the current and revised boundaries, building utilization and school areas of change.

2. Review of Feedback from October 9th and October 10th, 2013 Public Consultation Meetings

Superintendent Baldasaro reviewed the feedback from the Public Consultation meetings of October 9th and October 10th and stated that feedback is limited due to the number of people that were in attendance. Information regarding attendance area options and transportation provisions as per Board policy was clearly stated. General feedback indicated that there was an understanding that an attendance area adjustment of some form will be required. No additional questions or comments have been received from the public regarding the Attendance Area Review Committee Public Consultation meetings.

3. Boundary Descriptions for Options

With input from Niagara Student Transportation Services (NSTS), boundary descriptions were revised. Kathy Levinski presented the boundary descriptions to Committee members for information and review.

A lengthy discussion was held regarding each of the proposed options. Alternate boundary lines were examined and a suggestion was made to take the northern portion of Canadian Martyrs boundary to Assumption. This will further increase utilization to Assumption and reduce the utilization of Canadian Martyrs. This option was dismissed as it did not make a significant increase in the utilization rate for Assumption.

Trustee Burtnik recommended using the boundary adjustments as in Option 8B for St. Ann and St. James plus the boundary adjustments to Our Lady of Fatima and Assumption as in Option 8B and the St. Alfred and Canadian Martyrs boundaries in Option 10 to create Option 11. Kathy Levinski presented the new boundary showing utilization and the number of students affected.

Using the Terms of Reference in determining the options for consideration, further discussion was held. After much deliberation a decision was made to present Option 11 for consideration and feedback at future Public Consultation meetings.
