1. Niagara Catholic Good Samaritan Award

Director Crocco informed Trustees of the new system award for Niagara Catholic students and staff, the "Niagara Catholic Good Samaritan Award". He stated that the Good Samaritan Award is presented to a student or staff member in recognition of their unselfish and exemplary service to another human being in need, and outlined the criteria.

Nominations for the award will be accepted by the Director of Education throughout the year, and presented to the recipient(s) at a meeting of the Niagara Catholic District School Board.

1.1 Meredith Vanderlee – St. Ann Catholic Elementary School, St. Catharines

Yolanda Baldasaro, Superintendent of Education, welcomed Vicky Wegelin, Principal of St. Ann Catholic Elementary School, who presented information on Meredith Vanderlee, Grade 2 student at St. Ann School, who called 911 when her mother had a seizure and conveyed information about her mother's condition to the 911 dispatcher. Meredith learned what to do in an emergency last May, when she visited the Niagara Region Children's Safety Village with her classmates.

On behalf of the Niagara Catholic District School Board, Chairperson Burtnik congratulated Meredith on her brave efforts, and along with Vice-Chairperson Charbonneau and Director Crocco presented her with the first ever Niagara Catholic Good Samaritan Award.

1.2 Father Fogarty Adult and Continuing Education Centre Emergency Response

Frank Iannantuono, Superintendent of Education, presented information on the valiant efforts of the Father Fogarty Adult and Continuing Education staff when one of their instructors collapsed in class.

NIAGARA CATHOLIC INTERNATIONAL COOPERATIVE EDUCATION PROGRAM (NCICE) DOMINICA 2011

BACKGROUND INFORMATION

Following an invitation to all secondary school students in Niagara Catholic and an extensive application and selection process, on September 24th, 2011 ten (10) Niagara Catholic District School Board students and two (2) teachers embarked on the three month placement portion of the second Niagara Catholic International Cooperative Education Program in Dominica.

Lead by teachers Jason Benoit (Lakeshore Catholic) and Amber Benoit (Saint Michael), the ten students who spent from September 24th to December 22nd, 2011 in Dominica were; Amanda Mills, Emma Hoad-Owen, Kayla Barrow, Matt Pattison, and Leah Taylor of Lakeshore Catholic High School; Kaleigh Flynn, Cassandra Rebrovich, Vanessa Zanchin, and Jessica Gorham of Saint Michael Catholic High School; Chris Belanger of Blessed Trinity Catholic.

As the coordinating school for the 2011 Niagara Catholic International Cooperative Education Program, Lakeshore Catholic High School students and staff have raised money, through their pilgrimages, and have visited Dominica for thirteen years. Every February, teachers and students travel to the Caribbean island of Dominica, which is the second poorest nation in the Western Hemisphere next to Haiti to work with the community to improve their level of education and their standard of living.

The students and staff participating in this year's Niagara Catholic International Cooperative Education Program lived for the three months in the convent of Portsmouth, Dominica which was graciously donated by Sister Alces Williams. In Dominica, students worked at four cooperative education placements. The first placement was at St John's Catholic Elementary School assisting classroom teachers in preparing, delivering, and assessing curriculum. The second placement was at the Northern District Home for the Aged "The Grange" which is the local seniors' home. Students assisted registered nurses Mariette and Lucille in the daily care of the residents. A third placement was at the Portsmouth Library. Students helped to organize and administer the day to day duties under the supervision of librarian, Monique Matthew. The students also organized and volunteered at a literacy club at the library. The fourth and final cooperative education placement was at the Centre where Adolescents Learn to Love and Serve. This is an alternative where students worked with Sister Betty Rae and Mrs. Douglas to teach life skills to the students of the centre.

In addition to our Niagara Catholic students earning four (4) cooperative education credits, all students were enrolled in three (3) academic credits as part of the seven (7) credit program. Mr. Benoit, Program Chair of Religious Education at Lakeshore Catholic delivered the curriculum for the Philosophy of Religion course (HZT 4U) and Mrs. Benoit a Science teacher at Saint Michael Catholic High School,

delivered the curriculum for Grades 11 and 12 Biology (SBI 3U/SBI 4U). Finally, Mr. and Mrs. Benoit, who were both collegiate athletes and are actively involved in their schools' co-curricular athletics program, jointly delivered the curriculum for the Grade 12 Physical Education course (PPL 4O).

Students and staff returned safely to Canada on Thursday, December 22, 2011 and have shared their exceptional experiential learning experience in Dominica with both their secondary school communities and the elementary schools within their respective Family of Schools.

A presentation by students and staff at the January Board Meeting will highlight the remarkable social justice experiences from the Niagara Catholic International Cooperative Education (NCICE) Dominica 2011 program.

Hello,

I am writing in regards to the proposed boundary changes for the Port Robinson area. After reviewing the e-mail I just received regarding the proposed changes, I do have some concerns.

My daughter Arianna Hetherington, currently attends JK at St. Charles school. We purchased our home (1456 Allanport Rd, Port Robinson) 5 years ago. My husband and I are originally from Niagara Falls.

Obviously when buying a home one of the important considerations to make is schooling. Since my husband and I knew that we wanted to have a family, we looked into which school we were connected to.

Since we live on Allanport Rd. I was told that St. Charles was our home school. For the past few months, Arianna has happily attended St. Charles. In an effort to become part of the Thorold community (Port Robinson is part of the city of Thorold), we signed Arianna up for dance lessons in Thorold. There she is familiar with many of the children she goes to school with, from St. Charles.

Now I am reading that suddenly our street will be deemed out of bounds, and our home school will now be St. Andrews in Welland. Had I known that 5 years ago, when purchasing this home, I would have reconsidered. It does not seem fair that suddenly she is not being provided transportation to a school that should continue to be her home school, since we are a part of the Thorold community. We have NO ties to the city of Welland, and frankly, I do not want he r attending a school in down town Welland, in a rough neighbourhood. We did not purchase this home with that intention. I would rather see her attend her home public school.

If transportation is to be continued until 2015-16 for Monsignor Clancy and Dennis Morris, why would it be discontinued for St. Charles as of 2012-13? It is currently all the same bus route! Transporting her to school everyday is not an option for us at this time.

In thinking ahead to the future, it makes most sense (in terms of distance) for those residing in Port Robinson to go to St. Micheal's High School. With this in mind, would it not make sense to bus students to Loretto Elementary school?

NOTRE DAME COLLEGE SCHOOL AND ASSOCIATED ELEMENTARY SCHOOLS AREA, AND PORT ROBINSON ATTENDANCE AREA AD HOC COMMITTEE REPORT

BACKGROUND INFORMATION

In compliance with the Niagara Catholic District School Board Attendance Areas Policy 301.3, an Ad Hoc Attendance Area Review Committee was formed in 2011 and 2012 to review attendance boundaries for the Notre Dame College and Associated Elementary School Areas, and for the Port Robinson Area.

As stated in the Report to the Committee of the Whole on November 9, 2010:

The attendance boundary for St. Andrew/Notre Dame College in Welland includes Port Robinson, which lies between the Welland Canal and the attendance boundary for Monsignor Clancy / St. Charles/Denis Morris located in Thorold/St. Catharines areas. Students from Port Robinson are attending Monsignor Clancy / St. Charles / Denis Morris as out-of-bounds students and have been provided with transportation due to the fact that a bus with surplus capacity has a route in the area. A review is required to determine whether boundary changes should be made to include Port Robinson in the Monsignor Clancy / St. Charles / Denis Morris attendance area, and if so, where the new boundaries should lie.

The following motion was approved at the December 7, 2010 Committee of the Whole Meeting: THAT the Niagara Catholic District School Board approve the continuation of the following Ad Hoc Committees for the year 2011:

- Notre Dame College and Associated Elementary Schools Areas and for the Port Robinson Attendance Area Ad Hoc Committee
- Niagara Falls Elementary and Secondary Family of Schools/St. George and St. Joseph (Snyder)
 Catholic Elementary Schools Attendance Area Ad Hoc Committee
- St. Catharines Elementary and Secondary Family of Schools Attendance Area Ad Hoc Committee

At the Board Meeting of February 22, 2011 and the Committee of the Whole Meeting of June 14, 2011, Director of Education, John Crocco presented information about the Attendance Area Ad Hoc Committees stating that the Attendance Area Ad Hoc Committee Meetings would begin in September 2011. The Attendance Area Review Committee for Notre Dame College and its associated elementary schools and Port Robinson was confirmed at the September 27, 2011 Board Meeting. A report would be presented no later than the January 2012 Committee of the Whole Meeting in preparation for February 2012 student registration.

The Attendance Area Review Committee for the Port Robinson area is comprised of Rhianon Burkholder (Chair), Trustee Ted O'Leary, Trustee Fr. Paul MacNeil, John Crocco, Director of Education, Lee Ann Forsyth-Sells, Superintendent of Education, Mario Ciccarelli, Superintendent of Education, James Woods, Controller of Plant Services, Kathy Levinski, Manager of Plant Services and Yvonne Anderson, Recording Secretary.

The first meeting of the Ad Hoc Attendance Area Review Committee was held on November 8, 2011 at 5:00 p.m. at the Catholic Education Centre. A recommendation was made that the Ad Hoc Attendance Area Review Committee would conduct a community meeting on Monday, November 23, 2011, in order to receive input from the Port Robinson families. Invitations were sent to the Port Robinson families and the Port Robinson Community meeting was held on November 23, 2011 at 7:00 p.m. at Saint Michael Catholic High School.

On November 28, 2011 an Ad Hoc Attendance Area Review Committee Meeting for the Port Robinson Area was held at 5:30 p.m. at the Catholic Education Centre to review the input from the Community Meeting. As a result of the community feedback, and information received from the Niagara Student Transportation Services (NSTS), the Committee made the recommendation to provide another opportunity for input from the community of Port Robinson.

A letter with a survey was sent to all families requesting a response by 4:00 p.m. on January 9, 2012 (Appendix A). The information from the completed surveys was reviewed by the Ad Hoc Attendance Area Review Committee at the January 9, 2012 meeting. In addition, several meetings with the Niagara Student Transportation Services (NSTS) were held in December 2011 to gather further information about transportation routes and the costs of transportation which was presented at the January 9, 2012 meeting.

At the Ad Hoc Attendance Area Review Committee for the Port Robinson Area meeting of January 9, 2012 (Appendix B: Unapproved Minutes of the January 9, 2012 Meeting) the committee reviewed the Parent/Guardian Survey submissions, a report from the Niagara Student Transportation Services (NSTS), and drafted recommendations to be presented at the Committee of the Whole Meeting of January 17, 2012.

ST. THOMAS MORE – OUR LADY OF MOUNT CARMEL

- 22 people in attendance 19 parents, 2 principals, 1 reporter (Richard Hutton, Niagara This Week)
- 19:05 Mark Lefebvre began the evening with a prayer and introduced the Director, Chair of the Board, Trustee Fera and Controller of Plant
- 19:10 Director of Education, John Crocco, presented an overview of the current business case application being made to the Ministry of Education concerning the potential for consolidating St. Thomas More School with Our Lady of Mount Carmel School pending funding for construction and renovation at that site for Sept 2013. The Board is considering a motion for possible consolidation at its January 31, 2012 meeting.
- 19:22 James Woods provided an overview of the report for the potential consolidation of STM and OLMC schools. An initial concept for possible renovations to OLOMC was presented to the assembly. A Kindergarten drop-off and a Kiss and Ride lot are planned for the renovated OLOMC site. The potential Ministry funding allocation for this project is estimated to be approximately 1.7 million dollars.
- 19:36 John Crocco spoke to the assembly about a potential transition plan for STM and OLOMC.
- 19:45 Director Crocco solicited feedback from the assembly
- Melissa Roma presented submissions on behalf of the STM and OLMC Catholic School Councils. A written report was provided as points of reference.
- The Chair of the Board requested and James Woods spoke to the cost of adding an addition to a building structure vs renovations. Adding an addition would be a costlier option.
- Melissa Roma suggested that students should not lose French and music classrooms, and second gymnasium. Mr. Crocco commented that some secondary schools do not have two gyms and dedicated French rooms are a luxury. The board will maximize any funding it may receive and look at all options within the funding.
- Trustee Fera asked Mr Woods to explain the current Ministry funding formula for any Early Learning classroom additions/improvements. Mrs. Racine asked if an addition could be completed without any additional classroom improvements. Mr. Crocco and Mr. Woods spoke about the Ministry parameters in securing funding from the Ministry and assured the assembly that the Board will work with the community in discussing options to maximize the facility.
- Mrs. Racine asked if funds from the sale of STM can be used to offset any additional costs
 for construction at OLMC. Mr. Crocco spoke to Ministry parameters for disposition of funds
 from the sale of surplus property. Chair Burtnik spoke to the Boards sensitivity for balancing
 the interests of all schools and all Board projects.
- Mrs. Byers inquired about the entrance of the proposed Kiss and Ride on Carlton Avenue and condition of sidewalks. The Director and Mr. Woods spoke about how the Board will consult with the City concerning any potential traffic issues.

- Mr. Crocco spoke to scenarios for the two schools should this potential Ministry funding not be realized. The current recommendations of the ARC and motions of the Board will be followed. Mr. Crocco spoke to population trends as the result of a question from the assembly.

INPUT FROM THE OUR LADY OF MOUNT CARMEL AND ST. THOMAS MORE CATHOLIC SCHOOL COUNCILS TO THE BOARD OF DIRECTORS AND SENIOR STAFF OF NIAGARA CATHOLIC DISTRICT SCHOOL BOARD

On behalf of the Our Lady of Mount Carmel and St. Thomas More Catholic School Councils, I am here to provide input to be brought back to the January 31, 2012, Board meeting.

We are grateful to have been given the opportunity to serve as Council members of these two outstanding schools. More importantly our children have been blessed with the outstanding academic excellence that has been provided by the administration and staff.

We are thankful to have had a very unique setting with the two sister schools but realize that the Board is moving towards consolidating the two schools. Therefore we wish to ensure that all opportunities that are currently available to our students will continue once the consolidation takes place.

After careful consideration and upon reviewing your proposed plan, we have the following comments to make.

It appears that you are proposing to take away one of the gyms at Our Lady of Mount Carmel by renovating it to move the CyberQuest room to this location, and then renovating the current Cyberquest room into classrooms.

Currently, this second gym is utilized by the students, and with the addition of approximately 170 more students, we feel it is essential to keep both gyms available to the students. In addition, we feel that CyberQuest should continue to be housed in its current location in the school, which is easily accessible at the front of the school by visiting students.

Instead, we are proposing that a separate wing be built onto the school which would contain classrooms to accommodate the Early Learning Program. In addition, as St. Thomas More currently has an extensive library and computer area, the separate wing should contain its own library to accommodate the primary children. Also we feel an extra washroom should be added to this wing which would be suitable for primary students. In order to preserve the St. Thomas More name, we feel that the wing should be named the St. Thomas More Early Learning Centre.

We understand that during the years between when our schools are consolidated and when the new school is built in Warren Woods, the students from Warren Woods will be attending Our Lady of Mount Carmel and there may be a possibility of having up to four portables during these years to accommodate these students. We feel that this can be avoided by adding the new wing.

Currently, there are no portables at either of our schools and as parents we will strongly resist the housing of students in portables. In addition, we are concerned that parents from Warren Woods may not send their students to Our Lady of Mount Carmel due to this possibility and may decide to have their children attend a school in the public board rather than come to our school. Also the proposed solution of using indoor classrooms in order to avoid portables is not suitable as there are no windows in the classrooms and these rooms are currently being used for other purposes.

The construction that is being proposed currently would create a large disruption and would have to be done during the summer months but we feel that the building of a primary wing could be started during the school year which would allow more time for the renovation to be ready for September.

In addition we want to ensure that our French rooms and Music room are not taken away from our students. Both schools have always had a separate French room which is very conducive to learning for the children. Our Music Room has been built with soundproof walls, amphitheatre seating as well as storage for all of the instruments.

Also the routine that the students develop in rotating to these classrooms is very beneficial for them for when they attend high school. These rooms do not have windows so accordingly they cannot be used as regular classrooms.

We are also concerned about the possible loss of our Learning Strategies room which currently serves to meet the needs of our exceptional students, as well as the book room which houses teacher resources that cannot be accommodated elsewhere. Again these rooms do not have windows and accordingly are not suitable for regular classrooms.

The plan indicates the addition of skylights to some of the interior rooms and we feel that all interior rooms would benefit from skylights.

The last comment we have is that you seriously consider the addition of an air conditioning system to the school for the comfort of our students.

This consolidation should serve to enhance the learning environment for our students and not to take away from what they currently have.

In conclusion, we need to remember that our goal is the best interests of our children, and our role as Catholic School Council is to ensure that this is never forgotten. We look forward to working with you to achieve this very important goal for our most precious gift - our students.

BACKGROUND INFORMATION

At the May 26, 2009 meeting of the Niagara Catholic District School Board, the Board approved eleven (11) motions which provided specific system direction and decisions following open, transparent and accountable Pupil Accommodation Reviews in Niagara Falls and St. Catharines.

The Pupil Accommodation Process was in full compliance with the Ministry of Education *Pupil Accommodation Guidelines*, and the Niagara Catholic District School Board Policy 701.2 – Closure of Schools / Accommodation Review Policy.

One of the eleven motions approved on May 26, 2009 is as follows:

"THAT, no sooner than September 2012 and subject to Ministry of Education funding and approval for a new school in the Warren Woods Estate and for an addition and renovations to Our Lady of Mount Carmel Catholic Elementary School, the closure of St. Thomas More Catholic Elementary School with the students relocated to Our Lady of Mount Carmel Catholic Elementary School."

In the spring of 2011, as part of the continued exploration of pupil accommodation options, Senior Staff provided all Trustees with a Pupil Accommodation Review and Attendance Area Review binder which included the following information:

- Ministry of Education Pupil Accommodation Review Guidelines
- Niagara Catholic Policy 701.2 Closure of Schools / Accommodation Review Policy
- Niagara Catholic Pupil Accommodation Review Schedule for 2008-2009
- Niagara Catholic Pupil Accommodation Review Guidelines for Public Input
- Pupil Accommodation Reviews for Niagara Falls Elementary, St. Catharines Elementary and St. Catharines Secondary Report
- Student Enrolment, School Utilization, Operating Costs and Projected Enrolment
- Copies of Presentations made by the Public at the Special Board Meetings
- Copies of Correspondence received as of February 10th, 2009
- Copies of Correspondence received between February 10th, 2009 and March 6th 2009
- Copies of the Board Approved Minutes for the three Special Board Meetings
- Niagara Catholic District School Board Approved Motions May 26th, 2009

Recently, Ministry of Education staff have stated that approval for capital funding for new schools in new developments such as Warren Estates will be given first priority. Ministry staff have also indicated a current opportunity to access Full Day Kindergarten funding for renovation and addition to Our Lady of Mount Carmel in order to consolidate the two schools for the commencement of the Early Learning Full Day Kindergarten Program in September 2013.

As indicated in the November 8, 2011 Follow-up Report to the May 26, 2009 Board Meeting (Appendix B), a business case submission from Senior Staff is required. However, Ministry staff have stated that they will only review the business case for funding consideration once the consolidation has been approved by the Board. Senior Staff fully intends to continue the open dialogue with the St. Thomas More Catholic community prior to presenting a Report to the Board on January 31, 2012 and throughout the business case submission process.

Senior Administrative Council recognizes that all options and recommendations affect the lives of our students and their families, as we continue to address the challenges associated with declining enrolment and neighbourhood population shifts.

Should the consolidation of St. Thomas More and Our Lady of Mount Carmel Catholic Elementary Schools occur, a seamless transition plan for the students of St. Thomas More Catholic will be implemented as they join a new school community in September 2013.

A conceptual floor plan of the addition and renovations to Our Lady of Mount Carmel is indicated in Appendix A.

RECOMMENDATION

THAT the Committee of the Whole recommend that the Niagara Catholic District School Board approve the consolidation of St. Thomas More and Our Lady of Mount Carmel Catholic Elementary Schools at the Our Lady of Mount Carmel site for September 2013, subject to funding approval by the Ministry of Education for renovation and addition to Our Lady of Mount Carmel Catholic Elementary School.

Senior Administrative Council has categorized the Board approved motions of May 26th, 2009 as Action, Monitor, Establish or Report as noted below including a follow-up statement on the motion(s):

Action

- 1. THAT, St. Joseph Catholic Elementary School be closed by September 2010 with St. Joseph students relocated through the Attendance Area process to St. Mary, St. Patrick and Father Hennepin Catholic Elementary Schools.
 - **Follow-up** This motion was actioned with the official closure of St. Joseph Catholic Elementary School in Niagara Falls on June 30^{th} , 2010.
- 2. THAT, no sooner than September 2012 and subject to Ministry of Education funding and approval for a new school in the Warren Woods Estate and for an addition and renovations to Our Lady of Mount Carmel Catholic Elementary School, the closure of St. Thomas More Catholic Elementary School with the students relocated to Our Lady of Mount Carmel Catholic Elementary School.
 - Follow-up Senior Administrative Council has submitted a business case to the Ministry of Education for funding for an addition and renovations to Our Lady of Mount Carmel Catholic Elementary School. Ministry of Education funding is required in order to consolidate St. Thomas More Catholic Elementary School with Our Lady of Mount Carmel Catholic Elementary School, and is subject to development in Warren Woods warranting the construction of a new Catholic elementary school.
- 3. THAT, Senior Staff will continue to apply to the Ministry of Education for additional funding and to identify other sources of funding in order to provide facility plant upgrades to St. Francis Catholic Secondary School.
 - **Follow-up** Senior Administrative Council continues to dialogue with Ministry of Education officials regarding funding sources for facility upgrades to St. Francis Catholic Secondary School.
- 4. THAT, Catholic Secondary Schools in St. Catharines will continue to have the opportunity to implement specialized programs providing sufficient student enrolment and Ministry of Education funding and approval.
 - Follow-up Since 2009, Catholic Secondary Schools in St. Catharines have implemented Specialist High Skills Major programs in Hospitality, Arts and Culture, Transportation, Construction, Non-Profit, Information and Communication, Environment, Health and Wellness, Manufacturing and Business. Additionally, new programs in Animation, Music, Theatre Art, Dance, Hair and Make up, Manufacturing, and Nutrition have been introduced through centrally budgeted Program Start-Up Funding.

Monitor

5. THAT, over the next five years Senior Staff will monitor student population growth, projections, location and accommodation data in the southern portion of the City of Niagara Falls and if required, apply to the Ministry of Education for capital funding for a new elementary school in the Warren Woods Estate of Niagara Falls.

6. THAT, the Board maintains all three Catholic secondary schools in St. Catharines and monitors the accommodation and utilization of all three Catholic secondary school facilities over the next five years.

Follow-up – Senior Administrative Council continues to monitor all of the variables required within these two motions.

Establish

- 7. THAT, a Niagara Falls Elementary and Secondary Ad Hoc Attendance Area Review Committee of the Board be established in September 2009 to review the attendance boundaries for all elementary and secondary schools in Niagara Falls. According to the Board's Attendance Area Policy 301.3, the mandate of the committee will be to recommend to the Board stability within all attendance areas while maximizing facility utilization of all elementary and secondary schools in Niagara Falls.
- 8. THAT, a St. Catharines Elementary and Secondary Ad Hoc Attendance Area Review Committee of the Board be established in September 2009 to review the attendance boundaries for all elementary and secondary schools in St. Catharines. According to the Board's Attendance Area Policy 301.3, the mandate of the committee will be to recommend to the Board stability within all attendance areas while maximizing facility utilization of all elementary and secondary schools in St. Catharines.

Follow-up – At the Annual Organizational Meetings of the Board in December 2009 and 2010, the Niagara Catholic District School Board approved the establishment of the Niagara Falls and St. Catharines Ad Hoc Attendance Area Review Committees of the Board.

Report

- 9. THAT, not later than September 2012, a report be brought to the Board on the closure of St. Nicholas Catholic Elementary School which would occur no sooner than September 2012. The report will include recommendations on student relocation through the Attendance Area process. The Board will pursue all avenues for a joint venture school with community partners and the Ministry of Education to provide confirmed funding and approval for a new downtown elementary school.
- THAT, Senior Staff will continue to monitor the possibility of closing Michael J. Brennan Catholic Elementary School and that Senior Staff will bring a report to the Board no later than September 2012.
- 11. THAT, Our Lady of Fatima Catholic Elementary School not be consolidated at this time subject to the Ad Hoc Attendance Area Review process and recommendations and that Senior Staff continues to monitor enrolment and report back to the Board no later than September 2012.

Follow-up – Senior Administrative Council continues to monitor enrolment in St. Catharines and submits to the Committee of the Whole of November 8^{th} , 2011, for its consideration recommendations as they relate to the May 26^{th} , 2009 Board motions.

With the closure of St. Joseph Catholic Elementary School in Niagara Falls, Senior Administrative Council continues to action, monitor, establish or implement the remaining ten (10) Board approved motions. In doing so, Senior Staff continually focuses and considers the following key factors in the decision making process;

- the continued delivery of Catholic educational excellence aligned with the Niagara Catholic Vision 2020 Strategic Plan, Annual System Priorities and the Mission, Vision and Values of the Board:
- the continuation of fiscal responsibility;
- the continued decline in enrolment which affects school boards throughout Ontario;
- the potential of a slight upward movement in the overall board enrolment over the next decade in some geographic areas within the Board;
- the multiple variables causing increased surplus space;
- the limited facility renewal and capital funds;
- the shifting demographics from neighbourhood schools;
- the increased potential of multiple combined grades; and
- the importance of addressing long term accommodation needs in all schools in Niagara Catholic.

Recommendations

Through a confluence of events including the uncertainty of the financial climate in Ontario, nationally and internationally which may have an impact on available capital funding for school boards, Senior Administrative Council is presenting the following recommendations to the Board in fulfillment of the May 2009 Board approved motions, whereby the Board directs Senior Administrative Council:

- 1. to continue to implement the May 2009 motions categorized under Action, Monitor and Establish;
- 2. to design and implement a plan to reduce surplus space usage in all facilities and report to the Board on the specific strategies utilized;
- 3. to design and implement a plan to reduce cost associated with surplus space in all facilities and report to the Board on the cost reductions;
- 4. to continue the review of all potential boundary adjustments to minimize specific enrolment pressures in Niagara Falls and St. Catharines and present options and recommendations to the standing Ad Hoc Attendance Committees of the Board;
- 5. to continue to research all potential school organizational options for the consideration of the Board; and,
- 6. to defer the report timelines within the May 2009 Board motions categorized under Report until no later than December 2012 and that within the report to the Board submit recommendations on the implementation of the May 2009 Board motions as required.

Above all, Senior Administrative Council continues to recognize that all options and recommendations affect the lives of our students and their families, as we continue to address the challenges associated with declining enrolment and neighbourhood population shifts.

The Board and affected communities can be assured that Senior Administrative Council, together with Principals, Vice-Principals, school and Board level staff will continue to work in a collaborative, transparent and open process with all Catholic educational partners in fulfilling the results of the Pupil Accommodation Review process and the May 2009 Board Motions.

RECOMMENDATION

MINUTES

MICHAEL J. BRENNAN/ST. JAMES COMMUNITY INFORMATION MEETING

TUESDAY JANUARY 24, 2012

- 47 people in attendance (Approx. 20 are parents, 2 principals, remaining teachers)
- Yolanda Baldasaro began meeting at 7:05 p.m by leading a prayer. She introduced Kathy Burtnik, Chair of the Board, Trustees Charbonneau and Burkholder, John Crocco, Director, and James Woods, Controller of Plant
- Director of Education, John Crocco, presented an overview of the ARC and PAR process and of the current business case application being made to the Ministry of Education concerning the potential for consolidating Michael J. Brennan with St. James pending funding for construction and renovation at that site for Sept 2013. The Board is considering a motion for possible consolidation at its January 31, 2012 meeting. John explained that parents have the opportunity to send letters and information to John or Kathy before the Board meeting for trustees' consideration and advised of the process to make a delegation to the Board meeting.
- James Woods provided an overview of the report for the potential consolidation of MJB and SJ schools. An initial concept for possible renovations to SJ was presented to the assembly. An addition of three purpose built kindergarten classrooms and renovations to other classrooms as well as site improvements are shown on the conceptual drawing. The potential Ministry funding allocation for this project is estimated to be approximately 1.3 million dollars. James explained the surplus spaces currently in St. Ann and Assumption Schools and the possibility of expanding the boundaries to better utilize those schools.
- John Crocco spoke to the assembly about a potential transition plan for MJB and SJ.
- John solicited feedback from the assembly.
- Daniela Lafrail-MJB parent asked which boundaries are being considered the boundary plan shown could mean all four schools would change, not just doing things with SJ.
- John explained that the first step is sending the business case to Ministry to consolidate MJB and SJ school buildings. Boundary considerations are not part of business case. Boundary consideration is a different process and a boundary review would be the next step after the funding is secured. John provided information regarding Ad Hoc committees for boundary changes in different parts of St. Catharines.
- Justine Carpenter-MJB parent Changing the boundaries after the fact seems backwards, a lot of
 people would be ticked off if they are put together then moved around. What would happen if
 construction is not completed by September 2013? There is no mention of portables at the new SJ
 site.
- John advised that we still have MJB site to accommodate students if necessary. No portables are proposed. Potentially there could be portables down the road, depending on enrolment.
- Parent: MJB has small class sizes, what are the expected class sizes at SJ we don't like the idea of our kids getting lost in the shuffle.

- John confirmed that the success of our students, in partnership with parents is based on the
 excellence in Catholic education delivered daily by our talented staff and lead by our exemplary
 Principals in schools throughout Niagara Catholic and specifically at MJB and SJ as represented by
 staff here tonight.
- Parent: Will the current teachers at MJB move to SJ?
- John: Staff and Human Resources will provide a process regarding movement to school sites and positions. There will be an open dialogue with staff to determine what the placements will be.
- Parent: What happens if the Board or Ministry do not approve recommendations for funding?
- John: We will go back and reconsider our options with senior staff. The Board could use other funds.
- Parent: What will happen to the other half of MJB?
- John: There is a provincial process in place, we may need the building until November before we vacate, and then offer to coterminous Board, they have 90 days to review.
- Kim, MJB parent: I have a child currently attending MJB and I have another child who would be starting JK in September. It is a critical year, what do you suggest?
- John: Enrol your child in the MJB school community so that classmates will transition together.
 When we closed St. Joseph School in Niagara Falls, we heard from concerned parents after the
 closure who told us that their children were not as anxious as they thought they would be. The
 transition plan is important.
- Parent: Will daycare be available?
- John: Daycare will continue as per our current process.
- Bianca, parent: How many classrooms are there currently at St. James? How will 150 MJB students fit into the new SJ site?
- James: There are 7 classrooms, 2 kindergarten rooms and 3 portables used as classrooms. The proposal is based on consolidation and consideration of boundary changes. There will have to be 13 classrooms and 3 kindergarten rooms for all the MJB students to fit at the St. James site.
- Bianca: Can this concept of proposing a different concept be brought forward to the Board to accommodate all of the students from MJB into the SJ site?
- James: Yes.
- Kathy Burtnik: Trustees will be asking questions about the business case. We have not engaged in any discussion about the business case with staff. We want to know if the business case goes forward will it tie our hands? Your question will be asked, the Board will not make its decision based on silent assumptions. Right now, the only motion is consolidation of MJB and SJ. It makes sense from an enrolment point of view. We are not going to tie together; we have a real and transparent process. We have an open process for redesigning boundaries; it is a different conversation than what is being considered about a consolidation. Moe, myself and Rhianon are here and will bring your concerns forward.
- Justine, parent: Mr. Woods said that the proposal considers boundary changes. Mrs. Burtnik said that the boundary changes are a different process.

- John: This is one scenario that has been presented. One issue is MJB and SJ consolidation, boundary changes is a different process; this is one of the concepts.
- Parent: Do you need MJB to amalgamate with SJ to get the funding?
- John: Funding is available from Full Day Early Learning Kindergarten funding. The
 recommendation is for consolidation of schools. The proposal shown by Mr. Woods is a concept;
 we may need to ask for additional funding.
- Parent: Does the current design accommodate all of the students from MJB into SJ?
- James: We would need to add six additional classrooms.
- Parent: Will the Ministry be given the student enrolment numbers?
- John: This motion going forward does not have anything to do with changing boundaries it is for the consolidation of school buildings, that is a different process.
- Parent: How will the classes be amalgamated between both schools are you going to mix up the MJB and SJ kids?
- John: We are very sensitive to the needs of the students and will blend as best we can. During the transition staff will talk and make the best decisions.
- Parent: Students who are currently out of bounds, will they be able to continue at SJ?
- John: If out of boundary has been granted, then students can continue to attend per our Board policy. If there is a reason for a change, parents are always notified by April the year before.
- Parent: If you do change boundaries, will students be able to finish off in the school they started in?
- John: Decisions will be determined as per attendance area review process; usually changes in boundaries come into effect the next school year.
- Tammy, SJ parent: My children go to St. James, what happens if the construction is not finished in September 2013?
- John: We will provide programs at either MJB or SJ and during the construction process we will be creative to accommodate student programming.
- Tammy: What is the anticipated start date for construction?
- James: We haven't planned that far yet, there is a process. We would probably begin during March break and finish by the middle of August.
- Danielle, parent: What would be the name of the school?
- John: Traditionally, we keep the name of the site that is being renovated, in this case SJ, but we would recognize MJB in some manner such as naming the library information centre after MJB. We ask for parental input from MJB about how to amalgamate into SJ
- Danielle: Is there a concern about losing students to the public school board?
- John: We hope that if a parent has a concern, that they will contact the school principal, family of schools superintendent, director or trustees.

- Jerry, parent: Your proposed plan being submitted for renovation will not hold all the kids, you guys
 are in it for the money, and are doing this all backwards. You should design a school to hold all of
 the MJB kids.
- John: This is a draft concept, we have a limited amount of funding and we must look at the entire Board. Our opportunity now is due to ELKP funding that is available. We went through the ARC process and the decision was made to continue to review, and there was always the potential to consolidate. The Ministry said that there was a window and we thought it would be prudent to apply. If they say no, the Board could decide to use other funds.
- Parent: The plan should have been proposed for a school to hold all of the students from MJB and SJ.
- John: We have neighbouring areas with surplus space; it would be irresponsible of us not to look at
 our fiscal responsibility. We can't say we are open, honest and engage parents if we don't go
 through this process.
- Danielle, parent: Can we get a copy of the slide show?
- John: The presentation will be posted as a PDF on the Board website tomorrow morning.
- Justine, parent: When the ARC review happened in 2009 were there plans developed for school buildings?
- John: No, there were no plans at the time. The mandate was to look at the accommodation of our students. Now the Board is looking at how we will implement.
- Parent: If you did not get information about being able to apply for money, would the consolidation be brought forward so quickly?
- John: Probably not.
- Parent: Can you apply for funding without the amalgamation of two schools?
- John: No, the Ministry knew about surplus spaces and the potential of consolidation. The motion has to be attached to the business case.

John concluded the meeting at 8:55 p.m. by thanking everyone for their input and advising that staff and trustees would remain to answer questions or send an email to John or Kathy. All comments will be shared with the rest of the Board. Communities will be notified of the Board decision and any Ministry approvals.

I hope all is well! I am contacting you as the father of two children who attend Michael J. Brennan Elementary. My son Michael is nine and in grade 4, and my daughter Molly is seven and in grade 2. Both are proud members of the MJB community. Each has flourished at the school, and been given so many opportunities to grow there. My wife Krissy and I are thankful that MJB has been the foundation for our children.

While we are extremely disappointed that MJB is going to close, we understand the "business" of closing this school and moving them into St. James. For Michael he is leaving MJB a year earlier. He will finish grade 5 at MJB then be moving to St. James for grades 6, 7 and 8. Molly will be moving after her grade 3 year. Both children are prepared for this move, and infact in someways looking forward to the new friends, teachers and environment. They have always known they would move on to St. James for grade 7 and 8, so it is not a complete shock to them.

This brings me to my major concern. At the meeting last night at MJB, the discussion turned to boundaries. That combined with that fact that my children are ok with the move to St. James because they expected it eventually and because they will have their basis of friends at St. James makes me ask was the boundary discussion accurate? It is of real concern to my family and I am hoping you can ease our minds regarding it. If you have an opportunity to get back to me, I would appreciate it.

Ladies and Gentlemen,

I understand dwindlingschool enrolment has forced the Board to make some difficult decisions in the past.

Last week a letter was sent home with my children from Yolanda Baldasaro stating the Committee of the Whole was recommending the Board approve the consolidation of Michael J. Brennan with St. James Catholic School. In the same correspondence, an invitation for a community information evening was extended.

Knowing MJB was to be continually monitored and watching our school's population slowly start to shrink, myself and many other parents knew consolidation with St. James was inevitable for our MJB community.

Like many other parents at MJB, prior commitments prevented me from attending the information evening – which proved to be quite informative indeed.

Tonight I viewed the presentation featured at the information evening presented by John Crocco on January 24th. I fully expected to see the plans to renovate and construct an addition to St. James Catholic Elementary School in order to accommodate the displaced students of Michael J. Brennan, but I did not expect to see this.

Maps of proposed boundary adjustments illustrating the west side of Lake St., directly opposite Michael J. Brennan, were to fall under St. Ann's jurisdiction. Students residing at 691 Lake St. would, under the proposed boundary adjustments, have to travel 3.8 km to another school, instead of the 18 seconds it would take for students to cross the street to MJB located at 690 Lake St.

Although in Yolanda's letter she states:

"As part of Niagara Catholic's continued open and transparent communication with our school communities, we are extending an invitation to all parents/guardians to attend a information meeting ... regarding the recommended consolidation of the Michael J. Brennan and St. James Catholic School communities."

No mention of boundary adjustments on this correspondence. This by my definition is not transparent at all.

Also the document featured on the Board's website regarding the consolidation of Michael J. Brennan and St. James Catholic Elementary Schools states on page 3:

"Should the consolidation of Michael J. Brennan and St. James Catholic Elementary Schools occur, a seamless transition plan for the students of Michael J. Brennan Catholic will be implemented as they join a new school community in September 2013."

The proposed boundary adjustments outlined in the presentation would affect more than one third of the students currently attending MJB. I know it will not be "seamless" for the 50+students who will not move to St. James with their dassmates. There will also be approximately 15 students currently attending St. James who will no longer live within the proposed boundary adjustments and will be uprooted and expected to leave their school to attend Assumption.

As CSC chairperson of MJB, how am I to explain the information that was presented Tuesday evening to the parents of the children who will not be making this "seamless transition" to St. James when the letter/invitation sent home only stated in the recommendation the consolidation of the two schools?

I ask you to consider the recommendation made by the Committee of the Whole to approve the consolidation of Michael J. Brennan and St. James Catholic Elementary Schools without the review of boundary adjustments for three years.

If we must all leave, let us leave together.

As members of the Niagara Catholic family, we would like our letter to be presented and read to the Board of Trustees during the Board meeting on Tuesday January 31st, 2012. Please ensure that it is included in the public minutes.

We expect the motion to go forward as presented, to consolidate our two communities St. James Catholic Elementary School and Michael J. Brennan Catholic Elementary School. We would like the board to put forth the business case WITHOUT any boundary change, as consolidation means everyone coming together under one roof. We are well aware that this will include a slightly larger addition to St. James than the concept presented to us. As a community we have come accustomed to a school site which includes portable classrooms. It is fair and reasonable that portables would be present at the St. James site. Clearly the current site size has more than enough space to house these changes.

The invitation to the Community Information meeting held at Michael J Brennan on Tuesday January 24th 2012 only spoke to the consolidation of one Community to another which we fully support. It did not address the impact that the business case will have families unaware of the potential shifts in boundaries. We were clearly informed of a consolidation of 2 schools. St. James and Michael J Brennan Communities are both willing and accepting of the consolidation. Our definition of a consolidation is the amalgamation of Michael J Brennan and St. James School communities as population presently exists. A consolidation will fully maintain existing boundaries <u>exactly</u> as they exist at present with no boundary reviews. Furthermore, we would expect that there will not be any boundary reviews for a minimum of 3 years after the consolidation and any future boundary review suggestions should follow the board policy.

Following the minutes from the ARC meetings, we know that the following schools were involved: St. Nicholas, St. Denis, Our Lady of Fatima, St. James and Michael J. Brennan. Assumption and St. Ann were not part of this review. Our understanding of this committee is that only schools involved can be a part of the consolidation, closure and related boundary changes. Our Catholic School Councils are under the understanding that the Attendance Area Review Committee has not had a meeting since 2009. The lack of involvement and communication with Michael J Brennan and St. James parents proves neglectful of following the Board policies.

The statement of Policy states: The Board acknowledges that there may be changes to school attendance areas from time to time, to accommodate the changing demographics of the region and as schools open or close. Changes to school attendance areas will follow a public consultation process.

Upon reviewing the motion to consolidate St. Thomas More and Our Lady of Mount Carmel schools in Niagara Falls, clearly shows their boundaries remain intact. We, as 2 schools representing one community expect the same.

In closing, we are asking that you respect the integrity of the original recommendation as written:

THAT the committee of the Whole recommend that the Niagara Catholic District School Board approve the consolidation of Michael J. Brennan and St. James Catholic Elementary Schools at the St. James site for September 2013, subject to funding approval by the Ministry of Education for renovation and addition to St. James Catholic Elementary School.

As a member of the Niagara Catholic family, I would like this letter to be presented to the Board of Trustees during the Board meeting on Tuesday January 31st, 2012. Please ensure that it is included in the public minutes.

As a parent of two students who attend Michael J. Brennan, we were invited to attend the Community Information meeting held at Michael J Brennan on Tuesday January 24th 2012. The information regarding this meeting sent home from the school indicated we would review information about the consolidation of Michael J. Brennan and St. James schools. Much to my surprise and the shock of other parents in attendance, we were informed that not only was the School Board planning on closing Michael J. Brennan, but they were going to be changing the school boundaries in order to accommodate this 'consolidation'. The original recommendation put forth to the Committee of the Whole on December 2, 2008 clearly states:

"that the consolidation of Michael J. Brennan with St. James Catholic Elementary School takes place not prior to September 2010, and not prior to an addition/renovation and the completion of facility renewal needs to St. James to accommodate the enrolment."

In this recommendation there clearly is no mention of boundary changes. The addition to St. James School is clearly marked to accommodate the entire enrollment from Michael J. Brennan. It does not take into account anything but the whole consolidation of Michael J Brennan into St. James. If you look up the definition of consolidation, you will find it reads:

"the act of combining things to form a new whole, consolidating two or more things; union in (or into) one body".

At the meeting held on Tuesday January 24, 2012, I raised the question – if the Ministry had not made the deadline for the funding for the FDK now, would the Board even be looking at this consolidation at this moment. And the answer was 'no'. Too often decisions are made on a rushed basis, only to find mistakes have been made after the fact. These are our children we are talking about, and mistakes cannot be made when it comes to their wellbeing. We have invested too much time into their education, and lives to have an outside party make a rushed and uninformed decision on their behalf.

We understand that the Board has to look at the financial restrictions of running schools that are under capacity. We understand that the consolidation between Michael J Brennan and St. James School was a serious recommendation. However, not once was it mentioned that the boundaries were going to be changed in order to facilitate this. My two children are deeply upset that their school will be closing. They enjoy the school immensely, enjoy being known by all the teachers and students who attend, but to tell them that their best friends from Junior Kindergarten will not being making the move to St. James with them is too much. My son was in tears at this thought. And it is my job and duty as his parent to stand up for him and make this right.

The Board is <u>not</u> being transparent in their actions when they presented this motion of the consolidation of the two schools. The timing is too fast and doesn't allow for all parties to be considered fairly and equally. It does not allow for the true meaning of the word consolidation to take place as it was originally recommended in 2008. We accept that the consolidation of Michael J. Brennan and St. James School will occur, but we will NOT accept any boundary changes in order to facilitate this consolidation.

Thank you for your time. I expect that every effort will be made in order to follow the original recommendation of consolidating Michael J. Brenan and St. James School, under one renovated and accommodating roof for all to be at the same school.

Thank you for your information that was provided on January 24, 2012, unfortunately I was unable to attend. Thanks to the parent council committee of Michael J Brennan and St. James we were able to meet and review the slides from this meeting and share in our thoughts regarding the upcoming proposed changes. It is clearly understood that the two named schools will be consolidating in near future. It is also understood that there is an opportunity to secure funding for a new addition that would be based on acquiring ministry funding for the ELK program. As a business person and a parent in the community I understand that change is necessary and support both the plan to acquire ministry funding and to consolidate our two schools (Michael J Brennan and St. James) that reside in the same demographic area. Unfortunately with inadequate demographic explanations and illogical reasoning it has come to my knowledge that school boundary changes were also suggested at this meeting. I as the other parent find this both offensive and unacceptable. I would like a to see a public review of the persons responsible for such suggestions and the LOGICAL basis in which these ideas were formed! I feel they have blatantly disregarded the communities involved and are overlooking the natural demographic boundaries involved. To be specific in my case my two boys currently attend Michael Brenan and would be required to attend St. Annes in port Dalhousie. Again I understand that over time that change is necessary as demographics change and opportunities for additional programs and funding become available. My boys have had a great experience with the school system and carry a kind regard to the staff that keep these building running. The issue I have with this scenario is that it seems that these suggested boundaries did not take into consideration bussing, walking and the children's desire to continue their education with their peer that they have spent their last several years with. If the boundary changes made sense I may not be so offended by the suggestions, unfortunately they do not and I have no interest in my children walking through port Dalhousie to return home. I do understand that children are resilient and would probably manage just fine after some time and make new friends. The way I see It is that the suggested demographic boundaries to not appear to fall within the same area? Do you follow? I have not met these trustee members or the director/ treasurer or the person responsible for the designs of these schools. But I would recommend as often done in contracting that these proposals be carried out by outside member's as from what I see is there is a poor track record for adapting to the demographics and building quality schools. When examining the proposed design of St. James I quickly noticed one set of washrooms for all students!! The addition also included a demolition of area that could probably be well used if a quality architect were to be consulted. I feel that often when a system or body employs an internal person responsible for the complete design you end up with classrooms without windows! And schools with one washroom. I hope that you will take my thoughts into consideration and understand that I am pleased with the education process but displeased with those who make such suggested changes with apparently no sensitivity to the communities parents and students.

In conclusion I fully support the additions to St.James school for the purpose of acquiring funding for the ELK program. I aslo support the consolidation of Michael J.Brenan and St.James schools. I believe with a WELL planned out design St.James (portables are acceptable and efficient ways of adapting) would be capable of blending the populations and acquiring the ELK program simultaneously. I request that once this change is made that no further BOUNDARY ideas be withheld for 3 years to allow the community to adapt. The suggested boundary changes are foolish and illogical and I strongly disagree. The designer of the schools thus far has proven himself inept and the job should be contracted out(These are our children not inmates puts some skylights in!!!). I'm sure your architect looks out the window as he

designs these schools and renovations. Further two sets of washrooms will be required if any payment has been made to the proposed design I say you are wasting our money GET another opinion! Please.

Please understand that you have offended the members of this school community. But if highly paid people are not doing their jobs and making rash decisions affecting many people without due consideration then change your people! REPORT TO THE BOARD MEETING OF TUESDAY JANUARY 31, 2012

CLOSURE OF MICHAEL J. BRENNAN CATHOLIC ELEMENTARY SCHOOL

BACKGROUND INFORMATION

At the January 17th, 2012 Committee of the Whole Meeting, a presentation was made to Trustees entitled Pupil Accommodation and Attendance Area Exploration Phases. The presentation provided a number of options under exploratory consideration by Senior Administrative Council to implement specific decisions as approved by Board motions on May 26th, 2009. The motions followed an open, transparent and accountable Pupil Accommodation Reviews in Niagara Falls and St. Catharines which were in full compliance with the Ministry of Education *Pupil Accommodation Guidelines*, and the Niagara Catholic District School Board Policy 701.2 – Closure of Schools / Accommodation Review Policy.

One of the eleven motions approved on May 26th, 2009 was:

"THAT, Senior Staff will continue to monitor the possibility of closing Michael J. Brennan Catholic Elementary School and that Senior Staff will bring a report to the Board no later than September 2012"

Following continuous deliberations within Senior Administrative Council, on November 8th, 2011 the Board approved the following motion:

"to defer the report timelines within the May 2009 Board motions categorized under 'Report' no later than December 2012 and that within the report to the Board submit recommendations on the implementation of the May 2009 Board motions as required."

As reported to the Committee of the Whole on January 17th, 2012, in late December 2011 Ministry of Education staff indicated to Board staff that an opportunity was available for Niagara Catholic to apply for Full Day Kindergarten funding for renovations and an addition to St. James Catholic Elementary School commencing September 2013. Ministry staff indicated that the Board would be required to submit two requirements for funding consideration; (1) a Board motion to confirm the closure of Michael J. Brennan Catholic Elementary School; and (2) a business case outlining the specifics of the funding requirements. For the consideration of funding, both the Board motion and the business case would be required to be submitted to the Ministry of Education by January 31st, 2012.

As a result of the funding information and the potential for Niagara Catholic to receive Ministry of Education funding for an addition and renovations to St. James Catholic Elementary School, on January 17th, 2012, the Committee of the Whole approved the following motion:

"THAT the Committee of the Whole recommend that the Niagara Catholic District School Board approve the consolidation of Michael J. Brennan and St. James Catholic Elementary Schools at the St. James site for September 2013, subject to funding approval by the Ministry of Education for the renovation and addition to St. James Catholic School."

Given that Senior Administrative Council and the Board recognizes that all options and recommendations affect the lives of our students and their families as it continues to address the challenges associated with declining enrolment and neighbourhood population shifts, it was decided to continue our open and transparent process and invite families of both Michael J. Brennan and St. James Catholic Elementary School communities to a Community Information Evening on January 24th, 2012. The purpose of the meeting was to share the most recent information with the communities, illustrate a conceptual renovation and addition to St. James Catholic (Appendix A) and to engage those in attendance in an open dialogue prior to the Board considering the recommendation from the Committee of the Whole at the January 31st, 2012 Board Meeting.

As stated at the Community Information Meeting, to ensure that the Board was informed of the feedback from the January 24th, 2012 meeting, families were invited by the Director of Education to either delegate to the Board or forward correspondence to either the Chair of the Board or the Director of Education by noon on Friday, January 27th, 2012 to be included with the January 31st, 2012 Board Agenda. A copy of the agenda, minutes and correspondence received by noon on Friday, January 27th, 2012 were provided to the Board and are located in Section 3.3.1 of the January 31st, 2012 Board Agenda.

In consideration of the feedback received through the public consultation process at the Michael J. Brennan / St. James Catholic Elementary School Community Information Evening coupled with the opportunity for Niagara Catholic to apply for Ministry of Education funding for an addition and renovations to St. James Catholic Elementary School and in compliance with the key factors in the decision making process as shared with the communities (Appendix B), Senior Administrative Council is recommending to the Board the following;

- a) Subject to Ministry of Education funding, the closure of Michael J. Brennan Catholic Elementary School by September 2014;
- b) Subject to Ministry of Education funding, students attending Michael J. Brennan and St. James Catholic Elementary Schools as of February 1st, 2012 be grandfathered, including siblings, until completion of Grade 8 at the St. James Catholic Elementary School site commencing September, 2014;
- c) In compliance with Board Policy 301.1 Admission of Students, effective February 1st, 2012 out of boundary requests will not be granted for Michael J. Brennan and St. James Catholic Elementary Schools based on current or revised attendance area boundaries;
- d) Direct the St. Catharines Attendance Area Review Ad Hoc Committee to commence deliberation and public consultation on revised attendance area boundaries for defined areas of St. Catharines and provide a report and recommendations to the Board no later than June 2012;
- e) Revised attendance area boundaries for Michael J. Brennan and St. James Catholic Elementary Schools, excluding students grandfathered as of February 1st, 2012, will be in effect for the September identified by the St. Catharines Attendance Area Review Ad Hoc Committee and approved by the Board.

Should the Board receive the required Ministry of Education funding and close Michael J. Brennan Catholic Elementary School by September 2014, school and board staff will design a transition plan for the students and staff of Michael J. Brennan Catholic Elementary School.

RECOMMENDATION

THAT, subject to Ministry of Education funding, the closure of Michael J. Brennan Catholic Elementary School by September 2014;

THAT, subject to Ministry of Education funding, students attending Michael J. Brennan and St. James Catholic Elementary Schools as of February 1st, 2012 be grandfathered, including siblings, until completion of Grade 8 at the St. James Catholic Elementary School site commencing September, 2014;

THAT, in compliance with Board Policy 301.1 Admission of Students, effective February 1st, 2012 out of boundary requests will not be granted for Michael J. Brennan and St. James Catholic Elementary Schools based on current or revised attendance area boundaries;

THAT, the St. Catharines Attendance Area Review Ad Hoc Committee be directed to commence deliberation and public consultation on revised attendance area boundaries for defined areas of St. Catharines and provide a report and recommendations to the Board no later than June 2012;

THAT, revised attendance area boundaries for Michael J. Brennan and St. James Catholic Elementary Schools, excluding students grandfathered as of February 1st, 2012, will be in effect for the September identified by the St. Catharines Attendance Area Review Ad Hoc Committee and approved by the Board.



CONSOLIDATION OF MICHAEL J. BRENNAN AND ST. JAMES CATHOLIC ELEMENTARY SCHOOLS

At the May 26, 2009 meeting of the Niagara Catholic District School Board, the Board approved eleven (11) motions which provided specific system direction and decisions following open, transparent and accountable Pupil Accommodation Reviews in Niagara Falls and St. Catharines.

The Pupil Accommodation Process was in full compliance with the Ministry of Education *Pupil Accommodation Guidelines*, and the Niagara Catholic District School Board Policy 701.2 – *Closure of Schools / Accommodation Review Policy*.

One of the eleven motions approved on May 26, 2009 is as follows:

"THAT, Senior Staff will continue to monitor the possibility of closing Michael J. Brennan Catholic Elementary School and that Senior Staff will bring a report to the Board no later than September 2012"

In the spring of 2011, as part of the continued exploration of pupil accommodation options, Senior Staff provided all Trustees with a Pupil Accommodation Review and Attendance Area Review binder which included the following information:

- Niagara Catholic Policy 701.2 Closure of Schools / Accommodation Review Policy
- Niagara Catholic Pupil Accommodation Review Schedule for 2008-2009

- Pupil Accommodation Reviews for Niagara Falls Elementary, St. Catharines Elementary and St. Catharines Secondary Report
- Student Enrolment, School Utilization, Operating Costs and Projected Enrolment
- Copies of Presentations made by the Public at the Special Board Meetings
- Copies of Correspondence received as of February 10th, 2009
- Copies of Correspondence received between February 10th, 2009 and March 6th 2009
- Copies of the Board Approved Minutes for the three Special Board Meetings
- Niagara Catholic District School Board Approved Motions May 26th, 2009

On November 8, 2011 the Board approved: (Appendix B)

"to defer the report timelines within the May 2009 Board motions categorized under 'Report' no later than December 2012 and that within the report to the Board submit recommendations on the implementation of the May 2009 Board motions as required."

The deferral was due to an uncertainty of funding availability for the necessary renovation and expansion to St. James Catholic Elementary School to incorporate the Michael J. Brennan students, and the need for the continued exploration of accommodation options by Senior Administrative Council.

Recently, Ministry of Education staff have indicated an opportunity to access Full Day Kindergarten funding for renovation and addition to St. James Catholic, in order to consolidate the two schools for the commencement of the Early Learning Full Day Kindergarten Program in September 2013.

A business case submission to the Ministry of Education from Senior Staff will be required. However, Ministry staff have stated that they will only review the business case for funding consideration once the consolidation has been approved by the Board. Senior Staff fully intends to continue the open dialogue with the Michael J. Brennan Catholic community prior to presenting a Report to the Board on January 31, 2012 and throughout the business case submission process.

Senior Administrative Council recognizes that all options and recommendations affect the lives of our students and their families, as we continue to address the challenges associated with declining enrolment and neighbourhood population shifts.

Should the consolidation of Michael J. Brennan and St. James Catholic Elementary Schools occur, a seamless transition plan for the students of Michael J. Brennan Catholic will be implemented as they join a new school community in September 2013.


A conceptual floor plan of the addition and renovations to St. James Catholic is indicated in Appendix

BACKGROUND INFORMATION

At the May 26th, 2009 meeting of the Niagara Catholic District School Board, the Board approved eleven (11) motions (Appendix A) which provided specific system direction and decisions following open, transparent and accountable Pupil Accommodation Reviews in Niagara Falls and St. Catharines.

The Pupil Accommodation Review process was in full compliance with the Ministry of Education *Pupil Accommodation Review Guidelines*, and the Niagara Catholic District School Board Policy 701.2 – Closure of Schools / Accommodation Review Policy.

In the spring of 2011, all Trustees were provided with a Pupil Accommodation Review and Attendance Area Review binder which included the following information;

- Ministry of Education Pupil Accommodation Review Guidelines
- Niagara Catholic Policy 701.2 Closure of Schools / Accommodation Review Policy
- Niagara Catholic Pupil Accommodation Review Schedule for 2008-2009
- Niagara Catholic Pupil Accommodation Review Guidelines for Public Input
- Pupil Accommodation Reviews for Niagara Falls Elementary, St. Catharines Elementary and St. Catharines Secondary Report
- Student Enrolment, School Utilization, Operating Costs and Projected Enrolment
- Copies of Presentations made by the Public at the Special Board Meetings
- Copies of Correspondence received as of February 10th, 2009
- Copies of Correspondence received between February 10th, 2009 and March 6th, 2009
- Copies of the Board Approved Minutes for the three Special Board Meetings
- Niagara Catholic District School Board Approved Motions May 26th, 2009

Senior Administrative Council has categorized the Board approved motions of May 26th, 2009 as Action, Monitor, Establish or Report as noted below including a follow-up statement on the motion(s):

Action

- 1. THAT, St. Joseph Catholic Elementary School be closed by September 2010 with St. Joseph students relocated through the Attendance Area process to St. Mary, St. Patrick and Father Hennepin Catholic Elementary Schools.
 - **Follow-up** This motion was actioned with the official closure of St. Joseph Catholic Elementary School in Niagara Falls on June 30^{th} , 2010.
- 2. THAT, no sooner than September 2012 and subject to Ministry of Education funding and approval for a new school in the Warren Woods Estate and for an addition and renovations to Our Lady of Mount Carmel Catholic Elementary School, the closure of St. Thomas More Catholic Elementary School with the students relocated to Our Lady of Mount Carmel Catholic Elementary School.
 - Follow-up Senior Administrative Council has submitted a business case to the Ministry of Education for funding for an addition and renovations to Our Lady of Mount Carmel Catholic Elementary School. Ministry of Education funding is required in order to consolidate St. Thomas More Catholic Elementary School with Our Lady of Mount Carmel Catholic Elementary School, and is subject to development in Warren Woods warranting the construction of a new Catholic elementary school.
- 3. THAT, Senior Staff will continue to apply to the Ministry of Education for additional funding and to identify other sources of funding in order to provide facility plant upgrades to St. Francis Catholic Secondary School.
 - **Follow-up** Senior Administrative Council continues to dialogue with Ministry of Education officials regarding funding sources for facility upgrades to St. Francis Catholic Secondary School.
- 4. THAT, Catholic Secondary Schools in St. Catharines will continue to have the opportunity to implement specialized programs providing sufficient student enrolment and Ministry of Education funding and approval.
 - Follow-up Since 2009, Catholic Secondary Schools in St. Catharines have implemented Specialist High Skills Major programs in Hospitality, Arts and Culture, Transportation, Construction, Non-Profit, Information and Communication, Environment, Health and Wellness, Manufacturing and Business. Additionally, new programs in Animation, Music, Theatre Art, Dance, Hair and Make up, Manufacturing, and Nutrition have been introduced through centrally budgeted Program Start-Up Funding.

Monitor

5. THAT, over the next five years Senior Staff will monitor student population growth, projections, location and accommodation data in the southern portion of the City of Niagara Falls and if required, apply to the Ministry of Education for capital funding for a new elementary school in the Warren Woods Estate of Niagara Falls.

6. THAT, the Board maintains all three Catholic secondary schools in St. Catharines and monitors the accommodation and utilization of all three Catholic secondary school facilities over the next five years.

Follow-up — Senior Administrative Council continues to monitor all of the variables required within these two motions.

Establish

- 7. THAT, a Niagara Falls Elementary and Secondary Ad Hoc Attendance Area Review Committee of the Board be established in September 2009 to review the attendance boundaries for all elementary and secondary schools in Niagara Falls. According to the Board's Attendance Area Policy 301.3, the mandate of the committee will be to recommend to the Board stability within all attendance areas while maximizing facility utilization of all elementary and secondary schools in Niagara Falls.
- 8. THAT, a St. Catharines Elementary and Secondary Ad Hoc Attendance Area Review Committee of the Board be established in September 2009 to review the attendance boundaries for all elementary and secondary schools in St. Catharines. According to the Board's Attendance Area Policy 301.3, the mandate of the committee will be to recommend to the Board stability within all attendance areas while maximizing facility utilization of all elementary and secondary schools in St. Catharines.

Follow-up – At the Annual Organizational Meetings of the Board in December 2009 and 2010, the Niagara Catholic District School Board approved the establishment of the Niagara Falls and St. Catharines Ad Hoc Attendance Area Review Committees of the Board.

Report

- 9. THAT, not later than September 2012, a report be brought to the Board on the closure of St. Nicholas Catholic Elementary School which would occur no sooner than September 2012. The report will include recommendations on student relocation through the Attendance Area process. The Board will pursue all avenues for a joint venture school with community partners and the Ministry of Education to provide confirmed funding and approval for a new downtown elementary school.
- THAT, Senior Staff will continue to monitor the possibility of closing Michael J. Brennan Catholic Elementary School and that Senior Staff will bring a report to the Board no later than September 2012.
- 11. THAT, Our Lady of Fatima Catholic Elementary School not be consolidated at this time subject to the Ad Hoc Attendance Area Review process and recommendations and that Senior Staff continues to monitor enrolment and report back to the Board no later than September 2012.

Follow-up – Senior Administrative Council continues to monitor enrolment in St. Catharines and submits to the Committee of the Whole of November 8^{th} , 2011, for its consideration recommendations as they relate to the May 26^{th} , 2009 Board motions.

With the closure of St. Joseph Catholic Elementary School in Niagara Falls, Senior Administrative Council continues to action, monitor, establish or implement the remaining ten (10) Board approved motions. In doing so, Senior Staff continually focuses and considers the following key factors in the decision making process;

- the continued delivery of Catholic educational excellence aligned with the Niagara Catholic Vision 2020 Strategic Plan, Annual System Priorities and the Mission, Vision and Values of the Board:
- the continuation of fiscal responsibility;
- the continued decline in enrolment which affects school boards throughout Ontario;
- the potential of a slight upward movement in the overall board enrolment over the next decade in some geographic areas within the Board;
- the multiple variables causing increased surplus space;
- the limited facility renewal and capital funds;
- the shifting demographics from neighbourhood schools;
- the increased potential of multiple combined grades; and
- the importance of addressing long term accommodation needs in all schools in Niagara Catholic.

- 5. to continue to research all potential school organizational options for the consideration of the Board; and,
- 6. to defer the report timelines within the May 2009 Board motions categorized under Report until no later than December 2012 and that within the report to the Board submit recommendations on the implementation of the May 2009 Board motions as required.

Above all, Senior Administrative Council continues to recognize that all options and recommendations affect the lives of our students and their families, as we continue to address the challenges associated with declining enrolment and neighbourhood population shifts.

The Board and affected communities can be assured that Senior Administrative Council, together with Principals, Vice-Principals, school and Board level staff will continue to work in a collaborative, transparent and open process with all Catholic educational partners in fulfilling the results of the Pupil Accommodation Review process and the May 2009 Board Motions.

The Ministry presented on Special Education funding (see attached presentation), SEAC Roles and Responsibilities, and MACSE Recommendations on Building Capacity of SEAC. The information that was presented made us aware that the numbers being reported around children who are deaf or hard of hearing are inconsistent and unreliable. We know that 3 of every thousand births is a child with a hearing loss and that this number increases with age. The numbers reported in school Board reports typically only include those who are formally identified. Also, children with hearing loss can sometimes be reported under another exceptionality if they have multiple needs. This also raised questions as to the accuracy of the other exceptionalities and their numbers being reported. I put forth a request of our Administration to obtain the total number of students in our Board, number of identified students with hearing loss in our Board and the number of "actual" (not identified) students who are deaf or hard of hearing in our Board. This information will be passed onto VOICE and will help support our advocacy for guidelines and funding to effectively meet the needs of students with hearing loss.
- Also attached is an update on the VOICE AVT (Auditory Verbal Therapy) Mentorship program from Anita Bernstein.
- Our new Parent Mentor Program is getting underway. The first training for mentors was conducted earlier this month. Parent Mentors in the communities will be able to interface with their SEAC representatives and the Provincial Infant Hearing program to provide seamless support to families.

The presentation from the OPP highlighted the need to educate students on the safe use of the internet at an early age, stressing that delaying the education until a later age was leaving children at risk. They also reviewed the potential problems children encounter on the internet, especially bullying, and the supports the police departments are willing to provide to schools and emphasized on the legislated duty for schools to act in cases of "internet bullying".
 - This material is to be implemented in the classroom this year, and materials containing lesson plans have been provided to all school boards.
 - Aside from the new material for specific instruction, most of the other recommendations
 are already implemented in Niagara Catholic's policies for Safe Schools and partnerships
 with community partners, i.e. the Niagara Regional Police Services.

MID-YEAR PROGRESS REVIEW OF THE NIAGARA CATHOLIC SYSTEM PRIORITIES 2011-2012

BACKGROUND INFORMATION

At the May 24th, 2011 meeting of the Niagara Catholic District School Board, the following motion was approved;

THAT the Niagara Catholic District School Board approve the Niagara Catholic Strategic Directions Priority Indicators 2011-2012, as presented. (Appendix A)

The Niagara Catholic Strategic Directions Priority Indicators 2011-2012 are designed to provide the annual focus for the system towards achieving the outcomes of the Niagara Catholic Vision 2020 Strategic Plan. Within the two (2) Strategic Directions and the seven (7) Enabling Strategies are the approved system priority indicators which provide the specific framework to measure the achievement of each direction and strategy within our multi-year strategic plan.

The Board approved Strategic Directions Priority Indicators 2011-2012 were posted on the Niagara Catholic website and copies were provided to Bishop Bergie, the Diocese of St. Catharines, Special Education Advisory Committee (SEAC), Catholic School Council Chairs and the Niagara Catholic Parent Involvement Committee (NCPIC). In addition, a poster size copy of the Niagara Catholic Strategic Direction Priority Indicators 2011-2012 were displayed in public locations in all schools, Board sites and the Catholic Education Centre for review by students, staff, parents and guests to Niagara Catholic.

As we reach the approximate mid-point of the 2011-2012 academic year, Senior Administrative Council conducted its annual mid-year review of the progress in achieving the indicators of success within each Strategic Direction and Enabling Strategy. The results of the mid-year review were collated and reviewed by Senior Administrative Council, administrators and Board staff as a measurement of our success to date in achieving each priority indicator by the conclusion of the academic year. Principals will conduct similar discussions with staff on the implementation of system priorities and the measurements of success following a presentation to Principals at the February Director's Meeting.

Attached to this report (Appendix B) is a copy of the redesigned Mid-Year Progress Review of the Niagara Catholic System Priorities for 2011-2012. Within each Strategic Direction and Enabling Strategy is the indicator of success and comments on the measurables to determine the achievement of either *Action Required, On Target or Completed.*

With the majority of indicators directly linked to final achievement results at the conclusion of the 2011-2012 school year, members of Senior Administrative Council, administrators and Board staff will collate, analyze and review all data gathered for the 2011-2012 school year and present a final report to the Board and to all stakeholders at the September 2012 Board Meeting.

The annual final report will provide evidenced based information on the achievement of the Board's annual system priorities and the achievement of specific expectations within Niagara Catholic's multi-year strategic plan, Vision 2020.

Niagara Catholic Celebrates Class of 2029 at Second Annual Baby Celebration

The guests of honour ranged in age from one-year-old Joshua Gualtieri, born last January 5th, to 19day-old Rocky Sacco, who was born on December 30th. Donna Dalgliesh, Co-ordinator of the Ontario Early Years Centre at Mary Ward Catholic Elementary School in Niagara Falls, and Early Childhood Educator Theresa Sottile led activities for the event and provided books for the babies and information for parents. The packages also included special Niagara Catholic bibs and wooden crosses, which were hand-made by a member of the community and donated anonymously to Niagara Catholic last year. Working Together for Kids' Mental Health

Working Together for Kids' Mental Health ran from September 2010 to June 2011 in five Niagara Catholic schools. It was designed to address and build a child and youth mental health system that was coordinated, collaborated and integrated at all community and government levels. The program has been extended through the Special Education Services to all Niagara Catholic

Students aged four to 17 who met criteria through the school based team process as having possible mental health or behavioural concerns were the participants in this study.
