STAFF DEVELOPMENT DEPARTMENT PROFESSIONAL DEVELOPMENT OPPORTUNITIES

BACKGROUND INFORMATION

In alignment with the Board's Vision 2020 Strategic Plan and Annual System Priorities, the Department of Staff Development, as an integral aspect of its mandate, acts as the point of co-ordination among various departments. Thus ensuring that all professional development opportunities for staff, both teaching and non-teaching, occur in a seamless fashion so as to minimize disruptions to the myriad services provided within our Niagara Catholic community.

PRESENTATION BACKGROUND

Committee of the Whole Meeting November 7, 2017

PILGRIMAGE SUNDAY 2017

On Sunday, October 29, 2017, approximately 3,450 Niagara Catholic students, staff, trustees, alumni, parents and community members pilgrimaged through the streets of the Niagara Region in the 42nd Niagara Catholic Pilgrimage as they visually demonstrated the charisms and virtues of our Catholic schools. This Niagara Catholic tradition demonstrates the work of the Holy Spirit bringing hope, faith and love to God's children. This year's Catholic Education Week theme of *Renewing the Promise* as explained by Brian O'Sullivan, Director of Catholic Education of the Ontario Catholic Trustees' Association, is exemplified by this tradition. "*Renewing the Promise* speaks of the unique mission of Ontario Catholic education, the importance of its shared leadership by all those involved in Catholic education and the critical role of Catholic education in contemporary society" The Niagara Catholic 2017 Pilgrimage did just that.

Through the support of leaders at all levels of our Catholic school system the students of our Niagara Catholic Family, through this year's Pilgrimage, raised over \$160,000 for developing countries around the world. Their Catholic Education has afforded them the opportunity to show their love for their brothers and sisters in Christ. Sacrificing their time and energy and collecting money for those in need, our students strive to meet the needs of our ever changing world.

As in the past, social media and print communication was used to evangelize. Communication through Twitter, Facebook, Instagram and our local newspapers promoted and celebrated this year's pilgrimage. News of the money our Niagara Catholic students raised and the causes they supported quickly spread throughout the Niagara Region.

Blessed Trinity Catholic Secondary School

In the gospel, Jesus gives us two great commandments, love of God and love of neighbour. Pilgrimage Sunday began with Bishop Bergie celebrating mass with the Blessed Trinity Community in our gymnasium. In his homily, he emphasised that our Pilgrimage fulfils these commandments and consequently, this walk has purpose. We are united in faith, drawn together in a common mission, to help our brothers and sisters in the Dominican Republic. Our theme, "Two Families, One World" reminds us that we are all children of God, called to love and serve those less fortunate around the world. This year marks the 15th annual Pilgrimage through the streets of Grimsby where 430 participates raised a record \$20,000. We are proud that our students, in solidarity with all the students of Niagara Catholic, brought the gospel to life through this event.

Holy Cross Catholic Secondary School

This year's theme "The Future Is In the Hands of You and Me" focused on the power of the individual to choose a more just future. On Sunday October 29th, 160 Raiders confidently walked forward toward that very goal of creating substantial change in a broken world. Holy Cross Catholic Secondary School continued our longstanding tradition of supporting our sisters and brothers in the Global South through our annual Pilgrimage in support of Haiti. With our dollars, and the grassroots work of Holy Cross Sisters and Fathers in Haiti, we support the children of Regina Assumpta Elementary and Secondary Schools and the children of Holy Cross Elementary School in Thibeau, Haiti. Additionally, our funds support housing, food and medical aid for those who are in desperate need. Through our investment in long term social justice projects, we continue to build sustainable change that affirms the dignity and worth of those we serve.

Saint Francis Catholic Secondary School

On Sunday, 308 Phoenix gathered, joined by 30 staff and parents to begin our day with a short prayer service and messages of encouragement and thanks from Haiti. We set out despite the grey skies and drizzling rain to show that our theme of "Where is the Love?" was not an empty question, but a call to action. \$31,000 have already been raised to support Marie Immaculee School and Porte du Ciel Orphanage in Haiti, the Centro d'Esperanza in Guatemala, Fog Quest in Guatemala, and the Dominican Canadian Organic Farming project in the Dominican Republic. The downtown loop was a wonderful symbol of all three schools walking in solidarity before returning to market square for a simple lunch and signing of the pilgrimage crosses.

Denis Morris Catholic High School

There were 475 students and staff members who gathered Sunday morning and walked their 24th Pilgrimage in the spirit of Pope Francis recognizing and exemplifying that "Mercy is not easy... It requires courage." They walked throughout the city streets to the Market Square where they celebrated a beautiful mass alongside their friends from Holy Cross Catholic and Saint Francis Catholic. This year Denis Morris Catholic raised over \$15,000. These proceeds will be shared among L'Ecole Imaculee Conception in Pilate, Haiti, the Wells of Hope Projects in the Jalapa region of Guatemala, and a variety of local charities.

Note: Pilgrims from the three St. Catharines' Catholic secondary schools met downtown at the Market Square to participate in the annual Pilgrimage Mass, this year celebrated by Father Michael Prieur, assisted by Deacon Brian Prieur, where Fr. Michael Prieur challenged us to reflect on the value of every life, as he recalled the ministry of the late Fr. Trevor Plug.

Saint Paul Catholic High School

On Sunday, October 29, 2017, approximately 340 Saint Paul Catholic High School students and staff, under the leadership of the School's Chaplain, Patricia Morgetano, teacher, Ms. Joanne Santini and the Pilgrimage committee collected \$16,000 for the students at 'Ste. Croix de Milot' in Milot, Haiti. The theme song, "Where is the Love?", which was played every morning before announcements, reminded students that even though we are miles apart, our love for them is still strong and we will continue to do our part to assist them.

Saint Michael Catholic High School

This year, 452 Saint Michael Catholic Mustangs walked together in solidarity with our brothers and sisters in Rwanda. Our Mustangs raised \$21,000 to support the Hope for Rwanda's Children fund. The money goes towards scholarship support for the survivors of the Rwandan genocide and their families. Our theme this year was "Walk On", a call to continue to "walk the walk" no matter the challenges we face in doing so. This year our student-led Pilgrimage committee designed and presented a kick off assembly that featured a dramatic presentation, a Family-Feud style game with teachers and students, a live cover of U2's Walk On song and even a dance-off between Mikey the Mustang and Pat the Patriot.

On Pilgrimage Sunday, the weather was damp and cold but our spirits were high. Our day began with Father Jay Comerford celebrating Mass with us and then together with Saint Paul Catholic, the Pilgrims made their way through the streets of Niagara Falls. A highlight of this year's route was the use of a large stretch of the newly constructed Millennium Trail through Niagara Falls. We were thrilled with the positive response and tremendous support that we received from our community.

Note: The Pilgrimage Committees of Saint Paul Catholic High School and Saint Michael Catholic High School take turns hosting and organizing the Mass and Pilgrimage route through the streets of Niagara Falls. These schools join together to promote justice and witness solidarity to the residents and tourists. This year, Saint Michael Catholic hosted and all pilgrims began the day with a liturgy. Both schools featured the gifts and talents of student cantors, musicians, and a student choir.

Notre Dame College School

Approximately 900 students, staff, parents and alumni walked fourteen kilometres from Notre Dame Catholic to the Forkes Rd. Bridge in Dain City and back for our sacred Eucharist and candlelight prayer at 1 p.m.. The theme of Notre Dame's 42nd annual Pilgrimage for the Developing World was 'Balancing the Scales of Justice'. Grade level assemblies during the first week of October focused on the Catholic Social Teachings of Solidarity, Common Good, Dignity of the Human Person, Dignity of Work and a Preferential Option for the Poor. The message is that if all of us actively live these teachings every day, we would enjoy a more balanced world filled with justice. The \$38,000 raised will once again be divided between Development and Peace (D&P), Yancana Huasy in Lima, Peru, and the Dominican Canadian Community Development Group. Rev. Jim Mulligan, C.S.C. (founder of the NCDSB Pilgrimage) celebrated Mass. Rev. Gerald Cormier, C.S.C. (visiting from his home base in Haiti) concelebrated.

Lakeshore Catholic High School

Lakeshore Catholic's theme this year was 'Walk of Champions'. Over 200 Gator students and staff began the day with mass celebrated by Father Patrick Gilmurray. They walked through Port Colborne's streets and the Friendship Trail to raise money for their brothers and sisters in Dominica. The \$10,000 raised will support St. John's Elementary School, CALLS Alternative Learning Centre, Portsmouth Public Library, and CARE Distribution Centre.

TEACHER OF THE BLIND AND LOW VISION – MEETING THE UNIQUE EDUCATIONAL NEEDS OF STUDENTS WITH VISUAL IMPAIRMENTS THROUGH INSTRUCTIONAL STRATEGIES AND TECHNOLOGY

BACKGROUND INFORMATION

The role of the Teacher of the Blind and Low Vision directly aligns with the Ministry of Education goal of Ensuring Equity and the Niagara Catholic Vision 2020 Strategic Direction "To advance student achievement for all".

The Teacher of the Blind and Low Vision directly support students within their home schools to learn essential skills to successfully access the Ontario curriculum.

Nearly 80% of all learning is visual. This presents a unique challenge for students who are visually impaired. Students with visual impairments require direct instruction in literacy, visual efficiency, accessing the curriculum and require educational interventions that are beneficial to students in the educational setting. In addition to the core curriculum, students with visual impairments require instruction in a unique set of skills-The Expanded Core Curriculum. Intervention from the Teacher of the Blind and Low Vision is necessary to provide direct instruction in this area.

Assessment drives programming. In collaboration with the classroom teachers, Educational Resource Teachers and support staff, the Teacher of the Blind and Low Vision provides assessments unique to students with visual impairments to assist with programming to access the curriculum. Assessments of the students' functional vision, educational environment, learning media and use of perceptual vision is implemented into the students Individual Educational Plan (IEP) to be used within the classroom environment.

In alignment with the Niagara Catholic District School Board's Enabling Strategy to "Enhance technology for optimal learning", students with visual impairments utilize technology within the classroom. Instruction in the use of technology and assistive devices extends throughout a students' educational career within the Niagara Catholic District School Board. Technology for students with visual impairments provides access to information including the curriculum. Students are given the opportunity to take advantage of educational benefits provided by technology. Students need appropriate instruction provided by the Teacher of the Blind and Low Vision to use assistive and conventional technology effectively and independently. The use of technology is assessed and monitored to meet the changing the needs of the student.

Our Teacher of the Blind and Low Vision, Carole Vanderlee, will showcase the role and supports for students as part of this Committee of the Whole report.

Shining the Spotlight on St. Peter Catholic Elementary School



At each Board meeting, one Catholic elementary or secondary school or site is invited to attend the meeting to share what makes it such an important part of the community it serves.

During the October 24 Board meeting, St. Peter Catholic Elementary School was showcased in the School Excellence Program. Principal Victoria Wegelin was joined by

Kindergarten students Mason Nichols and Evan Pigeau, Grade 3 student Alexa Mlot-Styger and Grade 8 student Emily Slota, as well as Catholic School Council Co-Chair Lydia Morgan, who spoke about what St. Peter Catholic Elementary School means to them.

St. Peter Catholic Elementary School opened in a quiet neighbourhood in the south end of St. Catharines, right below the escarpment. There are currently 263 students from 161 families enrolled at the school.

The presentation began with Principal Wegelin, who brought along Mason and Nichols to show how well students work together. Asked what they learned from working with a

classmate, the smiled and said that they have learned how to collaborate! A huge word – and concept – for our youngest students to successfully grasp!

Principal Wegelin spoke about the close connection students and staff at St. Peter Catholic have with their parish, St. Julia, and also with Monsignor Clutterbuck, their spiritual leader who is a regular and familiar presence in the school, not only for mass and sacraments, but for other celebrations. They strive to find the face of Jesus in everyone they meet, noting that all students are gifts from God to be cherished.

The school adopts many social justice causes during the year, including the Holy Childhood Walk for the Holy Childhood Association, the Terry Fox Run, WE Day charities, Packs of Hope, and also collects non-perishable items for the St. Vincent de Paul Society's various drives throughout the year.



St. Peter Catholic is a member of the Denis Morris Catholic High School Family of Schools, and has a close connection with Denis Morris Catholic. Every grade spends a bit of time at the high school, whether it is for the annual Primary Christmas Party, art classes or the Grade 8 transition activities.

St. Peter Catholic has a strong foundation of faith, academics, athletics,

arts and community. Staff strive every day to ensure every student achieves their personal best, and staff are immensely proud when they see former Jaguars visit from Denis Morris Catholic and they see their success.

Students are provided with descriptive feedback from their teachers to assist in their progress, and help guide them to a higher level. Staff also look at the whole child and put a special emphasis on mental health and well-being. The Zones of Regulation concept and restorative circles, which empower students to make express themselves in a safe and nurturing environment.

Alexa spoke about her appreciation for all of the hard work teachers and staff put into masses, celebrations and other events such as masses, and liturgies, as well as into making sure lessons are fun as well as educational. She said the presentations provided to students – such as ones focused on bullying awareness and prevention – help create a kinder school climate for everyone.

She also spoke about the many parents who are actively involved in the school in many ways, from organizing events to putting together nutritious snacks through the SNAC program.

Emily spoke about her pride at being a senior student at the school, and the responsibilities entrusted to the St. Peter Catholic Class of 2018. Students are given

many opportunities to develop their leadership skills, from being the eyes and ears of the school, to being aware that there are many sets of eyes and ears on them during the day.

As co-President of the St. Peter Catholic Student Council, Emily also spoke about the many events and activities the Council plans for students, such as dances and fundraising programs, and about the exciting opportunities she and her classmates have to grow and develop their faith.

Finally, Mrs. Morgan spoke on behalf of Catholic School Council about the many excellent relationship between CSC and St. Peter Catholic staff, putting together programs, fundraising activities and other events, all to benefit the students at St. Peter Catholic Elementary School in a variety of different ways.

The OCSTA Annual General Meeting will once again offer an opportunity for delegates to consider and vote on all resolutions received from OCSTA members.

The study and processing of resolutions is one of the fundamental responsibilities of the Association. The resolution process provides member boards with the opportunity to shape the work of the Association by bringing important issues which have <u>provincial</u> implications to the attention of all trustees in the province.

During the year, important issues of a provincial nature that arise at the board level may be used to develop resolutions for OCSTA. Resolutions may be submitted to OCSTA any time up until the deadline of *January 31, 2018*.

Please Note:

OCSTA's Annual Finance Brief to the Minister and submission to the yearly Pre-Budget Consultation process serve as effective opportunities for advocacy regarding education funding issues. Boards are encouraged to submit education funding issues requiring Association action and advocacy throughout the year. However, should a board prefer to use the AGM Resolutions process for funding issues with provincial implications, they are, of course, welcome to do so. Funding issues submitted through the resolutions process may be recommended for inclusion in the OCSTA Finance Brief the following year. Resolutions may be submitted to OCSTA at any time up to the deadline of January 31, 2018.

Guidelines for Preparing Resolutions

To improve the effectiveness of the resolution process, we ask boards to review the following guidelines.

Resolutions are your opportunity to shape the work of the Association by addressing problems, solutions or concerns, which affect Catholic education in Ontario. A resolution approved by the membership at the Annual General Meeting calls for priority action by OCSTA and the commitment of OCSTA resources to address the particular issue outlined in the resolution.

A. All Resolutions will be reviewed by the Resolutions Committee and a Committee Recommendation will be added to each Resolution. Committee Recommendations will be guided by the following criteria.

The resolution:

- a. Is in keeping with the Mission, Vision and Strategic Priorities of the Association.
- b. Is of a provincial nature and addresses an area of concern for the province's Catholic school boards is a matter that requires attention or action.
- c. Is written in language appropriate for province-wide consideration (language contained in resolutions is often incorporated into subsequent communications to the government or other relevant parties).
- d. Is accompanied by substantiated rationale.
- e. Does not deal with education funding issues.
 - OCSTA addresses education funding issues in the Annual Finance Brief to the Minister and submission to the yearly Pre-Budget Consultation. Boards are encouraged to submit education funding issues requiring Association action and advocacy as they arise throughout the year.

B. Steps in Preparing a Resolution

- 1. Review the Mission, Vision and Strategic Priorities of OCSTA.
- 2. Identify the concern. Be sure the concern is a matter of **province-wide** scope.
- 3. Research and gather sufficient supporting background materials to substantiate the resolution. If the concern has been presented/dealt with in a previous resolution, review the outcome of that process to assess what changes in approach/additional information might be useful.
- 4. Write the resolution in the following proposed format taking care to ensure that:
 - a. Each "Whereas" is accompanied by adequate background material.
 - b. The "Therefore be it Resolved" directs OCSTA to take specific action.

C. Writing A Resolution

Structure

The resolution should be assigned a succinct title that identifies the problem or issue (or its proposed solution). There should be two parts to the resolution: a preamble followed by a resolving clause (or clauses).

1. Preamble

The preamble is a brief statement of background or rationale coming before the resolving clause(s). The purpose of the preamble is to provide information without which the point or the merits of a resolution are likely to be poorly understood.

Each clause in a preamble is written as a separate paragraph, beginning with the word "WHEREAS".

2. Resolving Clauses

A resolving clause indicates what action(s) is to be taken given the "WHEREAS" clause(s) in the preamble. If more than one action is being recommended, the "Therefore be It Resolved" portion should be divided into a), b), c), etc.

3. Submission Statement

Please include the following information in the submission statement.

[Mover's Name] [Seconder's Name] [Board Name] [Topic]

D. Submission Deadline Date

The <u>final</u> deadline date for receipt of resolutions in the OCSTA office is **12:00 p.m. EST**, **January 31, 2018**. We encourage boards to submit their resolutions at any time from May to January by email to Jane Ponte at <u>iponte@ocsta.on.ca</u>.

E. Regulations

Please see the attached current regulations regarding submission and presentation of resolutions at the AGM.

These guidelines and the enclosed template and the resolution session procedures have been provided as a reference that we hope you will find useful in preparing effective resolutions for your Association and Catholic education in Ontario.

Template

Please **do not use** tables, text boxes or any type of graphic or letterhead. The type of font to be used in this document is **Times New Roman 12pt**.

The following example is taken from a Resolution dealt with at a previous AGM and is provided for your reference.

Whereas: from time to time a vacancy occurs in the office of a member of the board;

Whereas: according to Section 221(1) of the *Education Act*, the vacancy must be filled

Whereas: boards choosing to appoint a new trustee will, most commonly, engage in an

open and fair process of selection; and

Whereas: the *Education Act* requires that the process be fully completed within 60

days of the office becoming vacant; and

Whereas: the 60 day time period may encompass a part of the year (e.g. Christmas,

summer months, March Break) when board operations and processes are

reduced, thus making the timelines very tight and, potentially,

unmanageable;

Therefore be it Resolved that:

OCSTA petition the Ministry of Education to review the section of the *Education Act* which relates to trustee vacancies with a view to extending the timeline by either increasing the number of days or altering the requirement that the process be completed within a designated number of regular school days.

Explanation of Committee Recommendations & Resolution Session Procedures

Resolution sessions will be conducted using "Robert's Rules of Order" and the provisions of the OCSTA Constitution. The chairperson of the session will ensure compliance with their rules.

Explanation of Committee Recommendations

The **Resolutions** Committee will study the resolutions and offer recommendations on the best way to meet their intent. The recommendations and their implications are:

i. **Approve**

The direction given in the "therefore be it resolved" section of the resolution will be carried out.

ii. Approve and refer to the committee for appropriate implementation.

The resolution will be forwarded to the designated committee for implementation.

iii. Receive and refer to the committee for study.

The resolution will be forwarded to the designated committee for study. Following the study and receipt of the committee's recommendation, the Board of Directors will determine whether or not the resolution will be implemented.

iv. Not approve

No action will be taken.

v. No recommendation

The committee is not making any recommendation with respect to the resolution.

vi. No action required

The intent of the resolution has been met. No further action will be taken.

Resolution Session Procedures

Delegates wishing to speak to a resolution must go to one of the floor microphones and state their name and the name of the board they represent.

The mover of a resolution will have the opportunity to be the first and last to speak to that resolution. Other trustees may speak **once** to a resolution.

The chairperson may declare a motion out of order giving the reasons for doing so. The chairperson's decision may be challenged by a majority vote of those voting delegates at the session when the vote is called.

Voting will be by a show of hands. Delegates carrying proxies must have and show proper identification i.e. proxy badge. Ballots will be provided in the event that a vote by ballot is called for.

Note Re Quorum: Quorum for the transaction of business at any meeting of the Members shall require the presence in person or by proxy of not less than a total of forty (40) current Members.

Grouped Resolutions

- a. the chair of the session will ask for a mover and seconder to approve the **grouping** of various related resolutions.
- b. the chair of the session will ask for movers and seconders for the committee recommendation for each group.
- c. delegates will vote on the committee recommendation for each group.

Delegates may request that any resolution(s) be removed from a "group" to be handled individually. These will be addressed when the group from which they have been removed has been dealt with.

Resolutions Handled Individually

These will include resolutions removed from the groups, resolutions for which the committee has not made any recommendation and resolutions from the floor.

A. Resolutions with committee recommendations

1.	The chair of the session will announce the resolution number and the name of the sponsoring
	board:

- □ the chair will call for the sponsoring board to move and second **the committee recommendation**;
- □ delegates will speak to the committee recommendation;
- delegates will vote on the committee recommendation.
- 2. If the sponsoring board does not move the committee recommendation from the floor:
 - the chair will call for the sponsoring board to move their **original resolution**;
 - □ delegates will speak to the resolution;
 - □ delegates will vote on the resolution.
- 3. If the original resolution is not moved by the sponsoring board, the resolution will be withdrawn.

B. Resolutions without committee recommendations

- 1. These resolutions will be handled as follows:
 - u the chair will call for the sponsoring board to move their **original resolution**;
 - □ delegates will speak to the resolution;
 - delegates will vote on the resolution.
- 2. If the original resolution is not moved by the sponsoring board, the resolution will be withdrawn.

C. Amendments from the Floor

Amendments made on the floor relate to the "therefore be it resolved" section of the resolution and **must be written out** and handed to the chairperson. The chairperson will consider the amendment and, if necessary, discuss it with the parliamentarian or others to ensure that it is clearly understood.

- □ the chair will **read** the amendment;
- □ delegates will speak to the amendment;
- □ delegates will vote on the amendment;
- delegates will vote on the resolution as amended.

If the amendment is defeated:

- delegates will be asked to speak to the original resolution;
- delegates will vote on the original resolution.

D. Members' Discussion Rights

Under Article 5.11 (*Members Discussion Rights*), a Member may raise a matter for discussion at the Annual General Meeting. Subject to the provisions in Articles 5.10.1 to 5.10.5, and 5.11, the item may be addressed, and may be referred to a committee of OCSTA for further consideration, but it shall not be put to a vote at the meeting at which it has been raised.

If the Member continues such discussion for three minutes or more, the Chair of the meeting may interrupt the Member and permit others to speak and/or make any subsidiary motion related thereto.

- 5.9.2 each such Resolution shall have been considered and reported upon by a Committee of the Board, or by the Board of Directors;
- 5.9.3 each such Resolution shall be circulated among all CDSB's not less than thirty (30) days prior to the Annual Meeting;
- 5.9.4 each such Resolution shall be included in the notice of the Annual Meeting; and
- 5.9.5 no such resolution shall be acted upon unless approved by a majority of the votes cast at an Annual Meeting.
