5.2 Senior Staff Good News Update

Senior Staff highlights included:

Superintendent Pizzoferrato

- Niagara Catholic has approximately 110 staff at 33 sites across the system providing in person service to over 75 of our most vulnerable students during this stay at home order. The numbers are attributed to the partnerships that exists, the trust that is in place between families, the commitment of our staff and the ability to prioritize the needs of our students.
- Niagara Catholic is in the process of finalizing an after school program for our students with autism that will focus on virtual service to expose them to coding and robotics. This will prove to be highly engaging.

Superintendent Lee Ann Forsyth-Sells

- St. Alfred Catholic Elementary School support staff have been able to accommodate 5 special needs students at school during the lock down, as well as many online. The EAs and the ERT have truly been outstanding with the flexibility of scheduling, and time allocated for one-to-one breakout sessions. Students are happy at school and are definitely benefitting, and parents are grateful for allowing this to happen. This is a shout out to all the EAs and ERT!
- Emails have been received by parents from both St. Ann and St. James Catholic Elementary Schools in St. Catharines praising the outstanding work of Principals and staff.
- Niagara Catholic is pleased to announce its partnership with Tools of Empowerment for Success Niagara, to launch *What They See Is What They Will BE*, a powerful mentorship program to support students in grades 6 to 12. A grant of \$25,000 from the Niagara Community Foundation will support the implementation of this program. Mentors will receive training in cultural competencies and racial nuances. This program will meet the needs of Black youth, addressing racial disparities and policy and program outcomes; such as data analysis, health, and mental health, education, literary and the performing arts, social impact and innovation and entrepreneurship.

Director Cipriano

 Virtual open houses are complete and Niagara Catholics registration are significantly higher than they have been in the last few years. A report will be brought to the February Board meeting.

ELEMENTARY AND SECONDARY SCHOOL YEAR CALENDARS: 2021-2022

BACKGROUND INFORMATION

The Education Act, Regulation 304 - School Year Calendar, Professional Activity Days outlines the requirements and timelines for preparing and submission of school year calendars to the Ministry of Education for approval.

For the 2021-2022 school year calendars, there are 194 possible school days between September 1, 2021 and June 30, 2022. Within this total, elementary and secondary schools must have a minimum of 194 school days, of which seven (7) days must be designated as professional activity days. Secondary schools may have a maximum of ten (10) instructional days set as examination days. The remaining school days shall be instructional days.

CONSULTATION PROCESS

The 2021-2022 School Year Calendar Committee met to discuss and review the draft calendar and the consultation process.

The consultation process provided the elementary and secondary draft calendars to all Elementary and Secondary Principals, Vice-Principals, Catholic School Council Chairs, Niagara Catholic Parent Involvement Committee (NCPIC), Special Education Advisory Committee (SEAC), OECTA Elementary and Secondary Presidents, CUPE President and staff for feedback by January 29, 2021.

Simultaneously, there has been on-going consultation with the co-terminous Board to achieve a similar school year calendar, where possible.

FINANCIAL INVESTMENT REPORT – AS OF DECEMBER 31, 2020

BACKGROUND INFORMATION

Several years ago, Niagara Catholic entered into a cash management strategy to optimize our interest income to support student needs at our School Board. In accordance with legislation, the Board has invested its surplus funds in securities prescribed under the Education Act, O. Reg. 41/10 – Part IV Eligible Investments. The Board continues to endeavour to achieve a positive rate of return to minimize the risk associated with investments by ensuring that the Board is compliant with the Education Act, while maintaining sufficient liquidity.

As part of our Administrative Operational Policy #600.7, the Superintendent of Business and Financial Services will provide an annual information report to the Board on the status of any financial investments.

Management Methodology

The investment objectives of the Board shall, in order of priority, be as follows:

- 1. Adherence to statutory requirements by the Education Act
- 2. Preservation of capital
- 3. Maintenance of liquidity
- 4. Competitive rate of return on investments commensurate with constraints in (1).

8. Mainstream – Lorraine Smith

- 2021 has begun with Mainstream offering only essential supports at this time, due to the new COVID-19 restrictions. All community programs have been reduced in hours and all community supports will be offered virtually or through some form of social media. They will strive to reach out to the families and the people they support to ensure some connection and support is offered during these trying times.
- Happy 2021 to all. Lorraine closed by wishing everyone a new year with renewed hopes, new opportunities, new ways to give and love and much happiness and good health.

9. Community Living Port Colborne / Wainfleet - Rita Smith

- Due to the most recent lockdown all programs have stopped again. All-day programs have been put on hold as the day support staff have been deployed to work in their group homes.
- Rita has been connecting with families via zoom and/or phone calls. The pandemic has been tough on parents as the respite that they were used to receiving from Community Living has had to stop for now. Some of the families have stated that doing online school work has been challenging, but they were so thankful for the support they have been receiving from the Educational Assistants as well as from their teachers. A couple of the young people that she spoke to stated that they have been doing better online than in person at school. They contribute that to fewer interruptions.
- Meridian held the Community Kindness Tree and donated toys and gift certificates to the children and teens that are supported by Community Living. Thanks to Meridian's donations, 40 children received gifts this year.
- Second Harvest is the largest food rescue organization in Canada. They recover perishable and/or unsold food before it spoils and distributes food to over 1200 social services agencies in Canada. Thanks to Second Harvest, 215 communities across Canada are being helped during this pandemic. Between March to June 30, 2020, \$30.9 million worth of food was rescued and redistributed.

F. STAFF REPORTS

1. <u>Elementary Principals – Chris Kerho</u>

- Chris started by thanking Superintendent Pizzoferrato for his earlier comments and echoed that the staff have embraced online learning and that the quality of online learning for our students has greatly improved when compared to last School Year. Educational Assistants are engaging students in Breakout Rooms that allow more direct instruction to students who require the support. He is looking forward to sharing some good news from our Elementary Schools at upcoming SEAC Meetings.

2. Secondary Principals – Kelly Majka

- Kelly started by saying that she was hesitant to say that she did not have any good news to share from the Secondary Schools because even though staff just got back from the Christmas break and although it may not be typical business as usual (during these COVID times), there are all kinds of wonderful things happening in the Virtual world at our Secondary Schools within Niagara Catholic.
- She continued by saying that at Notre Dame College, (where she is one of the School's Vice-Principals), she shared that the Special Class Teacher has a very creative NCVLE/Google Classroom up and running, filled with virtual class trips, music, art, literacy/numeracy, sensory room. You name it, it is there!!! Also, the Educational Resource Teachers and the Educational Assistants have been busy supporting students directly within the Virtual Setting.
- Furthermore, the Special Education staff at all of our Secondary Schools have been busy communicating this week with families to identify which Complex Special Needs students would benefit from returning to in-person learning commencing this <u>Monday, January 11, 2021</u>. That has been the main focus of this week, they are all planning to ensure that all is ready to go (i.e., staffing, programming, transportation, etc.) and that it is a seamless transition for our students and families.
- Kelly concluded by saying that she looks forward to capturing all the GOOD NEWS stories that
 are happening both virtually and in-person throughout January from our Niagara Catholic
 Secondary Schools and she will be sharing these stories with the group at upcoming meetings.

3. Superintendent of Education – Gino Pizzoferrato

- Superintendent Pizzoferrato reviewed SEAC's mandate to the group:
 - O Publicly funded education in Ontario is delivered through a decentralized system of school boards established by the provincial legislature to administer the education system at the operational level. The Ministry of Education is responsible for providing the regulatory and policy framework within which school boards exercise their responsibility. The Education Act and the regulations made under it establish school boards as independent corporations that are governed by elected trustees. The Act and regulations also set out various duties of boards which include establishing policies and committees of the school board including the legal obligations of school boards regarding the provision of special education programs and services. School boards are also responsible for establishing a Special Education Advisory Committee (SEAC) and the regulation made under the Education Act sets out the requirements for that committee.
 - Each school board and school authority in Ontario must establish a Special Education Advisory Committee (SEAC). A SEAC is a committee of a school board or a school authority that provides important advice on special education to that particular school board.

The SEAC:

- o Provide important advice on special education to their local board or school authority.
- Comprises trustees and representatives of local associations that further the interests and well-being of exceptional children or adults.
- Make recommendations to their board on any matter affecting the establishment, development and delivery of special education programs and services for exceptional students.
- Must be established at each school board and school authority in Ontario.
- Have requirements set out in Regulation 464/97.
- The floor was opened to questions and discussion.

4. Student Support Department – Jim Di Gioia

- The Student Support Department is currently engaging with schools and staff to support remote learning for students during the school closure. Program Resource Teachers and Behaviour Resource Teachers are sharing resources about pivoting In-Person learning accommodations and modifications to online learning. Itinerant Resource Teachers continue to engage and directly support their students while they are online at home. All extended Student Support staff are offering their expertise and experience to keep students actively engaged both online and off-line, depending on their ability to learn synchronously or asynchronously.
- As well, the ABA Team are preparing professional development presentations and activities for the upcoming February PA Day; the ABA Team and the Special Needs Facilitators are preparing for the annual Behaviour Management Systems (BMS) refresher certification for all support staff. Finally, the Student Support Coordinators are preparing to support transitions for next year's incoming Kindergarten students who require specialized supports and have complex needs.

5. Director of Education – Camillo Cipriano

- Director of Education Cipriano expressed his appreciation and gratitude for the staff of Niagara Catholic. He also thanked Superintendent Pizzoferrato and the Student Support Department for

all their work ensuring that our complex special needs students are being supported. He thanked the group for their discussion and comments.

G. TRUSTEE REPORTS

- Trustee Burtnik and Trustee Prince were both in attendance that evening. Trustee Burtnik acknowledged the compassion and care shown by staff for Niagara Catholic students. She closed by telling the group that we are waiting for further direction from the Ministry on when the schools will re-open and in what capacity.
- Trustee Prince echoed Trustee Burtnik's comments and appreciation to the staff of Niagara Catholic. She thanked everyone for their dedication and commitment to servicing the students of Niagara Catholic.

H. STUDENT REPORT

- This past month, Student Councils across our Secondary Schools have facilitated a variety of Christmas themed initiatives, including carol videos, give away prizes and a variety of other activities.
- Student Senate is currently working on planning a Student Mental Health Summit scheduled for February 5, 2021 from 10:30 am 12:00 pm. Through trivia, workshops and games, participants can learn about mental health. Each participant will earn two (2) community involvement hours towards the secondary graduation requirement. All students are encouraged to attend.
