2021-2022 PARENTS REACHING OUT (PRO) GRANTS

BACKGROUND INFORMATION

The Ministry of Education continues to support parental involvement in Ontario schools by funding Parents Reaching Out (PRO) Grants. The Parents Reaching Out (PRO) Grants program provides funding to district school boards and school authorities to lead projects with a focus on the identification and removal of barriers that prevent parents and families from participating and engaging fully in their children's learning.

This funding supports projects that are initiated by parents through communication with the Niagara Catholic Parent Involvement Committee and Catholic School Councils.

Projects for the 2021-2022 school year are to demonstrate a commitment to respecting the role of parents in students' educational experiences by working with parents or seeking parent input on how schools can improve in at least on of the following areas:

- addressing social inclusion and racism specifically anti-Asian, anti-Black, and anti-Indigenous racism and other prejudices toward racialized and marginalized groups;
- creating a safe and welcoming environment;
- demonstrating respect for parents as valued partners within the education system regarding decisions about their child's education:
- enhancing communication with teachers; and
- informing parents about the expectations of the Ontario Curriculum and supporting resources.

For the 2021-2022 school year, the Niagara Catholic District School Board has received \$26,172.96 to support parent engagement projects.
