ELEMENTARY AND SECONDARY SCHOOL YEAR CALENDARS: 2022-2023

BACKGROUND INFORMATION

The Education Act, Regulation 304 - School Year Calendar, Professional Activity Days outlines the requirements and timelines for preparing and submission of school year calendars to the Ministry of Education for approval.

For the 2022-2023 school year calendars, there are 195 possible school days between September 1, 2022 and June 30, 2023. Within this total, elementary and secondary schools must have a minimum of 194 school days, of which seven (7) days must be designated as professional activity days. Secondary schools may have a maximum of ten (10) instructional days set as examination days. The remaining school days shall be instructional days.

CONSULTATION PROCESS

The 2022-2023 School Year Calendar Committee met to discuss and review the draft calendar and the consultation process.
