D. CHAIR'S REPORT

- a. Parent Engagement activities 3 events to build community, the Council agreed to repeat events from last year
 - Christmas Fun Night a few changes to better accommodate a bigger group, changes to be determined when planning begins
 - Pasta Night Grade 8 students to again be involved in running the event
 - June BBQ

b. Food days

- trying out 3 per month as the Council requested more frequent food days last year
- we have added Pita Pit with smoothies
- Sara asked about having a monthly payment option
- Chris mentioned that the secretary will look into how to post this on School Cash, he also mentioned that it may be an equity issue, may be more difficult for families with more than one child to make a bulk payment for the month, we will try it in November

c. Bingo volunteers

- need commitment to sustain, Jessica said that there is enough people now who have signed up for the next few months, we need more people to be trained so that we have back-ups and so that we may be able to accept the second day per month that we have been offered
- Kuska polo shirts ordered for volunteers and will be paid by Bingo funds
- Francesca to post request for Bingo volunteers on social media
- Francesca to create a Google Form to send out to families to connect those who want to volunteer to help at events/Bingo but who aren't Council members

d. Bingo money

- approximately \$6000.00 in account right now, not typically permitted to accumulate such an amount, but since we just started in April they have given us a bit of time
- technology, subsidizing trip costs and the purchase of tables/chairs were all discussed as possible purchases
- Chris to find out cost of tables and chairs and then make that purchase soon

e. Fundraising events

- decided to sell poinsettias at Christmas
- Sara noted that Vermeer's was very organized and they have a voucher system so school will hand out vouchers and families will go pick up plants
- Sara shared the profit per plant option
- Ashley suggested limiting the options to 10" and porch pots, the Council agreed
- info needs to be shared with families by October 19

f. Lifetouch changes

- new team in the Niagara Region, we are hoping for a better experience this year
- class composites at a cost now, no longer complimentary

g. School Name

- Suggestion made to change school name to Saint name, came up organically with students and staff when staff was instructed to share story of school's patron Saint after the Faith PA day last year
- we are one of only 2 schools in the Board who is not named after a Saint or some other holy namesake
- Alexander Kuska was a former Director of Education, as well as a member of the Knights of St. Gregory, St. Gregory's name was brought forward as a suggestion because staff

learned at the Faith day last year that he is the patron Saint of teachers, students, singers and musicians, his feast day is during the first week of September which coincides with the beginning of the school year

- Chris shared that CSC Co-Chairs would need to bring this motion forward at a Board meeting and then a committee with all stakeholders would be created if the Director took the suggestion into consideration
- Student Council input was suggested and it was mentioned that past school members may also want some input as well, Martha mentioned that some may feel that a sense of tradition is being lost with a name change
- It was noted that the logo could continue to be Knights if St. Gregory was decided as the name and this would help carry on sense of tradition
- Council decided that a Town Hall could be organized to seek input from the community about whether the Co-Chairs bring this to a future Board meeting
