Blessed Trinity Cheerleaders donated some of their older trophies. Coaches Mrs. Brown and Ms. Sgambato had the trophies engraved with the date of the event and "Spirit Champions". Each one of the high schools was able to take home a huge trophy in remembrance of the day. From the happy grins and squeals of delight ... the trophies were a huge hit. Thanks go to all of the EA's for all their help in putting together a wonderful day! Thanks, also goes out to Blessed Trinity staff, administration and Frank Napoli from the Board for all of the assistance and support.
- We are looking forward to September and our new room. We have already begun planning programs for our students. Three of our students have confirmation of a work placement-Giant Tiger, Grimsby Library, and a local greenhouse. It is our desire that all of our students have meaning to their day after graduation. We use this model in our backwards planning, looking at life after they leave high school, and acquiring the skills during their time in high school to accomplish those goals. In effect, transition planning does not happen just in the year or two before graduation, but begins the moment they register as Blessed Trinity students. Constant and close communication between home and our school fosters effective programming, success during their time at Blessed Trinity and the alignment of home, school and community that continues beyond the walls of our school.
- One of the key aspects to a successful high school experience for our students with Special Needs is integration. Below, you will see just one of many examples of inclusion at Blessed Trinity:
- Recently, our school held a Much Music Video Dance. While all of our students are welcome to attend, not all do for a variety of reasons (time of the dance, noise etc). Three of our students attended this dance. All three asked their peer helpers for the information they needed, and made arrangements to attend. At the dance, not one moment, were they without someone to dance with or talk to.
- Additionally, on Wednesday evening, it is our Athletic Awards Recognition Night. Three of our students will be recognized for their outstanding performance in swimming. Again, our mainstream students, who are in constant contact with our students, asked... "are you going... who are you sitting with... you can sit with us". Once again, it was peers who made sure our students got their tickets etc.
- At lunch time, you will not find our students sitting as a group in the cafeteria. They sit with peers scattered around the cafe, or come into the Special Education Class, and you will find it filled with a variety of "mainstream" students who enjoy coming into our room to eat, heat their food, listen to music, chat, play games.
- This is what inclusion looks like. It is genuine, it says this is the way we treat each other. It says "I care more about someone else than I do myself".
- Have a wonderful summer! We look forward to new and exciting things in September!

### REPORT TO THE BOARD MEETING SEPTEMBER 25, 2012

### SAINT MICHAEL CATHOLIC HIGH SCHOOL ADDITION & ALTERATIONS

### **BACKGROUND INFORMATION**

On July 7, 2011 the Ministry of Education announced funding approval for \$5,527,880 under the Capital Priorities Funding program to replace the portable classrooms at Saint Michael Catholic High School with a ten (10) classroom addition to the school building.

In March, 2012 Raimondo + Associates Architects were hired and in consultation with Board and school staff, they prepared conceptual designs, cost estimates and timelines for four options for the project (Appendix A).

Some of the requests from staff included a new gymnasium and music room plus alterations to the hospitality, transportation technology, computer labs and servery to address program and functional inefficiencies.

Other than Option 1, all options exceed Ministry funding. The Ministry was consulted to determine if additional funds would be available for a new gymnasium, weight and exercise rooms. The Ministry did agree to the use of Board funds for Option 4 which addresses inefficiencies through an addition of a music, exercise and weight rooms plus renovations to the servery, hospitality and transportation technology rooms.

### **BACKGROUND INFORMATION**

Provincial assessments conducted by EQAO measure the achievement of students in relation to the Ontario curriculum.

The EQAO results from the Primary and Junior Assessments in Reading, Writing and Mathematics, Grade 9 Assessment of Mathematics and the Ontario Secondary School Literacy Test (OSSLT), along with classroom and other assessments provide data about student achievement.

On September 12, 2012, EQAO released the school and Board level results of the 2011-2012 assessments. Niagara Catholic continues to celebrate student success on provincial assessments with improved student achievement in the areas of literacy and numeracy.

Senior Administrative Council, Principals, Vice-Principals, teaching and support staff continue to work collaboratively to improve the achievement of each student by ensuring that individual needs are being met in the classroom.

The Board Improvement Plan for Student Achievement (BIPSA) provides the foundation for School Improvement Plans (SIPs) focusing on the improvement of student achievement in the four areas of Catholic Community, Culture and Caring, Literacy, Numeracy and Pathways.

Dear Niagara Catholic District School Board Trustees:

I have become aware that the Niagara Catholic District School Board has decided to ban the sale of bottled water in school board facilities.

The Canadian Beverage Association and its members' would like to express our disappointment in your decision and our exclusion in the consultation process on this manner. It is our hope that CBA will be included in any future consultations regarding our members' products in your School Board's facilities.

We believe that bottled water should continue to be available for sale in your schools and facilities as it provides a portable and healthy hydration option for your students and staff.

Unfortunately, over the last few years there have been a number of daims made against the bottled water industry in Canada; these claims are more often than not based on incorrect, dated or Americanbased facts and figures.

As such, the Canadian Beverage Association would like to use this opportunity to provide facts on the category.

#### Plastic water bottles are 100% recyclable and are recycled at high rates across the country;

- Total PET non-alcoholic beverage containers account for less than 0.5% of all waste produced in Canada. The beverage industry's containers are the most recycled consumer product packaging in Canada. Furthermore, recycling programs and infrastructure are supported and run by the beverage sector in every jurisdiction in Canada.
- Industry and government data indicates that over 60% of PET water bottles are recycled in the province of Ontario, with rates as high as 70-80% in single family dwellings.

#### Bottled water is produced in environmentally smart and efficient ways;

- The Canadian bottled water industry works to manage water resources in a responsible way.
- According to Environment Canada, our entire industry uses just 2/100<sup>th</sup> of 1% of all annual water withdrawals in Canada
- The per capita annual consumption of bottled water in Canada equals one 3-minute shower using a standard shower head.
- It takes:<sup>1,2</sup>
  - 1.3 litres to produce 1 litre of spring water (this includes the water in the bottle)
  - 35 litres of water to produce a cup of tea
  - 75 litres of water to produce a glass of beer
  - 120 litres of water to produce a glass of wine
  - 140 litres of water to produce a cup of coffee

## Water and You

#### Staying hydrated is an important part of a balanced diet!

The human body is approximately 60% water and water is an essential nutrient that the body cannot produce.<sup>1</sup> Canadians have access to an abundance of hydration choices including tap water; plain, flavoured or sparkling bottled water; juices; fruit drinks; tea; coffee; milk; soft drinks and many more. For many Canadians, bottled water is a hydration option especially when on the go because its convenience and portability facilitates consumption. Your fluid requirements depend on your age, activity level and you body's needs. All types of fluids count toward getting your daily requirements including water obtained from food. The Dietitians of Canada recommend the following:<sup>2</sup>

Age	Fluid in litres (or cups)*
Child 1-8 years	1.3 - 1.7 L (6 c)
<b>Boys</b> , 9-18 years	2.4 - 3.3 L (10-13 c)
Girls, 9-18 years	2.1 - 2.3 L (8-9 c)
Adult males	3.7 L (15 c)
Adult females	2.7 L (11 c)
During <b>pregnancy</b>	3 L (12 c)
While breast feeding	3.8 L (15 c)

## **Types of bottled water**

**Spring Water** – the most common type of bottled water. It must come from an underground drinkable source, usually an aquifer, and cannot be treated in anyway.

*Mineral water* – similar to spring water, as it comes from an underground source but contains a high amount of naturally occurring dissolved mineral salts. Mineral water may or may not be carbonated.

**De-mineralized or re-mineralized water** – comes from any source that has been treated to make the water drinkable and to remove minerals and other impurities. During the bottling process, advanced multi-stage reverse osmosis filtration systems are often used to remove any additional impurities.

In Canada, approximately 94% of the bottled water sold is spring water with the balance being mineral or de-mineralized.

#### **Fast Fact** Our members' products are tested

at the beginning and end of each production run as well as hourly during production to ensure the product exceeds all requirements.



## Water Usage

When considering bottled water as a beverage choice, it is important to understand the facts about bottled water in Canada – the usage, production, packaging, quality, testing and regulations.

## **Regulations for Safety and Quality**

Like all foods and beverages sold in Canada, bottled water safety and quality is regulated by Health Canada under the Food and Drugs Act and Regulations. Production facilities are subject to inspection by the Canadian Food Inspection Agency, and Health Canada and the Canadian Food Inspection Agency both apply the *Guidelines for Canadian Drinking Water Quality* in their monitoring of bottled water.

In addition, our members' production facilities have stringent internal quality measures to ensure their products meet consumer expectations in terms of quality, safety and taste.

## Setting the Record Straight

The Canadian bottled water industry works to manage water resources in a responsible way. According to Environment Canada, our entire industry uses just 2/100<sup>th</sup> of 1% of all annual water withdrawals in Canada. This amounts to approximately 50 litres per person per year or 1.6 billion litres annually.<sup>6</sup>

To put that in context, the average Canadian consumer uses over 125,000 litres of water per year, meaning that per capita bottled water consumption represents 0.04% of a person's yearly water use.<sup>6</sup> By comparison, one of Canada's largest municipalities annually loses 54 billion litres of fresh water or 14% of its total annual supply because of leaky infrastructure. This water loss represents 30 times the amount of bottled water consumed annually by all Canadians. Environment Canada estimates nationally that up to 30% of the total water entering municipal supply-lines systems is lost to leaking pipes.<sup>6</sup>

Our members are continually investing in new science and technology to improve water quality, production efficiencies and water conservation practices.

Per capita annual consumption of bottled water equals one 3-minute shower using a standard shower head.<sup>6</sup>

## **Our Packaging, Our Bottles**

Our single serve bottles for water are made of a plastic called Polyethylene Terephthalate or PET. PET is used to make a variety of other products including fibre for carpeting and upholstery, and polyester for clothing.

PET is 100% recyclable. PET bottles are one of the most recycled forms of consumer packaging in Canada and, when compared to other beverage packaging choices, has the lowest environmental footprint. When recycled, a PET bottle preserves 86% of the energy used to create it.<sup>7</sup>

In Canada, PET beverage bottles are recycled at very high rates in programs that are run and funded by the beverage sector. The average recycling rate is over 70%, with some jurisdictions such as Alberta, British Columbia and Saskatchewan having rates of approximately 80%.<sup>8</sup> Through new innovations, the beverage sector is working to improve its already successful environmental track record.

#### **Fast Fact**

According to Plastics Recycling Update, the EU rate for recycling PET is approximately 48% while in Canada the rate for PET is approximately 70% and higher for beverage containers.



#### Did you know?

The human body is approximately 60% water. <sup>1</sup>

The average adult needs to consume between 2.7 and 3.7 litres of 'total water' per day.<sup>2</sup>

About 80% of our total water intake needs are met through the beverages we drink and the remainder comes from the foods we eat.<sup>3</sup>

#### How much water does it take?

It takes 1.3 litres of water to make 1 litre of spring water, and approximately 1.8 litres to make 1 litre of de-mineralized or re-mineralized water. These amounts include the 1 litre of water that ends up inside the bottle. <sup>4</sup>

Some of our members are using recycled PET and renewable plant based materials in their PET.

Reduced weight and renewable materials reduce the environmental impact of bottled water.

#### Re-use:

Many of our members use recycled PET in their bottles, some even offer a 100% recycled-PET bottle.

Recycled PET that is not used for beverage packaging is re-used to produce new packaging for other consumer goods or for polyester fibre to be used in the production of new clothes, carpets and other goods.

#### *Myth:* Single use PET plastic water bottles contain BPA or other chemicals that leach into the product.

Fact: The single use plastic containers that are used by the beverage industry, including those used for bottled water, are made from PET plastic. There is no bisphenol-A in PET plastic water bottles because no bisphenol-A is used to manufacture PET plastic. All food and beverage grade packaging used in Canada must be approved by Health Canada, including PET plastic. Health Canada has reviewed the use of PET plastic and determined that it is safe to use.

#### *Myth:* Bottled water competes with municipal water systems.

**Fact:** Bottled water does not compete with tap water. Bottled water competes with other bottled beverages. According to Probe Research, 70% of Canadians drink tap water at home and bottled water away from home.

Tap water serves a variety of purposes in the typical Canadian household including drinking, personal hygiene, clothes and dish washing, cooking, cleaning and irrigation. Bottled water provides portability and convenience. We support a consumer's right to choose the beverage that meets their needs and preferences, whether that is tap or bottled water or a combination of both.

Furthermore, water is the primary ingredient for many of the other beverages produced by the Canadian beverage industry. Therefore strong municipal water systems are as important to the Canadian beverage industry as they are to all citizens.

#### Myth: Municipal water is safer than bottled water.

**Fact:** By law, Health Canada regulations for bottled water must be as strong and protective of public health as provincial regulations for tap water. Bottled water is regulated as a food product by Health Canada through the Food and Drugs Act.

Bottled water is regulated by Health Canada and the beverage industry's facilities are inspected by the Canadian Food Inspection Agency. Members test water for quality and safety before production, each hour during production and at the end of production.

The bottled water produced by the Canadian Beverage Association members meets or exceeds all Canadian requirements.
