#### **B. PRESENTATIONS**

#### 1. Blessed Trinity Catholic Secondary School Choir

Rob Ciarlo, Superintendent of Education, welcomed Ted Farrell, Principal of Blessed Trinity Catholic High School, and Music Director Angela Maccaroni. Mr. Farrell gave a brief background on the accomplishments of the Blessed Trinity Catholic Secondary School Choir. Mrs. Maccaroni introduced the Choir who performed for the Board.

Chairperson Burtnik thanked the students for their very entertaining performance and asked Trustees Crole and Belcastro to presented the students with Niagara Catholic "Excellence in the Arts" pins.

#### 2. <u>Christmas Card Presentation to Students</u>

Frank lannantuono, Superintendent of Education, presented information of the contribution of Niagara Catholic students in the design of the Board's Christmas cards for 2008. He explained that students within the Board were invited to submit artwork for use on the cards, and that specific cards are chosen to be used by the Board.

Director Crocco, Chairperson Burtnik, and Vice-Chairperson Fera, presented each of the students with a box of Christmas Cards containing their designs.

#### 3. Lakeshore Catholic High School - OFSAA Football Team

Yolanda Baldasaro, Superintendent of Education, presented a brief background on the Lakeshore Catholic High School OFSAA Championship Football Team. Superintendent Baldasaro called upon Danny DiLorenzo, Principal of Lakeshore Catholic High School who spoke briefly of the dedication and determination of the team and of how they diligently incorporated their Catholic values into every game. Principal Di Lorenzo introduced football coaches Rocky DiPietro, Terry Lehne, Peter Burnett and Bernie Tessier.

Chairperson Burtnik congratulated the students on their success and asked Trustee Dekker to present the students with Niagara Catholic "Excellence in Athletics" pins.

#### 4. Denis Morris Catholic High School - YMCA Peace Medallion

Lee Ann Forsyth-Sells, Superintendent of Education, welcomed Tony Bozza, Principal of Denis Morris Catholic High School. Principal Bozza introduced Shondra Mings, a Grade 12 student at Denis Morris who was awarded the YMCA Peace Medallion.

The YMCA Peace Medallion is awarded to individuals who meet the criteria of enhancing the lives of people in their community, or around the world, by creating a more peaceful environment.

Shondra spoke briefly of her involvement in programs such as R.E.A.C.T. (Resist, Expose and Challenge Tobacco), which educates youth about the dangers of tobacco products, and her dedication to Third World Projects, such as the Pilgrimage and Starvathon. Shondra also leads the Denis Morris Catholic High School Social Justice Club, and is presently a Student Senate Representative.

Chairperson Burtnik commended Shondra on her charitable efforts and commitment to Denis Morris Catholic Secondary School, the Student Senate, the school community and Third World Countries, and asked Trustee Charbonneau to present her with a Niagara Catholic "Excellence in Academics" pin.

# **EQAO Primary Assessment of Reading, Writing and Mathematics**

The Niagara Catholic District School Board is celebrating student achievement after province-wide test results showed its Grade 3 students have exceeded the provincial averages in Reading, Writing and Mathematics, once again. In May of 2008 the EQAO Primary Assessment of Reading, Writing and Mathematics was administered across elementary schools in our board. Achievement is described in four levels, where Level 3 is the provincial standard. The EQAO reported the results of school, board and provincial achievement by two methods: Method 1 includes all Grade 3 students and Method 2 includes Grade 3 students excluding students who were exempted or did not complete any work during the assessment. The Niagara Catholic District School Board's commitment to quality Catholic education and to the success and achievement of each individual child entrusted to its care was demonstrated by the fact that 98% of Grade 3 students participated in the Provincial Assessment

# EQAO Junior Assessment of Reading, Writing and Mathematics

The Niagara Catholic District School Board is celebrating student achievement after province-wide test results showed its Grade 6 students have exceeded the provincial averages in Reading, Writing and Mathematics, once again. In May of 2008 the EQAO Junior Assessment of Reading, Writing and Mathematics was administered across elementary schools in our board. Achievement is described in four levels where Level 3 is the provincial standard. The EQAO reported the results of school, board and provincial achievement by two methods: Method 1 includes all Grade 6 students and Method 2 includes Grade 6 students excluding students who were exempted or did not complete any work during the assessment. The Niagara Catholic District School Board's commitment to quality Catholic education and to the success and achievement of each individual child entrusted to its care was demonstrated by the fact that 98% of Grade 6 students participated in the Provincial Assessment

# School Improvement 2008 - 2009

The Niagara Catholic District School Board Improvement Plan and individual School Improvement Plans will set SMART Goals as a means to continuous improvement. Each school's plan will include SMART goals on Faith Formation, EQAO targets, Safe Schools, and an additional two goals that are school specific.

Our Improvement Plans are dynamic in that they will be closely monitored by both Board and School Improvement Planning Teams, along with Senior Administration, throughout the school year. If required, adjustments will be made to the individual plans to reflect the needs of our students and school communities.

**SMART** stands for goals that are S – Specific, M – Measurable, A – Attainable, R – Relevant, T – Time Based.

#### 1.3 <u>Ontario School Board Governance for the 21<sup>st</sup> Century Consultation Paper</u>

Director Crocco presented the Ontario School Board Governance for the 21<sup>st</sup> Century Consultation Paper. He stated that Minister of Education Wynne has announced the creation of a Governance Review Committee which will make recommendations to the Minister on:

- Ways to modernize and clarify in the Education Act, the duties, powers and account abilities of School Boards, Chairs, individual Trustees, and Directors of Education, while reinforcing the relationship between elected officials as a group and the Director of Education as sole employee accountable to the board;
- Effective practices in governance applicable to the education sector, including codes of conduct for Trustees, enforceable at the Provincial or Board level, and audit committees with external members;
- Appropriate long-term capacity building program for Trustees; and
- Appropriate content and format for Provincial interest regulations designed to ensure that a Board achieves student outcomes specified in the regulation.

The Committee has written a Consultation Paper to provide background information on these four areas and on the scope of the its mandate. The deadline for written submissions to the Consultation Paper is February 28, 2009.

Director Crocco, Chairperson Burtnik and two members of the Niagara Regional Catholic School Council/PIC will be meeting with the Governance Review Committee on February 20, 2009.

#### 1.4 *Inclement Weather*

Director Crocco informed Trustees of the revised timelines in the Niagara Catholic District School Board Inclement Weather process, which begins with early morning discussions with the Director of Education from the District School Board of Niagara; the Niagara Student Transportation Services, who provides information from Regional contacts; and James Woods, Controller of Plant Services, regarding snow removal and building conditions(power outages, water main bursts, loss of heat).

The revised timeline allows confirmation of the cancellation of buses or the closing of schools by 5:30-6:00 a.m. to the Superintendents, Radio and Television Stations, as well as allowing sufficient time to post the information on the Board Website; e-Community; and change the voice message at the Catholic Education Centre.

A system is in place for contacting the Superintendents, Managers, and Principals to activate phone chains to notify staff of a closure.

Trustees will be contacted by the Director to keep them apprised of inclement weather results.

Director Crocco has drafted a letter to all parents/guardians outlining the Niagara Catholic District School Board decision making and communication process for inclement weather, and suggesting that they have a contingency plan for the supervision of their children when buses are cancelled, schools are closed and for mid-day school closures. A copy will be provided to all Trustees.

Trustees were informed that Senior Staff is tracking attendance on days where bussing is cancelled.

#### 9.1 VOICE for Hearing Impaired Children – Kim Rosati

• Kim Rosati attended the VOICE SEAC Workshop on November 8, 2008. There was a presentation from the Ontario Infant Hearing Program and the importance of early identification.

How Deaf and Heard of Hearing Children can be successful in Mainstream:

- Early identification (Infant Screening)
- Access to Auditory Verbal Therapy
- Parental & Community Involvement
- Trained Teachers of the Deaf

Statistics show that 40% of the deaf and hard of hearing have another physical or learning challenge.

- Anita Bernstein, Director of Therapy Services for VOICE for Hearing Impaired Children • spoke on the VOICE Training and Mentoring Program in the Auditory Verbal Approach. Voice is aware of the shortage of AV trained professionals and has provided an AV Training/Mentorship program. The program has successfully impacted a number of communities through the model "Train the Trainer". In 2007, the Ontario Ministry of Education launched a Pilot AV training/mentorship program in four Ontario School Boards. Currently six professionals from the various school boards are training under the mentorship of a VOICE certified Auditory-Verbal Therapist. The primary goal is to achieve a longer term change in services provided to students who are deaf and hard of hearing. The ultimate goal is to train Listening and Spoken Language Specialists who are capable of providing intervention in the Auditory Verbal approach. This will also help the transition of the students from the Infant Hearing Program to the educational environment. - Kim Rosati informed members of a SEAC booklet from the Halton Catholic District School Board and inquired about the possibility of a similar booklet from the Niagara Catholic District School Board to provide information and awareness to parents. A brief overview of the services they provide and personnel were presented to parents.

#### 10.3 Ken Griepsma – Vice-Principal, Secondary

- There are many success stories going on in Special Education at the secondary level right now. A Grade 12 student from one of our high schools participating in a co-op placement at Shopper's Drug Mart was offered a part time job at the conclusion of his coop and there are numerous stories of this type across the board. Many students appear to be participating in co-operative education opportunities and are doing very well.
- It was reported by a number of schools that Special Education students who will be writing the OSSLT will be having a practice assessment using the accommodations that they will be using during the actual test in February. This test will be marked and feedback will be provided to these students.
- Special Education students/classes in a number of schools have taken up fundraising activities (i.e. Saint Michael selling meatball subs once a month to raise money to further subsidize their field trips). Other classes are doing community service (i.e. Lakeshore Catholic students assisting with the cleaning, peeling, and cutting of vegetables used in the Port Colborne soup kitchen).
- The Supported Learning and General Skills teachers at Denis Morris are working with their local Special Needs' Facilitator and two local service providers on a pilot project involving creating a portfolio for each student in the General Skills class and selected students in the Supported Learning class. The idea being that each student who leaves will have a portfolio outlining accomplishments and skills they have attained.

# PUPIL ACCOMMODATION REVIEW GUIDELINES FOR PUBLIC INPUT

As required by the Closure of Schools/ Accommodation Review Policy of the Niagara Catholic District School Board, the Board will hold a special Board meeting for public input regarding the School Valuation Report filed by the Accommodation Review Committee and the Director's Report. These special Board meetings are scheduled as follows:

Niagara Falls Elementary, 7:00 p.m. February 17, 2009, at Saint Michael Catholic HS

- St. Catharines Elementary, 7:00 p.m. February 18, 2009, at Denis Morris Catholic HS
- St. Catharines Secondary, 7:00 p.m. February 23, 2009, at Denis Morris Catholic HS

The public may provide a written report to the Director of Education at any time.

The following Guidelines describe the public meeting process.

#### **Delegation Application Process**

The public meeting will follow the By-law of the Board for public delegations in modified form, as set out below. The modifications are intended to facilitate public participation.

- (a) Written application requesting the opportunity to appear as a delegation must be submitted to the Director of Education no later than 4:00 p.m. on February 10, 2009.
- (b) The following information should be included with this application:
  - (i) The name of the organization/individuals(s) or party(ies) who will be making the presentation;
  - (ii) Their authority/title/position with the organization (if applicable);
  - (iii) A complete mailing address;
  - (iv) A day time telephone number;
  - (v) A number where they can be reached after business hours;
  - (vi) A fax number (if available);
  - (vii) An e-mail address (if available);
  - (viii) The complete presentation in written format
- (c) Delegations are encouraged to send the Presentation in as soon as possible so that it can be provided to and reviewed by Trustees prior to the meeting. Presentations that are received on a timely basis will be considered and addressed in the Director's follow-up report to the Board required by the Pupil Accommodation Review Policy in which the Director will report on and respond to the presentations made by the public. A presentation that is submitted late may not be addressed in the Director's follow-up report although it will be made available to the Trustees.

#### **Delegation Presentation**

Minutes of the Special Board Meetings including references to the presentations will be posted on the Board's website.

- (a) The identified spokespersons will address the Trustees from the podium.
- (b) The spokespersons are expected to provide comments that are relevant to the subject matter of the meeting. If a previous delegation has already addressed the matter and the delegate is being repetitive, the Chairperson of the Board may request the delegate to express support for an earlier presentation and may reduce the following speaking times available to the delegate accordingly.
- (c) The time for each public delegation to speak, excluding the question and answer period, is not to exceed fifteen (15) minutes, with normally a five (5) minute question period following.
- (d) Delegates who have a similar perspective are encouraged to co-operate in appointing spokespersons in addressing the Board.
- (e) Delegations from the same school community on the same point of view shall be limited to a combined total of fifteen (15) minutes.
- (f) Delegations who are unrelated to a particular school community but who are speaking on a common issue shall be limited to a combined total of fifteen (15) minutes.
- (g) Trustees may ask questions of the delegation for clarification only, for a period of time which shall be at the discretion of the Chairperson.
- (h) The Chairperson will apply the normal Board practices in respect of decorum and order at the meeting.
- (i) The Board will not permit delegations respecting the Pupil Accommodation Review Policy at other Board meetings.
- (j) In accordance with Board By-law 7.5 the Board shall not remain in session later than 11:00 p.m. unless so determined by a 2/3 majority of the members present.

# **Funding for New Elementary schools**

Niagara Catholic has received additional funding from the Ontario Ministry of Education for the construction of two new Catholic elementary schools in Grimsby.

In March, 2007, the Ministry announced funding approval for St. Joseph Catholic Elementary School and Our Lady of Fatima Catholic Elementary School under the Prohibitive to Repair program. Niagara Catholic received nearly \$8.7 million in funding for the new schools, but the amount did not cover the cost to rebuild two new schools.

St. Joseph Catholic Elementary School opened in September 1954. Our Lady of Fatima Catholic Elementary School opened in September 1968 as an open concept school. Both schools are in need of many upgrades and repairs.

After a series of discussions with the Ministry of Education, Niagara Catholic is pleased to report that an additional \$3.4 million in funding has been approved for the schools. The funds include \$700,000 for demolition and site repair, \$1 million to build three new classrooms for full-day learning for four and five-year-olds, \$1 million for three new classrooms due to primary class size reductions and an increase in construction cost benchmarks

The approval means the Board can move on to request tenders to build the new schools. The tendering documents are expected to be completed by May and tenders received in June.

If all goes according to plan, construction of the two schools will begin July and the doors will open for students in September 2010.

The Our Lady of Fatima and St. Joseph Catholic Elementary School communities, as well as Niagara Catholic's Trustees, will be consulted and kept informed of updated information throughout the tendering and construction process.

•We want students to enjoy winter fun outdoors, but students are reminded of the need to play safely.

#### Office of the Director of Education

Dear Parents and Guardians;

A very Happy New Year to you and your family as we begin 2009. With the winter months now upon us and the recent weather which has resulted in two decisions to cancel school transportation and keep schools open, I thought it important to provide parents and guardians with information on our decision-making and communication process when we are faced with making such decisions.

It is always a challenge in making weather related decisions given the unpredictability of the weather and the diverse topography of the Niagara Peninsula which affects the impact of weather systems across the region. The Niagara Catholic District School Board covers 1,868 sq km, bordered by Lake Erie, Lake Ontario and the Niagara River. With 72 facilities, 24,000 students and 3,100 staff in the 12 municipalities across the Region of Niagara, our Board covers a large geographic area.

#### **Cancelling Student Transportation**

When adverse weather conditions are forecasted, Niagara Student Transportation Services (NSTS), our student transportation provider, gathers information on road and weather conditions. Throughout the night and beginning very early in the morning (4:00 a.m.), NSTS gathers data from a wide variety of sources, including the bus companies, various municipal and regional agencies and from NSTS staff performing checks on selected routes to experience the road conditions first hand. NSTS considers the actual weather conditions, the forecasted weather and the road conditions very carefully.

Once all available information has been collected and reviewed, the decision to cancel buses is made by NSTS, in consultation with the bus companies, if it is determined that students cannot be safely transported to schools, as well as transported home at the end of the day.

#### **Closing Schools**

The process and decision to close schools is made independently from the decision to cancel student transportation and is made by the Director of Education. Given that all of our schools provide an essential service to students and parents, if the weather deteriorates, I am in contact with the Director of Education of the District School Board of Niagara and, after careful consideration, we decide whether it is necessary to close schools. In our discussions, we consider such issues as:

- ✓ Can some students safely walk to school ?
- ✓ Can some staff safely get to schools to welcome students who arrive ?
- $\checkmark$  Are the main roads clear ?
- ✓ Are there any other circumstances that would necessitate a school closure, such as a power outage, water main burst or loss of heat inside the school ?
- ✓ What are the conditions across the Region of Niagara ? Does the inclement weather affect the entire Region, or is it localized to one community ?
- $\checkmark$  What is the impact of closing schools ?

There are times when weather conditions will deteriorate throughout the morning, making it necessary to close schools mid-day. This is not a decision that is made lightly as we recognize the impact on students, parents and staff. In these circumstances, we consider the impact on all stakeholders and, most importantly, how to ensure the safety of our students and staff.

#### Communication

The decision to cancel transportation and/or close schools is made by 6:00 a.m. which is then immediately communicated to all local radio and television (CHCH) for broadcast. It is also posted on our Board's website at *www.niagaracatholic.ca*, e-mailed to all participants of our *e-Community* and placed as a message on the main phone line of the Catholic Education Centre.

Simultaneously, Niagara Catholic Family of Schools Superintendents are in contact with all Principals to advise them of bus cancellations or school closures. In discussions with Principals, our Family of School Superintendents review student participation at SCOEP, planned ski and field trips, along with school-based activities and events scheduled during the day and evening. While programs will continue to be provided for students during days when bus transportation is cancelled, the type of program may be modified to include review or time to work on assigned work depending on the number of students who attend school as determined by parents and guardians based on the weather conditions in a particular area of our Board.

I strongly encourage parents to join Niagara Catholic's *e-Community* to receive immediate communication from our Board throughout the year, especially during inclement weather. To join our *e-Community*, follow the link on the main page of our Board's website at *www.niagaracatholic.ca*.

#### **Contingency Plans**

With bus cancellations and/or school closures possible at any time throughout the school year, we will always do our very best to communicate the decision without delay. With many working parents, it is highly recommended that parents and guardians continually provide schools with current home and work phone numbers along with having three annual contingency plans in place for your child(ren) as required for:

- 1. <u>Bus Cancellations</u> to arrange transportation for your child(ren) to and from school or to provide supervised care during the day;
- 2. <u>Closed Schools</u> to provide supervised care during the day; and,
- 3. <u>Mid-Day School Closure</u> to provide the safe pick-up of your child(ren) at school and to provide supervised care during the day.

At Niagara Catholic, our primary focus and concern in making the challenging decision to cancel transportation and/or close schools is the safety of our students and staff. Funding from the Ministry of Education to operate our system is not affected by either decision. While all information is taken into account at the time of the decision and is monitored throughout the day for any changes, when schools are open, it is always the final decision of the parent or guardian whether or not to send your child(ren) to school during inclement weather.

I trust that the information on our decision-making and communication process along with the suggestion for a family contingency plan is helpful and informative to you and your family, as we continue to work together as partners in Catholic education in the Niagara Catholic District School Board.
