# Who We Are

A. T. Clancy School was erected in 1964. Additions were made in 1968 and 1990, after the school had been re-commissioned Monsignor Clancy Secondary School in 1989. In 1999 the school was reconstituted as an elementary school.

- Grades in the school: 4 to 8. Total student enrolment 480 students
- Our facilities include a chapel, science lab, library, 2 computer labs, 120 seat theatre, cafeteria, double gym, CyberQuest technology lab, instrumental music room & courtyard
- We are handicap accessible with specialized rooms for life skills instruction, sensory stimulation & physiotherapy
- In addition to the principal and vice-principal, we have 20 classroom teachers, 3 French teachers, 2 educational resource teachers and 2 CyberQuest teachers.
- The 2 Learning Strategies & Social Skills Classrooms located on site have full time teachers & full time Child & Youth Workers servicing students from across the peninsula
- We have an Intensive French program (grade 6) and an Extended French Program where history and geography are taught in French (grade 7 & 8)
- Support staff include: 1 part time child & youth workers, a library technician, a secretary, 6 educational assistants, two full time interpreters, a full time custodian and 3 cleaners
- Our grade 7 and 8 students attend classes at Cyber Quest, located in our school. This lab
  introduces students to broad base technologies including engineering design, C N C
  machining, wood working, filmmaking, digital editing and audio recording.
- In addition to the Ontario curriculum, we have a full religious program culminating in the Spiritual Centre and Outdoor Education Program (SCOEP) and the sacrament of Confirmation in the grade 8 year

# Niagara Catholic District School Board

In May and June of 2009, the EQAO Primary and Junior Assessments of Reading, Writing and Mathematics were administered. The results of these provincial assessments were released in September 2009. Students who have achieved a Level 3 or 4 on an EQAO Assessment have achieved the Provincial Standard as established by the Ontario Government.

The Niagara Catholic District School Board is celebrating the achievement of students in Grades 3 and 6 for exceeding the provincial averages in the EQAO Assessments of Reading, Writing and Mathematics. Our commitment to quality Catholic Education, and to the achievement of each individual child, has been demonstrated by the participation of 99% of all Grade 3 and Grade 6 students in the EQAO Primary and Junior Assessments.

The Niagara Catholic District School Board continues to facilitate Student Achievement on the EQAO Assessments through the dedicated and coordinated efforts of its staff through continuous School and Board Improvement Planning initiatives.

# **EQAO Background Information**

The Education Quality and Accountability Office (EQAO) tests students' skills in reading, writing and mathematics at key points in their elementary-school education. Students are tested twice:

- at the end of Grade 3, to assess what they've learned throughout the Primary Division (Grades 1–3)
- at the end of Grade 6, to assess what they've learned throughout the Junior Division (Grades 4-6).

# Why does Ontario conduct province-wide tests of reading, writing and mathematics?

In 1995, Ontario's Royal Commission on Learning recommended such tests for Ontario students. The Commission made this recommendation after consulting with parents, educators, students and others who wanted greater accountability and assurances of quality in the publicly funded education system.

# What do EQAO results tell me about my child?

EQAO test results provide a snapshot of your child's achievement in relation to the provincial standard. Students meeting or exceeding the standard (Levels 3 and 4) have demonstrated most or all of the required reading, writing and mathematics knowledge and skills expected at this stage in their education. However, no single test can offer a complete or definitive picture of what your child has learned. In the end, no one better understands the true measure of your child's abilities and knowledge—or is in a better position to assess them—than his or her classroom teacher. When used together, the results of EQAO and classroom tests provide a more complete picture of your child's knowledge.

We will use regular common assessment practices in every class across grades 4 through 8. We will regularly access the expertise of a Literacy Coach to share best practices in programming and teaching strategies.

The OHNIA:KARA Native Aboriginal Drum Group, who have been performing for students in Niagara Catholic's schools, performed a song of honour and appreciation for the Board to express their gratitude for the relationship formed with the Niagara Catholic District School Board.

The Electricity generated will be fed back to the power grid and, through a long-term "Feed-In-Tariff" contract with the Ontario Power Authority, is expected to return approximately \$184,800 per year to the Board energy budget.

## 10. <u>Ontario Brain Injury Association – Dianne Radunsky</u>

- The Ontario Brain Injury Association (OBIA) is still averaging 300 calls per month to our Support Services department. The greater part of our calls come from survivors and family/caregivers. The majority of professionals who call are looking for referrals to services, literature on ABI and many are inquiring about our training programs. We do receive a number of calls from college/university students working on a project or others who are interested in specializing in the ABI field.
- In December of 2009 OBIA, added the Brain Injury Association of Thunder Bay to their list of community ABI associations participating in the Peer Mentoring program. Collectively, we have been able to train 134 Mentors. There have been 132 partners across Ontario who have sought support through this program. The objective for 2010 is to increase marketing efforts and expand our reach. Currently, we have 15 ABI community associations participating in the Peer Mentoring program.
- OBIA reports 130 educational assistants from the Near North Board of Education taking our "Brain Basics" training program. John has been in discussion with a probation officer from the Ministry of Youth Justice with respect to, hopefully, taking our Brain Basics course in that direction.
- November's "Children and Youth with Acquired Brian Injury" training was attended by 70 professionals from the discipline of psychology, occupational therapy, nursing, personal support workers and caregivers/parents. The next Level I training program Neurorehabilitation: "Assisting Recovery and Function in Everyday Life Following Brain Injury" will be held on Feb. 22-25, 2010 at Brock University.
- In January our director John Kumpf met with representatives from the Fetal Alcohol Syndrome Association, the Learning Disabilities Association, The ADHD Association and the Tourettes Association to discuss a response to the Ministry of Education's "discussion paper" on neurologically based disabilities and how the needs of children with these disabilities better manage classrooms. The conclusion was that key strategies would be to provide awareness and training to educators to improve their understanding of these students. There is a meeting scheduled on Feb. 26, 2010 to meet with a representative from the policy Department of the Ministry of Education.
- John has been invited by an instructor to an Additional Qualification course on Special Education to make a presentation to 20 teachers who are taking the Special Education Part I course.
- Our calls have increased from parents of students who have a brain injury who are slated to start high school this coming September. The chief concern is, as usual, the students are deemed to be "slow learners" who will be put in a congregated class with a severely watered down curriculum. Transitions are always challenging and once again the answer is awareness and training.
- The good news is that we are getting more opportunities to provide the training and our expectation is that as the word gets around the requests will increase.

## NIAGARA CATHOLIC DISTRICT SCHOOL BOARD 2010 TECHNOLOGY SKILLS COMPETITION

## **BACKGROUND INFORMATION**

Each year, hundreds of Niagara Catholic students learn about the many career opportunities available to them in the skilled trades through programs offered at their schools. For the past six years, Niagara Catholic has provided students with the opportunity to showcase what they have learned in class in an annual Technology Skills Competition. This year, more than 200 students in Grades 10-12 took part in the Niagara Catholic Technology Skills Competition, which took place at the Glendale Campus of Niagara College in Niagara-on-the-Lake on March 4<sup>th</sup>, 2010, and at the former Canadian Tire store on Niagara Street in Welland on March 9<sup>th</sup> and 10<sup>th</sup>, 2010.

Students from all eight Catholic secondary schools competed in categories ranging from culinary arts and baking, to desktop publishing and web design, homebuilding, landscape design and automotive repair. The students with the highest scores qualified for the Skills Ontario competition at RIM Park in Waterloo May 17 <sup>th</sup> to 19 <sup>th</sup>, 2010. The national Skills Canada competition will run from May 20 <sup>th</sup> to 23 <sup>th</sup>, 2010. Last year, students from Niagara Catholic competed at the national level.

This year, Grade 9 students across Niagara Catholic were on hand while the students competed, allowing them the opportunity to learn more about the trades programs offered at Niagara Catholic secondary schools.

## **BACKGROUND INFORMATION**

The design of the 2010-2011 Niagara Catholic System Priorities and Annual Budget by Administrative Council will follow the same organization, consultation and implementation process as 2009-2010 with discussions and input from Principals and staff through Director's Meetings, department staff at the Catholic Education Centre, Curriculum Councils, SEAC, Catholic School Councils and the Niagara Catholic Regional Catholic School Council / PIC. The four (4) main system priorities along with specific indicators within each priority will provide the framework to design the annual budget and to measure the achievement of the priority

Once the system priorities are approved by the Board, a poster sized copy of the Niagara Catholic System Priorities 2010-2011 will be sent to all schools and Board sites to be prominently displayed. A copy of the Niagara Catholic System Priorities 2010-2011 will also be sent to Bishop Wingle, SEAC, Catholic School Council Chairs and the Niagara Catholic Regional Catholic School Council / PIC. A copy will also be placed on the Board website.

Recently, information from the Ministry of Education has been provided to Directors of Education and Superintendents of Business and Financial Services on the upcoming release of the Grants for Student Needs (GSN's) for 2010-2011 through Business Memorandums and presentations to Directors of Education and various Senior Board Staff. Over the next number of weeks, the Ministry of Education will host regional technical meetings for Superintendents of Business and Financial Services to provide additional details on the transfer of funds for District School Board Budgets for 2010-2011.

With the presentation of the Niagara Catholic Vision 2020 Strategic Plan scheduled for the May 11<sup>th</sup>, 2010 Committee of the Whole meeting, the timelines for the submission of the 2010-2011 Niagara Catholic System Priorities and Annual Budget to the Board have been aligned with the submission of the Vision 2020 Strategic Plan.

The proposed timelines are presented for the Board's information and consideration. (Appendix A)

Dear John,

I take this opportunity to express my thanks to you and the Niagara Catholic District School Board for the money from the Bishop's Gala and the schools to support the rebuilding process in the aftermath of the earthquake in Haiti.

All Holy Cross confreres in Haiti are most grateful for – and deeply touched by – the funds as well as the prayers of the NCDSB community.

As you are aware, this has been and continues to be a very difficult period in the life of the Haitian people. There is no easy fix, but the concern of so many throughout the world has been and continues to be an inspiration to the people of Haiti and our Holy Cross community in Port-au-Prince and other areas.

Father Gerald Cormier, in a recent letter, highlighted the difficulties in trying to re-establish education programs in the country. Firstly, school buildings must be checked to ascertain whether or not they pass safety inspections. Secondly, the education program has been dealt a major blow, as the Collége Saint-Louis de Gonzague, which is responsible for publishing most of the class notes for the various subjects on elementary and secondary school curricula, is in ruins.

Always impressive is the resilient spirit and deep faith of the Haitian people. Father Cormier quotes an old woman squatter who lives in the Sisters' courtyard in Turgeau. She is absolutely destitute and yet reminds people regularly: "The God who raised Jesus from the dead will raise Haiti from this disaster as he has many other times."

Again, the sincere thanks of the Holy Cross community, including and maybe especially, the community here in Welland. Your generous gesture has touched us all very deeply.

Thank you for forwarding a copy of your *Annual Report of the Director of Education*, *December, 2009.* We appreciated receiving your report which included your board's notable accomplishments. Your report provided a very good summary of information for parents and other stakeholders in a clear, concise and easy-to-read format.

You and all of the staff of the Niagara Catholic District School Board are to be congratulated on steadily increasing your students' provincial EQAO test scores over the last six years. Of note were the greater than 15% increases in Grade 3 Boys Writing and Grade 6 Boys Reading. Your data also shows that almost one in five Grade 6 girls within your board increased their achievement levels to the provincial standard or higher in Writing over the same time period. In addition, between 2003-2004 and 2007-08, the number of English Language Learner students within your school board who have successfully completed the Grade 10 Ontario Secondary School Literacy Test has increased by 12%. These results are significant accomplishments that your school board has achieved.

Parents and community members would also be interested to see within your *Annual Report* your board's data on the Primary, Junior, and Grade 9 Mathematics EQAO tests for your board's English Language Learner students and special education students. This information would further highlight your board's very strong focus on supporting students with a wide range of needs. As well, data on the successful programs that Niagara Catholic District School Board currently offers to students who are unable to attend regular school programs (i.e., for students in care, custody, treatment programs, and suspended and expelled students) would reinforce the introductory statement made within your *Annual Report* to parents and the community regarding your board's commitment to support all students as they strive to achieve their learning goals. John, it is very evident throughout your *Annual Report* that setting and maintaining high standards of academic excellence among your students and staff is an important priority. Your report outlined a wide variety of initiatives to support this priority including the work of Student Success Teams at each secondary school along with credit intervention strategies to support students at-risk, a revised teacher hiring practice designed to attract the best teachers, and a strong focus on differentiated instruction designed to meet the individual learning needs of your students. Your *Annual Report* also emphasized alternative learning opportunities for your students such as dual credit programs, a growing specialist high skills major program (SHSM) with the addition of an Arts and Culture SHSM program, and a vibrant adult and continuing education program.

The description provided in your *Annual Report* indicated parent and community engagement through a "... series of Discovery Sessions ..." which will shape the development of your board's "Vision 2020 Strategic Plan" due for release in May 2010. The Niagara Catholic District School Board school community would also be interested to learn about the many additional opportunities that your board currently makes available to parents and the community that allow them to be directly and meaningfully engaged in student learning.

You also noted in your *Annual Report* the current measures that the board has taken to align its Board and School Improvement Plan with the principles associated with the Ontario Equity and Inclusive Education Strategy. You and your staff are to be commended for taking the initial steps toward recognizing that the Ontario Equity and Inclusive Education Strategy goes beyond the development of a policy and involves a broad and deep cultural reform that supports and welcomes diversity among all students and families within the Niagara Catholic District School Board community.

Please share our congratulations and appreciation with your senior administration team, trustees, teachers and all of the support staff for the work they have done to help each student throughout your Niagara Catholic District School Board community achieve his/her greatest potential.

## Consultation Guide: Parent Involvement Committees (PICS)



As you are aware, Bill 177, the *Student Achievement and School Board Governance Act, 2009* has received Royal Assent, which will permit approval of a regulation to require every board in the province to have a PIC to reinforce the vital link between school and parents and bolster parent engagement at the grassroots level. The Ministry of Education welcomes your responses to the following consultation questions, which will be used to inform the development of a proposed new regulation, and are based on feedback from education stakeholders across Ontario to date. The Ministry acknowledges, with thanks, your participation in this important consultation.

## The role and mandate of PICs:

The following is a list of possible areas of focus for PICs. Do you agree that PICs can make effective contributions in these areas? Should any of these be removed from consideration? Are there areas that should be added to this list?

- Seek the advice of parents, school councils and interested community members and communicate this advice to the director and trustees.
- Encourage dialogue among school councils, the PIC and the board on relevant board policies, such as those that affect student achievement.
- Provide advice to the director and trustees on how to engage parents in support of student achievement.
- Assess the level of parent involvement in matters that relate to student achievement at the board level.
- Develop and implement an action plan to enhance meaningful parent engagement as a key factor in supporting student achievement.
- Be involved in the development of board improvement plans.
- Provide information to school councils and parents about Ministry initiatives aimed at reducing barriers to parent engagement.
- Determine, in consultation with the director and the board, how parent engagement funding provided by the Ministry is to be allocated.

## The role and responsibility of district school boards:

The relationship between the board and the PIC is important, and it is therefore important to establish roles for boards. In your view, are these reasonable expectations of boards?

- That the board consults with the PIC on policies and guidelines that affect student achievement, parents and families.
- That the board advises the PIC of actions taken in response to the PIC's advice.
- That the board provide appropriate facilities for PICs and make efforts to provide for members to attend meetings by electronic means.

## PIC composition and voting:

Please comment on the following to support a robust and effective PIC:

### Parent members

- Parents should make up the majority of PIC members.
- Eligible parents should be those who have a child attending a school within the board.
- An eligible parent may apply to the PIC for appointment to the committee.

### Director and trustee

As PICs are intended to provide a direct link between parents and the director of education and trustees, is the following membership a reasonable expectation?

- The Director of Education, or designate (an Associate Director or Supervisory Officer)
- A trustee, or designate (a fellow trustee of the board)

#### Community members

Community members bring a perspective from outside education.

- Should there be community members?
- If yes, how many community members should there be? Should there be a maximum?
- If yes, should community members be appointed by the PIC? If so, should the PIC be required to develop a process for appointing community members?

#### Additional members

Are there additional members who should be considered (e.g. student, principal)? Should they be included as required members, or as suggested members?

#### Voting or Non-voting:

Should it be specified which of the above categories that potentially make up the PIC are voting and non-voting?

- Parents?
- Director and trustee?
- Community members?
- Additional required/suggested members?

## Term of membership:

Should there be a set term for the duration of a PIC member's appointment (e.g. one year or two years)? Should there be an option for re-appointment? If so, should this be open-ended or limited? To help ensure continuity should the terms of PIC members overlap, so that not all terms begin or end at the same time? Should members of existing PICs be permitted to complete their terms prior to any new requirements coming into force regarding length of terms?

### Election of chair or co-chairs:

Should there be an option for chair or co-chairs?

Should the chair or co-chairs be parent members? If co-chairs, should both co-chairs be required to be parent members? Should it be specified that the chair or co-chairs be elected by members of the PIC?

## PIC meetings:

#### Frequency and attendance...

Should a minimum number of PIC meetings in a year be specified? If yes, how many? Should there be an option for PIC members to make alternate arrangements to attend meetings (e.g. by electronic means)? Should it be specified that all PIC meetings be open to and accessible by the public?

#### Majority requirement for meetings...

Should it be specified that PIC meetings cannot be held unless there is a majority of members present at the meeting? If yes, should it be required that a majority of those members present be parents? To help ensure the communication link between parents and the director and trustees, should it be specified that PIC meetings cannot be held in the absence of the Director and the trustee (or their designates)?

## PIC meetings: Records

PICs are an important conduit for information between school councils and the broader community, and the board and are a key vehicle for enhancing parent involvement in support of student achievement at the board level. Records will assist in this very important function, and will help ensure transparency and accountability. Should it be specified that:

• Meeting minutes and financial records should be recorded and maintained by the PIC?

- Meeting minutes should be posted on the board website and distributed to all school councils of the board?
- PICs should submit a written annual report on its activities to the board?
- Directors should make the annual report available to all school councils and post it on the board website?

In December, 2009, Marco Magazzeni, Niagara Catholic's K-12 Technology and Specialist High Skills Major Consultant, and Andrew Keltos, a Cyberquest instructor at St. Mary Catholic Elementary School in Welland, prepared a video entry to the competition. Titled *Global Challenges - Partnerships in Education*, the video highlighted Niagara Catholic's many partnerships with industry and community organizations throughout Niagara.

On February 23rd, Niagara Catholic was informed that the Board has been selected as a 2010 Global Best Award recipient in the Global Challenges category and has been invited to present the video submission at the conference in April.

In addition to receiving the Global Best Award, Niagara Catholic is also in contention to be named the overall region winner for the Americas and to win the overall competition.

Those winners will be announced during the International Education Business Partnership Conference, *Making a Difference in Today's Global Economy* - The Power of Partnership April 25th-28th in Toronto.

## Aboriginal Culture Thriving at Niagara Catholic Schools

Aboriginal education is alive and well in Niagara Catholic schools.

The Ministry of Education has identified Aboriginal education as one of its key priorities, with a focus on meeting two challenges by 2016: Improving student achievement among Inuit, Metis and First Nation students and to close the gap between Aboriginal and non-Aboriginal students in the areas of literacy and numeracy, student retention, graduation rates and advancement to post-secondary education.

The program also increases the understanding of Aboriginal culture by non-Aboriginal students.

To meet these goals, Niagara Catholic applied to and received funding from the Ministry of Education to provide special programming to broaden awareness of Aboriginal culture in Niagara Catholic schools. The funding has made it possible to bring Aboriginal drummers and dancers into schools, to host a Catholic Secondary School Aboriginal Education Symposium for students, teachers and administrators, to appoint an Aboriginal Education Liaison Co-ordinator and to offer a Grade 10 class specializing in the Aboriginal Peoples in Canada at Blessed Trinity Catholic Secondary School and Lakeshore Catholic High School.

Since receiving funding approval, Niagara Catholic staff have been working towards the full implementation of these initiatives.

## Niagara Catholic to Generate Energy from Rooftop Solar Panels at Two New Grimsby Schools

Niagara Catholic will receive \$1.9 million to install solar panel systems at two west-Niagara schools currently under construction.

On February 19th, the Ministry of Education informed Director of Education John Crocco the Board will receive \$943,373 for each school, to install rooftop solar photovoltaic systems at St. Joseph and Our Lady of Fatima Catholic Elementary Schools in Grimsby.

In a report to the Board at the Committee of the Whole Meeting on March 9th, Controller of Plant James Woods said the two new school projects offered an excellent opportunity for Niagara Catholic to install large solar photovoltaic systems. The systems allow electricity generated by the solar panels to be fed back to the power grid. Through a"Feed in Tariff" contract with the Ontario Power Authority, the panels are expected to return approximately \$185,000 per year to the Board's energy budget.

During construction, each school will be equipped with framing to support a total of 504 solar panels. A web-enabled data acquisition system to monitor the energy generated is also included. A 40-inch display streaming the output will be placed in a prominent location of each school so staff and students can have a constant reminder of the solar power system.

The data system will also include a weather monitoring system, which will monitor the room temperature and the temperature of the solar panels, wind speed and direction. This will show how a grid connected to a solar power system functions.

This new solar photovoltaic system will tie into the Board's philosophy of environmental stewardship. All Niagara Catholic schools have fully implemented the Ontario EcoSchools environmental education program, which incorporates energy and energy conservation ideas in all grades. The new system will tie into this program, as well as other learning opportunities at all Niagara Catholic schools, due to the systems monitoring and data acquisition opportunities available over Niagara Catholic's computer network.



Two Niagara Catholic Elementary Schools will not only use less power once they are in operation in September, 2011, they will also put energy back onto the grid. When they are constructed, St. Joseph and Our Lady of Fatima Catholic Elementary Schools in Grimsby will have among the largest arrays of solar panels installed in Canada. The systems are expected to be in operation by August 31, 2011. The image above is a rendering of the design for Our Lady of Fatima Catholic Elementary School.
