ADDITION AND ALTERATIONS TO ST. AUGUSTINE CATHOLIC ELEMENTARY SCHOOL AWARD OF CONSTRUCTION CONTRACT

BACKGROUND INFORMATION:

Tenders were opened on Tuesday July 20, 2010 for the addition and alterations to St. Augustine Catholic Elementary School, as per the drawings and specifications prepared by Graff Grguric Architects Inc. The results of the tender were as follows:

PROJECT SCOPE:

The project includes the addition of a new library, renovations to the existing library to be two new general classrooms, expansion of two classrooms to be new early learning classrooms, and creation of a new playground, driveway entrance and parking for the early learning area.
