# AWARD OF CONSTRUCTION CONTRACT

### **BACKGROUND INFORMATION**

Tenders were opened on Friday March 4, 2011 for the addition and alterations to St. Anthony Catholic Elementary School, as per the drawings and specifications prepared by Garwood-Jones & Hanham Architects.

The following motion was approved at the Special Board Meeting of April 12, 2011:

**"THAT** the Niagara Catholic District School Board approve the award of a construction contract to Charter Building Company for the addition and alterations to St. Anthony Catholic Elementary School in the amount of \$1,728,360."

A post tender addendum was issued to the three lowest bidders on April 18, 2011 and were received and analyzed by the architects. A recommendation was made on May 3, 2011 to award the contract to Merit Contractors Niagara Ltd. as per the following details:

#### **PROJECT SCOPE**

The project includes the addition of three new kindergarten classrooms and paved playground, as well as a required upgrade to the building electrical supply.

#### FUNDING

Funding for the project is from the following sources:
