STATEMENT OF POLICY

Policy No 100.11

Adopted Date: September 28, 2010

In keeping with the Mission, Vision and Values of the Niagara Catholic District School Board, Niagara Catholic is committed to It is the Policy of the Niagara Catholic District School Board to recognizing the importance and value of providing fair levels of honoraria for elected Trustees of the Board members as set out in Ontario Regulation 357/06, "Honoraria for Board Members"

Ontario Regulation 357/06 sets out the method for calculating the limits on honoraria paid to elected Trustees under section 191 of the Education Act. The regulation states that the honorarium shall consist of the following four (4) components:

- 1. The base amount for the year
- 2. The enrolment amount for the year
- 3. The attendance amount for the year
- 4. The distance amount for the year

The honorarium for elected Trustees of the Board will be calculated in accordance with the provisions of Ontario Regulation 357/06 and the honorarium will be adjusted each year to take into consideration the changes in enrolment from the previous year. Separate honoraria will be calculated for the Chair of the Board, the Vice Chair of the Board and for the Other Elected Trustees.

The Honorarium for elected Trustees of the Board Members, will be for each year of the term of office from December 1, 2010 to the following November 30, 2014 annually. will be calculated in accordance with Regulation 357 and shall consist of the following amounts:

In compliance with the Education Act Regulation 357/06, at the annual December Board Meeting, a Trustee Honorarium report and recommendation for the annual honorarium for all elected Trustees will be presented and then all amounts shall be posted.

## STAFF DEVELOPMENT DEPARTMENT PROFESSIONAL DEVELOPMENT OPPORTUNITIES

### **BACKGROUND INFORMATION**

In alignment with the Board's Vision 2020 Strategic Plan and Annual System Priorities, the Department of Staff Development, as an integral aspect of its mandate, acts as the point of co-ordination among various departments. Thus ensuring that all professional development opportunities for staff, both teaching and non-teaching, occur in a seamless fashion so as to minimize disruptions to the myriad services provided within our Niagara Catholic community.

The following is a listing of activities occurring during the period April 4, 2017 through May 9, 2017.

### Wednesday, April 5, 2017

Assessment, Evaluation and Reporting Learning Sessions with Tom Schimmer (Double Tree Fallsview Resort)

- As we continue to implement and improve assessment, evaluation and reporting practices, Tom Schimmer, author of *Grading From the Inside Out*, will be providing two professional learning sessions for administrators and select staff from both the elementary and secondary panels.

### Thursday, April 6, 2018

Early Childhood Educators - Teacher Talk Training (Catholic Education Centre)

- As part of our continued effort to develop strong oral language skills in our youngest learners, Early Childhood Educators from the following schools are invited to participate in The Hanen Centre – Teacher Talk workshops. Teacher Talk covers the key principles of Learning Language and Loving It, providing educators with core strategies that will help them create rich and stimulating classroom learning environments. The Teacher Talk training sessions are designed to actively engage participants through discussions, small group activities, analysis of video examples and practical Action Plans that participants can take back to the classroom.

### Tuesday, April 18, 2017

Gap Closing in Literacy (Catholic Education Centre) – Session #3 of 4

- As part of the Ministry of Education's ongoing commitment to supporting literacy achievement, special funding has been allocated to support Gap Closing in Literacy in Grades 7-12. This initiative will aim to foster more precise and targeted reading instruction in applied level courses within specific subject areas (2017 Dates: February 15, March 9, April 18 and May 18).
- The work will focus on using assessment to better inform our decision making around next steps for reading instruction, and learning about how technology and specific ministry resources, such as, the *Adolescent Literacy Guide*, can help support student learning. The learning will be approached with an understanding that the literacy challenges students encounter will be different in each discipline and will need to be differentiated accordingly.

### Wednesday, April 19, 2017

New Teacher Induction Program (Holiday Inn, Ontario Street)

- Protégés and mentors will participate in a full day professional development session focusing on a variety Special Education topics such as Individualized Education Programs (IEP's), Executive Functioning and Niagara Catholic DSB support structure for students with special needs.

### Thursday, May 4, 2017

*Leadership Identification Program (LIP) – Session #4* 

- The Niagara Catholic LIP Committee will host Frances Jacques and Nick Teti from CPCO. The LIP candidates will participate in two sessions. Session one is titled: Integrating Life and Work. Session two is titled: and Leading Through Difficult Conversations.

## NIAGARA CATHOLIC ALTERNATIVE LEARNING PROGRAMS

### **BACKGROUND INFORMATION**

In alignment with the Niagara Catholic District School Board's Mission, Vision, Values, its Vision 2020 Strategic Plan and its annual System Priorities and Budget, the Boards Alternative Learning Programs provides all students with different programs, supports, services and environments in order to achieve personal and academic goals.

### **Pope Francis Centre**

The Pope Francis Centre provides our students with an alternative - school connected place to learn with individually designed programs, experiences and support. The Pope Francis Centre motto is "A Place Where all are Welcome". The Centre works in conjunction with several other Niagara Catholic alternative programs designed to support all students, wherever their educational journey takes them, in a non-traditional school setting.

### Niagara Catholic LINK

Niagara Catholic LINK is a program designed for students who are not currently attending secondary school or who are at risk of leaving school before graduation. Niagara Catholic LINK allows students to work towards earning secondary school courses while at the same time earning one Niagara College Dual Credit. (A Dual Credit counts both as a secondary school credit AND a College general elective credit).

### Supervised Alternative Learning Plan

A Supervised Alternative Learning Plan (SALP) is used to encourage students who are at risk of not graduating to continue their education in an alternative manner. Students who are not attending school regularly are encouraged to apply to a SALP along with parental/guardian support. The goal of the SALP is to re-engage students to work towards their secondary school diploma and graduate with their peers.

### Saint Kateri Located in the Former Village of St. John's

The Niagara Catholic District School Board and Niagara Regional Native Centre have formed a partnership in providing secondary school students as well as adult learners of the indigenous community an opportunity to complete their OSSD in an alternative learning setting. Together in partnership with Niagara Peninsula Conservation Authority we are able to provide this learning environment at Saint Kateri located in the former Village of St. John's.

### **Community Outreach Teacher**

The Niagara Catholic District School Board supported a Community Outreach Teacher in the Fall of 2016. Together with the assistance of the Board Attendance Councilor, several students have been provided various options in order to complete the Ontario Secondary School Diploma (OSSD). Both the teacher and counselor reach out to community partners and agencies and find students of all needs and all points of their life who need assistance.

### Young Parent Support Program

A Young Parent Support Program has been established to provide a safe nurturing environment for young parent(s) who may be experiencing challenges with completing school credits within a traditional school setting. With the added responsibility of caring for their child, the Parent Support Program provides an environment conducive to learning and caring for their child all within the same setting.

### **Parent Support Program**

The Parent Support Program is for young mothers and fathers or mothers-to-be (up to 21 years of age) working to earn high school credits in an alternative learning environment and have the opportunity to bring their child to school. Parents are provided with opportunity to complete the requirements for an Ontario Secondary School Diploma and their home school's Catholic School Graduation Diploma.

### **Children Youth in Care**

The Children Youth in Care (CYIC) Program at Niagara Catholic District School Board provides additional support to Crown Ward students in Secondary Schools. A designated teacher is assigned and provides academic support to students and assists them in navigated school resources as well as transitioning to post-secondary opportunities. The CYIC Teacher meets students in their school or off site.

## TRANSITION TO THE ONTARIO AUTISM PROGRAM – NEW FUNDING TO SUPPORT SCHOOL BOARDS

### **BACKGROUND INFORMATION**

On June 28, 2016, the Ministry of Education (EDU) issued a memorandum to Directors of Education providing information regarding new one-time funding to support district school boards as a result of the changes to autism services under the Ministry of Children and Youth Services (MCYS). The new funding provided spans both the 2016-2017 and 2017-2018 schools years to support boards during the transition period to the new Ontario Autism Program. A subsequent memorandum to Directors of Education and Supervisory Officers of School Authorities, issued on September 29, 2016, outlined information regarding the eligibility to apply to run After Schools Skills Development Programs specifically for students with Autism Spectrum Disorder (ASD). EDU and MCYS continue to work together to provide supportive environments for children with ASD and their families.

As outlined in both memoranda, the role for school boards regarding the one-time funding from EDU is outlined below:

- meet the increased demand for Connections for Students transition teams, including the hiring of additional personnel (e.g. professionals with Applied Behavioural Analysis (ABA) expertise);
- provide school-based team support to all students impacted by changes to autism services; and
- submit applications to receive funding for After Schools Skills Development Programs that focus on different areas such as social and communication skills development and behaviour management for students with ASD, intended to run in the 2016-2017 and 2017-2018 school years during the transition period.

Based on the EDU funding received, Niagara Catholic has been able to provide additional supports (human resources, professional development, programs, supplies) to respond to the needs of staff and students during the transition period. A sample of supports is listed below:

- hiring of additional ABA Supervisor to align with Student Achievement three team area approach;
- hiring of three new short term positions, ABA Special Needs Facilitators, that provide direct service to schools to support students with ASD and resource support to staff;
- approval of Niagara Catholic's submission to provide After Schools Skills Development Programs for students with ASD. These after school ABA programs will introduce selected students to a variety of activities geared to support skill acquisition in the following domains: social skills, executive function, self-regulation, safety/community, communication, fine/gross motor skills;
- release time and resources for secondary school staff for professional development in the area of ABA principles and executive functioning to support the work of the Renewed Mathematics Strategy.

During the Committee of the Whole Meeting, Kristin Baker, Cathy McMullin and Julia Nemcko, ABA Supervisors, will provide a short overview of Niagara Catholic's work in supporting all students using ABA principles and outlining the after school skills development programs proposed to be offered during the 2016-2017 and 2017-2018 school years.

Each month during the Board Meeting, one school makes a presentation to the Board of Trustees, showcasing the great things happening in their school.

This month, St. Michael Catholic Elementary School in Niagaraon-the-Lake was in the spotlight, and Principal Blaine

MacDougall was joined by Nieva Mastromatteo and Oishi Ray to share what makes St. Michael such an integral part of the Niagara-on-the-Lake community.

The school is heavily involved in both local projects, such as the Board's Kids Helping Kids campaign, the Niagara-on-the-Lake Christmas parade and food and toy drives, as well as national and global projects such as the Terry Fox Run, WE Day, Backpacks of Hope and adopting a "sister school" each Christmas.

Principal MacDougall spoke about the ways in which staff at the school work together to promote student success and engagement.

Divisional meetings take place at the school level to discuss programming each month, and School-Based Team meetings take place monthly to discuss students in need of support.

Student council holds weekly meetings to discuss topics that are important to students and monthly Catholic School Council meetings are held to promote parent involvement. Volunteer reading and math programs encourage students to continue to grow their skills.

St. Michael has a close relationship with its parish church, St. Vincent de Paul, through rosary circles led by members of the parish's Catholic Women's League. The school has been active in participating in the second tier of the Board's Catholic Educational Congress in collaboration with Father Randy Gallant, and students have expanded its retreat program for students.

#### Contract Awarded for Addition to Our Lady of Fatima Catholic Elementary School

During the March 28 Board Meeting, the Board approved awarding the contract for a \$4.5-million addition to Our Lady of Fatima Catholic Elementary School in Grimsby to Brouwer Construction (1981) Ltd. of St. Catharines.

This project consists of six classrooms and three child care rooms, and includes improvements to parking, landscaping and walkways, as well as the demolition of the former Cyberquest program building.

#### WEEKLY ROUNDUP

**WELL FED** – With Liberal majorities in Ottawa and Queen's Park, gone is the rhetorical bombast that used to surround Budget days – which reached its apex a decade ago when federal Finance Minister **Jim Flaherty** and his provincial counterpart **Dwight Duncan** would spend weeks hammering each other every spring. Nowadays the men in those respective roles, **Bill Morneau** federally and **Charles Sousa** in Ontario, speak of each other only in the softest of tones – if at all. "It's a budget that talks about maintaining the status quo," was as much as Sousa could muster in terms of a review of the federal fiscal plan unveiled this week. (PC Finance Critic **Vic Fedeli** noticed the partisan niceness, chiding, "Look, if this was a Conservative budget you would have seen passion, table pounding from [Sousa].") Even before Morneau tabled the federal Budget, Sousa had pronounced that it would make little difference to his own, at least in terms of eliminating the deficit. Sousa affirmed that Ontario will "absolutely" be in the black in the upcoming provincial Budget, which is expected within the next few weeks – reportedly either April 6 or April 13. Sousa wouldn't confirm the date, but acknowledged that Morneau's Budget was the final major piece. "The [Ontario Budget] will come out after we take a full review [of the federal plan] and after we lock in our numbers," Sousa told reporters. Much of the document is no doubt already written.

**UP AND AD 'EM** – Government advertising is always buried in Budget minutiae, but it inevitably raises the hackles of the Opposition – and, they hope, voters. Both the PCs and NDP were apoplectic this week about radio ads touting the Ontario Liberals' plan to reduce consumer hydro bills. They assert that the taxpayer-funded ads, featuring a narrator intoning, "We've heard you and we're taking action with the fair hydro plan," are actually quite partisan. PC House Leader **Jim Wilson** went so far as to claim the ad campaign is in contempt of the Legislature by presuming the outcome of the legislative process. "It not only definitively states the result of legislation that is yet to be tabled by the Minister of Energy, which is '25% off your hydro bill,' but also presents an unqualified timeline: 'starting this summer,' " Wilson argued in his contempt complaint. Speaker **Dave Levac** shot it down, but the Tories know most voters don't much care about parliamentary process anyway. The real value from an Opposition standpoint is in the attendant media coverage. To that end, Auditor General **Bonnie Lysyk**, who has been in a public feud with the Liberals over their diluting of her authority to censor government ads, didn't miss the opportunity to pile on. "Under the previous legislation it would likely not have passed because it does convey a positive impression of the current government," Lysyk said. "It's more like a pat-on-the-back type of advertisement." Both PC Leader **Patrick Brown** and NDP Leader **Andrea Horwath** parlayed Lysyk's umbrage into platform planks, each committing to reinstate the Auditor's vetting authority if they form government.

BROWN AND SERVE - Speaking of partisan advertising (which nobody has a problem with as long as the parties

pay for it), the Tories have launched a new series of short videos in what is openly being called the "Brand Brown" campaign. The 20-second spots emphasize the big-tent philosophy Brown is espousing, each opening with the caption "I BELIEVE" followed by shots of the PC Leader marching in the Pride parade, in ethnic garb and meeting with various stakeholders. All of this is overlaid by excerpts from Brown's speech to a party convention a year ago, when he described himself as "a pragmatic progressive conservative" and welcomed a wide range of demographics with, "It doesn't matter … who you love … where you worship … if you belong to a union … etc. … You have a home in the Progressive Conservative Party of Ontario." Not surprisingly, the Liberals have their own "Brand Brown" campaign that is somewhat less complimentary. In their latest salvo, they launched a website building on a recent theme, FactsStillMatter.ca. According to Liberal agitprop, "We developed these tools to document the misinformation that Patrick Brown has been spreading across Ontario, and challenge the myths in one place." There isn't anything subtle about the partisanship here – the home page features a large picture of Brown scowling, with the caption, "The Man with No Plan."

**COFFEE SPILL** – In the hyper-sensitivity of the current pre-election atmosphere, statements don't have to be blatant to cause problems, as PC MPP **Randy Pettapiece** found out this week. Pettapiece was evidently trying to be funny at a committee hearing on public appointments, but his choice of words was all Liberal **Daiene Vernile** needed to pounce. In approving the appointment of engineer **Rumina Velshi** to the Ontario Energy Board, Pettapiece made a joke about the committee's notoriously bad coffee. But the way he phrased it led to an uncomfortable exchange:

Pettapiece: Maybe with her background, she could go to the kitchen and get them to do something about this coffee.

Vernile: You want a woman to go get coffee for us, is that what you're saying?

Pettapiece: No, do something about it, the taste of it.

Vernile: Why is it her responsibility?

Pettapiece: With her scientific background.

Vernile went in for the kill later with reporters, aiming to reinforce the Neanderthal image the Tories are trying to dispel. "This is a woman with incredible academic and professional credentials," Vernile fumed. "That he would order her to go to the kitchen — 'go to the kitchen,' he said — and do something about the coffee was demeaning, degrading and, I think, sexist." Pettapiece subsequently apologized, and Velshi insisted she was not in any way offended. "It was a clumsy attempt at humour," she said. "During the committee meeting, his comments about my qualifications were entirely positive." Her son, **Alykhan Velshi**, just happens to be Patrick Brown's new Chief of Staff.

**LEAVING LADY** – As nominations for incumbent MPPs continue to accumulate, one long-serving MPP – in fact the longest *ever* serving female MPP – has reached the end of her political road. **Julia Munro** announced this week that she will not be seeking re-election in 2018, bringing to a close a Queen's Park career that began nearly 22 years ago. Despite being elected on the **Mike Harris** *Common Sense Revolution* ticket in 1995, Munro has a reputation as a moderate, which has earned her respect across party lines. Indeed, Women's Issues Minister and Liberal MPP **Indira Naidoo-Harris** praised Munro as a "trailblazer," noting, "There was a time when people thought there was no place for women in politics. Well, they were wrong." PC MPP **Laurie Scott** also paid tribute, telling the House, "Every day is a new record for the member from York-Simcoe or, as we call her, Lady Munro. We seek to be as professional as, and to continue to be mentored by, the gracious member."

#### IN THE HOUSE

- Treasury Board President Liz Sandals introduced Bill 111, the *Supply Act*, routine legislation to authorize the public payroll for the current fiscal year.
- Bill 92, tweaking school board collective bargaining, passed Third Reading, by a vote of 53-38, with the Tories and NDP voting against it.

#### FOR THE RECORD

"There's a whole lot of people in the Ontario Liberal party who think that it's all over. ...You have to ask yourself, Premier, whether given that scenario, it's better to step down before the next election. The [polling] numbers do not lie and the ability to win the next election is in grave grave doubt."

• Former Ontario Finance Minister and Ontario Liberal Party President **Greg Sorbara**, on TVO's *The Agenda*, suggesting Premier **Kathleen Wynne** is hindering the party's re-election chances since, in his words, it is "extremely unlikely" she'll win.

"The fact is there is a lot of momentum in the U.S. right now for 'Buy America' kinds of approaches. That's what we're up against. So it will be a challenge for us to get an exemption. We recognize that. But it's something we'll certainly be doing our very best to try to achieve."

• Economic Development Minister **Brad Duguid**, who along with International Trade Minister **Michael Chan** was in the New York state capital of Albany this week, trying to convince legislators there not to adopt President **Donald Trump**'s protectionist stance. Duguid said they positioned their argument as being in the Americans' own self-interest, explaining, "there are a lot of American jobs dependent on an unfettered trading relationship and open procurement between New York State and Ontario."

#### WEEKLY ROUNDUP

**FISCAL THERAPY** – The now-annual drip-drip-drip of the provincial Budget is underway, with Finance Minister **Charles Sousa** offering little hints about what will be in his pending fiscal plan. This week he talked of measures to cool Toronto's blistering housing market, adding that it won't be just one step, suggesting he's looking at a "suite of options." Sousa is also being coy about the actual date for the Budget – "It's not complete, yet" was his answer to that question from reporters. April 13<sup>th</sup> is seen as a possible timeframe, although that's the day before Good Friday. Given that Sousa needs a robust post-Budget tour to sell the initiatives – a must for the Liberals to have any hope of turning around their sagging popularity – it would be an odd strategy to launch the Budget right before a momentum-killing long weekend. Once the date is set, look for an onrush of announcements, as the LIBs keep up a tradition of rolling out many of the key Budget themes in advance.

**GREGATIVITY** – As Sousa prepares for the upcoming Budget, the words of a *former* Liberal Finance Minister are hanging heavily in the air. **Greg Sorbara**, who once wielded supreme influence in Ontario Liberal politics, stunned friends and foes alike when he opined, on TVO's *The Agenda*, that poll numbers put Liberal re-election chances in "grave, grave doubt," and that Premier **Kathleen Wynne** should step down. Coming from a Liberal power broker – Sorbara notably threw his support behind Wynne during the leadership convention that installed her as Premier – the comment has layers of intrigue. He's known as a canny politician, so many observers assume the move was calculated, and there is much speculation about what might happen next. Wynne couldn't have been happy about it, surely, but she put on a brave face when it once again raised questions about her immediate future. "Punditry is a wonderful thing," she shrugged. "Retired politicians engaging in punditry is an even more wonderful thing. I will leave Greg and whoever else to their opinions. There's no secret there have always been people in the Liberal Party who weren't keen on me. That's a reality." If there is going to be an internal campaign to push Wynne out, it will have to happen soon, giving the party time to pick and groom a new leader before next year's election.

**DIRTY DOZEN** – Even before Sorbara made his pronouncement, new polling numbers bolstered his case. A national survey by the Angus Reid Institute pegged Wynne's approval rating at 12% – a horrible number on many levels. It's a drop of four points from a similar poll last December; it's the worst among Premiers across the country; and it's the second-lowest rating ever recorded in this regular poll. (Only B.C.'s **Gordon Campbell** ever got lower approval, in single digits – paving the way for his resignation in 2010. As Sorbara is no doubt aware, Campbell's successor **Christy Clark** managed to fix the damage, keeping the Liberals in power in the subsequent election.) Later in the week Forum Research poured more fuel on the fire, releasing poll results showing the Liberals potentially losing party status. According to Forum, the Tories have 43% support among decided voters, the NDP

28% and the Liberals just 19% – which, translated to seat counts, would give the PCs a big majority and leave the LIBs with only seven seats. Despite these low numbers, however, most pundits – excepting, perhaps, Sorbara – still see a race in Ontario. Wynne has a reputation as a very good campaigner, and her chief opponent, PC Leader **Patrick Brown**, is still a relative unknown. Interestingly, Wynne and Brown have somewhat similar story arcs, in that both have been perpetually underestimated, and both made careers from outhustling rivals.

**OH, MAN** – We're still more than a year away from the next provincial election, but already the hyper-partisanship of a campaign is starting to swamp Queen's Park – when every move and utterance is subjected to howls of outrage from the other side. Two cases in point this week:

- PC MPP Jack MacLaren, whose sexist jokes at a cancer fundraiser last year got him banished from the Tory caucus while he underwent sensitivity training and thereby painted a target on his back for the Liberals got in trouble again during legislative debate. The offending quote had to do with protecting patients from sexual abuse, and MacLaren's contention that the proposed laws are too rigid: "Any time you hear the term 'zero tolerance', I find that dangerous, because there always has to be consideration of leniency, of understanding and of tolerance." Cue the umbrage, ranging from Health Minister Eric Hoskins admonishing, "Zero tolerance means just that. Zero tolerance for any form of sexual abuse of any kind by anyone, period," to Deputy Premier Deb Matthews going for the jugular by describing MacLaren's comment as "a throwback to another era when misogynist opinions were the norm." MacLaren later apologized, but Brown felt compelled to distance himself from the wayward MPP again. "There's no grey in this issue," Brown pronounced. "It was a foolish comment." (Brown, notably, has not blocked a nomination challenge against MacLaren. Prominent Ottawa physician Merilee Fullerton has the green light to try and usurp MacLaren, and she reportedly has the backing of some Tory heavyweights in the area.)
- Brown was also on the defensive about another event that, under normal circumstances, would barely register on the political radar. But in these days of overheated scrutiny, giving a speech to the Cambridge Club is apparently akin to a war crime. See, the Cambridge Club is men-only, and when the Liberals learned Brown would be speaking there they pounced, with Women's Issues Minister Indira Naidoo-Harris charging, "He's sending a very strong message that, in terms of how he regards Ontarians, he's fine leaving women out." Except that Brown's speech was at the Toronto Athletic Club which, while owned by the Cambridge Club, is in fact wide open to anyone. As the Tories snidely pointed out, former NDP MP and noted feminist Olivia Chow has spoken there. They, and many commentators, deemed the Liberal indignation to be "excessive."

Only 14 more months of this to go.

**NIAGARA FRONTIER** – One woman who clearly doesn't think the Tories are sexist is Wainfleet Mayor **April Jeffs**, who will be acclaimed for the party's nomination in the newly-created riding of Niagara Centre on April 9<sup>th</sup>. This is something of a coup for Brown, inasmuch as Jeffs is exactly the kind of candidate he is trying to attract – female, relatively young, experienced in business and politics. The only knock against her would be that she doesn't live in the new riding, but few expect that to be a serious hindrance. Jeffs lives in the reconfigured riding of Niagara West, which is held, strongly, by **Sam Oosterhoff**. Speaking of the teenage MPP, he's another reason for Brown to smile. Far from the punchline he was supposed to be, most of the reviews of Oosterhoff have been positive, with stakeholders visiting his office saying he is always well-briefed and articulate, earning respect that belies his youth.

#### **RUMOURS & RUMBLINGS**

#### TO DIE FOR

Many MPPs report they have rarely seen a public response as intense as that around Bill 84, provincial legislation with respect to medical assistance in dying. Public hearings finished this week, amid an outpouring of correspondence. Literally tens of thousands of people have emailed or snail-mailed constituency offices asking that

the conscience rights of healthcare professionals be protected through the bill – i.e., healthcare providers who are morally opposed to assisted suicide should not be forced to provide it, or referrals, for their patients. Conscience rights advocates were equally active in successfully lobbying at the federal level, convincing MPs and Senators to agree to protections last year. Under the banner of www.canadiansforconscience.ca almost 43,000 electronic letters have been sent to federal and provincial officials. Of those, some 22,000 were to Ontario politicians, while thousands more were sent by regular mail. "The days of traditional lobbying are over," observed our own **Peter Landry**, Enterprise's Managing Principal, who spearheaded the campaign. "The digital world has changed everything. If you can't harness constituents to care and act on an issue, your cause will be an also-ran."

- Michael Coteau, Minister responsible for Anti-Racism, introduced Bill 114, the *Anti-Racism Act*, to embed the Anti-Racism Directorate in law and promote a "whole-of-government effort towards identifying and redressing systemic racism in our society."
- Bill 111, the Supply Act authorizing the public payroll, passed Third Reading.

"At a time when Ontario ratepayers are hurting, this kind of compensation is not only undeserving, it's a slap in the face. In a year where tens of thousands of Hydro One customers were disconnected and hundreds of thousands were found to be in arrears because of uncontrolled hydro prices, executive salaries ... hit astronomical new highs."

PC Energy Critic Todd Smith, getting a jump on the annual "Sunshine List" of high government earners – which comes out today – by assailing the salaries of Hydro One brass. Although the newly-privatized utility only has to publicly release the pay packets of its top five executives, the fact that the quintet pulled in some \$11 million last year gave Smith plenty of ammunition.

"All municipalities are struggling, including our own. I think we just have to make it work, because I can't imagine any government de-amalgamating a city like Sudbury. I think it would create all sorts of chaos. It's a good debating point, however."

• Floyd Laughren, who was MPP for Nickel Belt for 26 years and Finance Minister in the NDP government of the 1990s, opposing renewed calls for Greater Sudbury – which was created under the PC government that succeeded his – to be split back into smaller municipalities.
