LARKIN ESTATE ADMISSION AWARDS 2020-2021

BACKGROUND INFORMATION

The Larkin Estate Admission Awards are administered by the Board of Trustees of the Niagara Catholic District School Board. Funding for the awards comes from a bequest from the estate of Maria Eveleen Larkin and Aimee Theresa Larkin. These awards have been administered annually since 1969 by the Board of Trustees of the former Lincoln County R.C.S.S. Board.

As of March 31, 2020 the undistributed earnings and the balance of the scholarship fund amounted to \$24,780.86 with projected interest in the amount of \$5,000 to the end of 2020. According to the terms of the bequest, the undistributed earnings may be paid to eligible students who are approved by the Board.

The Larkin Estate Admission Award is available to graduates of a Catholic high school situated in the jurisdiction of the Niagara Catholic District School Board. Candidates must be enrolled in St. Michael's College, University of Toronto, or a school of nursing, social service work or a college or university offering such course. Applications have been reviewed and a list of qualifying candidates has been prepared, as noted on Appendix A (New Applicants).

The applicants have been made aware that they must provide proof that they have registered in the eligible courses and/or school in order to receive the award. This proof is in the form of an official letter from the registrar of either St. Michael's College or a school of nursing, social service work or a college or university offering such course. Candidates are also obliged to submit evidence of successful completion of their year's study in order to qualify for a renewal of the award. (Appendix B - Renewal Applicants)

LIVE STREAMING AND MODERNIZATION PROJECT – FATHER BURNS CSC BOARD ROOM AND HOLY CROSS COMMUNITY ROOM

BACKGROUND INFORMATION

In fiscal 2018-2019 an initiative was launched to complete a comprehensive review of our current audio visual (AV) system for both the Father Burns csc Board room and the Holy Cross Community Room. A decision to begin sourcing an AV consultant and provide pricing to modernize both these rooms was agreed upon by Senior Administration. This decision was in response to our existing AV equipment, which has become completely antiquated, cumbersome and ineffective. Niagara Catholic has reached a point whereby our ability to repair or replacement the current audio equipment is no longer an option. With effective technological equipment often having a shorten life cycle, some of our current equipment is well over twenty-five years old.

The latest audio visual technology and systems are much easier to use, offer more connection options, improve collaboration and increase productivity. In short, a good AV system should be fully integrated into the room. A boardroom with an integrated AV system solution will work seamlessly for internal staff, Board of Trustees, guests and external stakeholders alike.

As part of this process, at the February 25, 2020 Board meeting, the Board of Trustees approved the motion below to include the pricing of live streaming capabilities for all public meetings at Niagara Catholic.

"THAT be it resolved the Board of Trustees give direction to the Secretary of the Board and Director of Education to provide a detailed plan for the purpose of increasing transparency through providing live streaming capabilities for all public meetings at Niagara Catholic District School Board. The Secretary is to report back to the Board of Trustees no later than April 28, 2020 with the costs associated with supply/installation/storage and hosting the live streaming service for the Board's consideration."

The ability to effectively achieve live streaming capabilities for our public audience must entail a comprehensive investment in a new software platform and improvements to our current audio and visual systems at the same time. Implementing only live streaming for our public would result in a suboptimal solution with our current audio and visual system.

The funding for this project that improves our audio visual system and any renovations required will be funding through proceeds of disposition (POD) – Admin. These funds are earmarked by the Ministry of Education solely for the use of capital projects for improvements of our administrative buildings.

In response to the above motion, the estimated cost associated with live streaming is approximately \$5,000 and the complete upgrade of our AV system is estimated at approximately \$80,000 - \$100,000.

BACKGROUND INFORMATION

Closure of Schools

The Provincial announcement of school closures due to the CoVid19 pandemic crisis has been unprecedented and an adjustment for Niagara Catholic.

Regulation Amendment for Deferral of Education Property Taxes for 2020

Further to the announcement made by the Minister of Finance in *Ontario's Action Plan: Responding to Covid-19 (March 2020 Economic and Fiscal Update)* to defer the quarterly (June 30, 2020) remittance of education property tax to school boards by 90 days, a new regulation under the *Education Act* titled "Extension of Instalment Due Dates" has been made to extend the due dates for the upcoming two education property tax installments:

- The June 30, 2020 installment is now due on or before September 30, 2020;
- The September 30, 2020 installment is now due on or before December 31, 2020;

To mitigate the financial impact of this deferral on school boards, the province will adjust its cash flow schedule to school boards to offset this deferral. The ministry will rebalance the School Board Operating Grant (SBOG) payments by increasing the SBOG payments in June 2020 and reducing the SBOG payments starting January 2021 until the advance payment is fully recovered.

The additional cash payments resulting from this schedule adjustment will be flowed to boards as a separate payment in June 2020. The additional amount will be equal to about 25% of the annual education property tax amount as forecasted by the school board in 2019-20 Revised Estimates.

Provided below is a summary of potential savings and costs associated with this closure period.

Savings:

The announcement and direction by the Ministry of Education to continue payments for average occasional staff replacement costs until April 4, 2020 was processed and completed. The savings

attributed to replacement costs will begin post April 4, 2020 and continue until through the 2019-2020 school year. With replacement costs at Niagara Catholic attributed to approximately \$40,000 per instructional day. The anticipated savings will be used to support distance learning and several projects to support the technological infrastructure to improve the learning environment for staff and students.

Attendance comparison between school years:

Some key initiative and projects for this fiscal year will continue and are as follows:

- 1) Replacement and refresh of approximately 208 2020 latest generation iMac Desktop computers for each secondary school.
- 2) Refresh and additional wireless access points (WAPs) for all our elementary schools
- 3) Additional endpoint devices for kindergarten and primary division
- 4) Expansion of virtual desktop technology for all staff

Forecasted utility costs are expected to decline as well. With school closures and little use of our facilities we expected a savings in water, electricity and gas.

The transportation consortium is continuing to pay bus drives during this closure. However, a savings of approximately 12% of our expenditures are expected for fuel charges.

We have no direction from the Ministry of Education as to our direction with respect to any savings accumulated during this closure period.

New Costs:

Costs continue to increase associated with our current capacity to provide home technology and software licensing for staff and students. In addition, expansion of cloud storage for increased demand for virtual desktop infrastructure for essential staff.

Investment in endpoint devices for students that need support and deployment of Niagara Catholic devices to families to continue the distance learning for the month of April.

We are tracking all costs associated with this pandemic for the Ministry of Education.

May 26, 2020

The May 26 Board Meeting was held electronically, due to the COVID-19 school closures. All Committee of the Whole and Board Meetings will take place electronically until further notice. As they are public meetings, the public is provided with public access numbers to listen into meetings by teleconference.

Catholic Elementary School in Thorold to be Renamed

Niagara Catholic continues to await approval from the Ministry of Education for a \$5million addition to Monsignor Clancy Catholic Elementary School. The addition of 104 pupil places and 49 child care spaces will allow for the consolidation of St. Charles and Monsignor Clancy Catholic Elementary Schools.

However, Niagara Catholic continues to move forward with plans to consolidate the school, and trustees have approved a new name for the consolidated school. Once built, the consolidated school will be renamed *Our Lady of the Holy Rosary Catholic Elementary School,* matching the name of the Catholic parish in the community. The new chapel at the school will be named the St. Charles Chapel, and the library information centre will be named the Monsignor Clancy Library Information Centre.

The proposed name was selected in accordance with the Board's Naming or Renaming of a Board Facility policy.

Occupancy is currently planned for Fall, 2021.

2020-2021 System Priorities Approved

During the May 26 Board Meeting, trustees approved the 2020-2021 System Priorities.

This year's recommendations focus on enhancing safe and accepting schools, student engagement and student success, enhanced communication within the home-schoolchurch triad, ensuring our schools have access to technology at school, facilitating health, wellness and safety programs for staff, and maintaining sound fiscal management. The complete report is available in section A 6.1.4 of the May 26 Board Meeting Agenda.
