#### STATEMENT OF GOVERNANCE POLICY

Policy No 100.11

Adopted Date: September 28, 2010

Latest Reviewed/Revised Date: April 25, 2017

In keeping with the Mission, Vision and Values of the Niagara Catholic District School Board, Niagara Catholic is committed to - recognizing the importance and value of providing - honoraria for elected Trustees of the Board - as set out in Ontario Regulation 357/06, "Honoraria for Board Members".

In the years 2018, 2019 and 2020, the year of a member's term of office begins on December 1 and ends on the following November 30.

In 2021, the year of a member's term of office begins on December 1 and ends on the following November 14. Beginning in 2022, a year of a member's term of office begins on November 15 and ends on the following November 14.

Ontario Regulation 357/06 sets out the method for calculating the limits on honoraria paid to elected Trustees under section 191 of the Education Act. The regulation states that the honorarium shall consist of the following four (4) components:

- 1. The base amount for the year
- 2. The enrolment amount for the year
- 3. The attendance amount for the year
- 4. The distance amount for the year

The honorarium for elected Trustees of the Board will be calculated in accordance with the provisions of Ontario Regulation 357/06 and – will be adjusted each year to take into consideration the changes in enrolment from the previous year. Separate honoraria will be calculated for the Chair of the Board, the Vice Chair of the Board and for the Other Elected Trustees in accordance with the provisions of Ontario Regulation 357/06 and, will be adjusted each year to take into consideration the changes in enrolment from the previous year.

The honorarium for elected Trustees of the Board, will be for each year of the term of office from November 15, to the following November 14, annually.

In compliance with the *Education Act* Regulation 357/06, at the annual December Board Meeting, a Trustee Honorarium report and recommendation for the annual honorarium for all elected Trustees will be presented and then all amounts shall be posted.

In keeping with the Mission, Vision, and Values of the Niagara Catholic District School Board, the Board recognizes that the support of students with prevalent medical conditions is complex requiring a whole-school approach to promote student health and safety and to foster and maintain healthy and safe environments in which students can learn. A safe, accepting, and healthy environment empowers students to work toward the self-management of their medical condition(s) according to their Plan of Care.

Supporting Children and Students with Prevalent Medical Conditions Policy articulates the role and responsibilities of parents, guardians, medical professionals, and school staff in supporting students. It also articulates the roles and responsibilities of the students themselves. The policy provides a framework for the development of strategies that reduce the risk to students living with a prevalent medical condition and to ensure school staff and others in contact with these students are prepared to handle an emergency situation.

The Director of Education will issue <u>Administrative Operational Procedures</u> for the implementation of the policy.

In keeping with the Mission, Vision and Values of the Niagara Catholic District School Board, and Board By-Laws, this policy preserves the governing function of the Board to establish and cyclically review Board Governance Policies in order to fulfill its duties and responsibilities.

The Director of Education, as Chief Executive Officer, is accountable to the Board for the implementation of Board Governance Policies. Board Governance Policies support the learning, achievement and wellbeing of all students and staff, are congruent with and supportive of the *Education Act* and Regulations, all applicable laws and statutes, and the Multi-Year Strategic Plan.

All Board Governance Policies shall be reviewed on a cyclical basis at least every five (5) years in order to meet the current needs of the system, to comply with current legislation, and to provide an opportunity for all stakeholders within the Niagara Catholic education community to provide valuable feedback.

From time to time, specific Board Governance Policies may be reviewed earlier than the five-year cycle to ensure alignment with changes in law, or regulations or at the request of the Board. The development of a new Board Policy will be at the direction of the Board, or as required by law or regulations by the Director of Education.

The Director of Education will issue Administrative Operational Procedures to operationalize this policy.

#### *i)* Literacy Program Update

#### a) Empower

The Empower Reading program is running strong in Niagara Catholic. Empower teaching staff are delivering lessons with students daily and the feedback has been very positive. We are extremely delighted to see our students making literacy gains, no matter how significant. Preparation for training session #3 is currently being planned for teachers. Depending on the lesson that teachers are on, some staff will receive training in December. The rest of our teachers will receive their 3<sup>rd</sup> training session in January.

#### b) Lexia

 The majority of Principals, Vice-Principals, Educational Resource Teachers and the CEC staff participated in the Lexia Professional Learning Sessions throughout October and November. Our IT department has recently completed the technical set-up for Lexia and most students have been identified to receive a license. Students will begin the use of this program with support from their teacher and the Educational Resource Teacher.

#### *ii) Gifted Module*

• Our Program Resource Teachers will be offering our students identified as gifted to participate in a module on **December 15th** and **December 16th**. Students will have

an opportunity to explore various expressions of identity through poetry, song, quotes and/or artistic representations. Through these open-ended activities, students will create representations of their identity to share with peers. Overall, students will gain a deeper understanding of "self-identity" and how their sense of self influences their interaction with their Catholic faith, the Holy Trinity and the world around them.

#### iii) Student Support Staff

 Student Support staff along with our regional partners are ready to host a "Transition to School" Parent Information Session. These sessions are scheduled for <u>December</u> <u>8th, December 9th and January 12th</u>. This session allows parents the opportunity to learn more about Niagara Catholic's Kindergarten classrooms along with the transition to school process.

#### iv) School Meetings

Superintendent Forsyth-Sells asked Jeremy if he wished to stand for the position of Co-Chair of the Niagara Catholic Parent Involvement Committee. Jeremy Harb thanked Chris for the nomination but declined the nomination.

**THAT** Fr. Paul MacNeil be nominated for the position of Co-Chair of the Niagara Catholic Parent Involvement Committee to hold office for a two-year term.

Superintendent Forsyth-Sells stated that as per the *Education Act*, the Niagara Catholic Parent Involvement Committee Policy and Administrative Operational Procedures and NCPIC By-Laws, only parent members with a two-year term are eligible to hold office of the Chair and/or Co-Chair of the Niagara Catholic Parent Involvement Committee. Therefore, Fr. Paul MacNeil was not eligible.

Alexandria Attree was in support of the self-nomination.

Chris Kouroushis also self-nominated to continue as the Co-Chair for a term of one year.

Superintendent Forsyth-Sells invited Director of Education Cipriano to speak to this process. Director Cipriano thanked the parent members for their ongoing support and respecting the position of Chair/Co-Chair. He also stated that the NCPIC By-Laws act as a guide to support the operations of the Niagara Catholic Parent Involvement Committee. However, when the committee, in itself as a whole sees value in steering from the words of the by-laws to benefit the consensus was to elect two Co-Chairs, it would be in alignment with the two parent members who offered to continue for a term of one year, but it would have to be put to a vote.

#### **B. PRESENTATION**

1. Mental Health and Well-Being-Andrea Bozza, Mental Health Lead

Superintendent Forsyth-Sells stated that the mental health and well-being of all Niagara Catholic students is a priority. We are grateful to the Board of Trustees, our administrators, and staff for their support of mental health programs, services and supports in Niagara Catholic schools.

Andrea Bozza presented a PowerPoint presentation on the Mental Health and Well-Being Strategy 2021-2024 highlighting the priorities and goals of the strategy:

- 1. COVID-19 Recovery: Creating safe and accepting environments to return to, and to address the anxiety, isolation, potential trauma and impact of COVID-19
- 2. Equity, Inclusivity and Diversity: Anti-Black racism, anti-Indigenous racism, antidiscrimination, 2SLGBTQ+ supporting specific populations in our community who may require more or unique mental health and well-being support and services
- 3. The Link Between Our Faith and Mental Health: Being intentional in our messaging to staff and students, that our faith and mental well-being are inter-connected
- 4. Social-Emotional Learning: Embedding SEL into our curriculum and learning
- 5. Pathways to Care: Ensuring students receive timely and responsive, evidence-based prevention and early intervention services at school and in community

Andrea also shared information on:

- the mental health referral process to support students i.e. anxiety, suicidal thoughts, self-harming
- the Niagara Catholic Compassionate Care Guide to support students and staff when there is a death in the school community i.e. student, parent or staff member
- the Mental Health and Well-Being workshops that were provided to all staff in September to support staff and student mental health and well-being
- the Mental Health resources that are available on the website <u>School Mental Health Ontario</u> (SMHO)

- Community partners to support students i.e. abuse, alcohol, drugs, addictions
- Pathstone Wellness Walls displayed in all Niagara Catholic schools to support students
- Ontario's focus this year on anti-sex trafficking; all school boards across Ontario are to create a policy and protocols to be in place by January 2022. This is an area of concern in Niagara and the Mental Health Team will work collaboratively with Senior Administration in the development and implementation of this policy.

A question and answer period followed the presentation. The PowerPoint presentation will be sent to all members for information.

A request to add a parent representative to the Niagara Catholic Mental Health Leadership Team was made. The request will be shared with the team for consideration.

#### C. SUBCOMMITTEE REPORTS

  - Members were asked to email Josie Rocca with their intent to join the Faith Formation Subcommittee.
- 2. Goals/Parent Engagement Events

Co-Chair Vernelli reported that no policies were currently being vetted.

#### E. CO-CHAIRS' REPORT

Ministry of Education's Conversation with PIC Chairs and School Board Leads held on October 26, 2021.

Co-Chair, Vernelli reported that in preparation for her participation on the Ministry of Education's Conversation with PIC Chairs and School Board Leads, NCPIC parent members were asked to provided feedback on the Ministry question, "How are parents and families feeling about the new school year? This included what parents are confident about, and what concerns parents may have?" Co-Chair, Vernelli thanked the parent members for their responses and shared them during the meeting. Discussions also occurred about defining the roles of PIC members.

Co-Chair Vernelli reported that during the breakout sessions, there were discussions on defining the roles of the PIC members. PICs also shared best practices for parent engagement such as:

- Virtual Fun Fairs
- Hosting Guest Speakers
- Scavenger Hunts
- Coffee Chats for Catholic School Councils hosted by PICs
- Outdoor Parent Engagement Events-High Schools
- Paint Nights

The Ministry will send a summary report of the session that will be shared with all NCPIC members.

A question and answer period followed including clarification on volunteers and spectators in the schools at the elementary and secondary levels.

A request was made for contact information of Catholic School Council Chairs/Co-Chairs to be shared with NCPIC members. Superintendent Forsyth-Sells reported that this is a privacy issue and that we would have to request consent from all Catholic School Council Chairs/Co-Chairs. Superintendent Forsyth-Sells will follow up on this request.

Director Cipriano added that when you collect information from a privacy perspective, one of the requirements is that you must inform the individual that you are collection information from with the purpose of the collection of information, so if we have not informed our CSC Chairs/Co-Chairs that one of the purposes was to share their contact information with the NCPIC we would not be able to share their information. However, we may going forward make a secondary request but it will be on approval on a individual level basis to share contact information.

#### F. REPORT FROM THE DIRECTOR'S DESIGNATE SUPERINTENDENT OF EDUCATION

- Review of the Niagara Catholic Parent Involvement Committee By-Laws Superintendent Forsyth-Sells asked for feedback or questions on the By-Laws of the Niagara Catholic Parent Involvement Committee. Diana was acclaimed as the Niagara Catholic OAPCE Regional Director by consensus.

- The sea container to support Fr. Daniel's after school program arrived in Nunavut just after Thanksgiving.
- Various elementary and secondary schools participated in Thanksgiving Food Drives to support St. Vincent de Paul food banks.
- St. Vincent de Paul is getting ready to prepare Christmas Hampers and are looking for volunteers.
- St. Vincent de Paul conferences are starting to reach out for client's participation following COVID protocols.

#### I. BISHOP/DIOCESAN REPORT-Fr. Paul MacNeil

Fr. Paul MacNeil reported:

Synod on Synodality:

• The theme of the next universal synod of Bishops is "Synodality: "The Church of God is convoked in Synod. With this convocation, Pope Francis invites the whole Church to question itself on synodality: a decisive theme for the life and mission of the Church. This will be a two-year journey (2021-2023) of reflection and sharing of the whole Church, with a special invitation to parishes and dioceses to become involved in this process through small group sharing and reflection. More information will be available through the parish." The pastoral letter from the Bishop was sent to all members for information.

Anniversary of the Diocese:

Tuesday, November 9, the feast in honour of the Dedication of St. John Lateran in Rome, marks the 63<sup>rd</sup> Anniversary of the foundation of the Diocese of St. Catharines. This feast illustrates the unity of each diocese with the Universal Church, the See of Rome, and the Holy Father. We try to live that unity within our diocese through the inspiration of the Holy Spirit. This date also marks the 11<sup>th</sup> Anniversary of the installation of Bishop Bergie as Bishop of the Diocese of St. Catharines.

Announcement:

• Bishop Bergie is pleased to announce that the Holy Father has accepted the invitation of the Bishops of Canada to visit the Church in Canada on the context of a pilgrimage of healing and reconciliation with our Indigenous Peoples.

#### J. STUDENT SENATE REPORT-Allan Buri

Allan Buri reported that:

- The elementary Lead Out Loud Summit will be held virtually on November 25, 2021, featuring a keynote speaker, with a theme of "Compassion, Equity and Inclusion". Senators will lead breakout sessions with their respective families of schools' to promote discussion how these values can be translated into initiatives at their home schools.
- Student Senate will be holding another virtual Mental Health Summit in February 2022. It will involve educational materials, helpful resources, and trivia. Community service hours will be awarded to students who participate. The event was an immense success last year and the Senate hopes to replicate this reception.
- Student Senate is also hoping to boost its social media presence on Instagram this year.
- Open discussions have also revealed that secondary students are feeling increasingly comfortable with the current school model, and thoroughly enjoy the return of extracurriculars and multiple classes as well as the abandonment of cohorts.

#### K. STAFF REPORTS-Joe Tornabuono and Kevin Timmins

Elementary Principal, Tornabuono and Secondary Vice-Principal, Kevin Timmins provided elementary and secondary school updates for information. A question and answer period followed.

#### L. TRUSTEE REPORTS-Leanne Prince

Trustee Prince reported that at the May 2021 Board Meeting, a motion was made by trustees requesting that the Director be authorized to explore a partnership with an appropriate organization(s) to secure access to quality menstrual products and education materials at no cost or minimal cost to the Board, and that a report be provided to the Board no later than September 21, 2021 with a timeline of implementation in all 8 secondary schools, the Pope Francis Centre and Adult Education Centres, followed by all elementary schools.

As a result of the presentation at the Board Meeting of September 21, 2021, the trustees unanimously voted in-favour of implementing the Period Poverty project in Niagara Catholic. On October 8, Stephen Lecce, Minister of Education, announced that the Ontario Government will distribute six million free menstrual products per year to school boards under a new and innovative partnership with Shoppers Drug Mart designed to improve access to menstrual products. Schools will be able to distribute the products to students by late fall this 2021-22 school year.

#### M. NEW BUSINESS/AGENDA ITEMS-DISCUSSION FOR FUTURE MEETINGS

Superintendent Forsyth-Sells reported that two presentations have been arranged for the upcoming NCPIC meetings:

- January 13, 2022-Student Support Services will present on special education services
- March 3, 2022-The "unlearn" organization will present about bias, stereotypes, prejudice and discrimination, in order to support safe, caring and inclusive learning environments.

Superintendent Forsyth-Sells welcomed members to make a recommendation for future presentations.

• Jeremy Harb recommended a PRO Life guest speaker.

Superintendent Forsyth-Sells will consult with Krista Wood, Board Chaplaincy Leader on booking a PRO Life speaker for the NCPIC meeting of May 5, 2022.
