REPORT TO THE BOARD FEBRUARY 22, 2022

NEW LINCOLN ELEMENTARY SCHOOL

BACKGROUND INFORMATION

The Niagara Catholic District School Board completed the purchase of a 2.24-hectare (5.53 acre) vacant property on Greenlane Road in Lincoln on September 24, 2021 accessing funding from Education Development Charges (EDC). Additional site preparation costs funded from EDC may include site servicing, remediation as required and additional studies required by the municipality.

Board staff applied for funding for a new school through the 2021-2022 Capital Priorities Grant (CPG) program and on November 23, 2021, the Ministry of Education approved funding of \$10,108,084 for a 421-pupil place school. According to the CPG, the new school shall be completed no later than 2024-2025.

The Minister of Education, Hon. Stephen Lecce announced the new Lincoln school funding at a public announcement with other Ministry and local dignitaries, Board trustees and staff on December 15, 2021 at St. Mark Catholic Elementary School and at the new Lincoln school site.

The Town of Grimsby is projecting approximately 2,790 new residential units over next 15 years, mostly townhomes and apartments; the Town of Lincoln is projecting 2,100 new residential units over next 15 years, 25% expected to be low-density single-family homes. Enrolment projections indicate that the Board could expect about 300 new elementary students from Grimsby and Lincoln developments. Four of the five schools in the Lincoln/Grimsby area have reached or are over capacity and expected to experience increased enrolment throughout the next several years; St. Mark Catholic ES, St. John Catholic ES, Our Lady of Fatima Catholic ES and St. Joseph Catholic ES.

The new elementary school will reduce the pressures and provide a local school presence. In order to determine the boundary of the new Lincoln school, the Director of Education, according to the Attendance Area Policy, will provide a recommendation to the Board to initiate an Ad-hoc Attendance Area Review Committee. The timing of this review can run in parallel with the design and construction process.

In order to meet the timelines for construction completion of 2024-2025 and comply with the Ministry of Education Capital Construction Approval Process, facilities staff will submit a facility space template for approval. Upon Ministry of Education approval, an architect can be engaged to begin the design process. Additional benchmarks include Ministry approval of the preliminary cost estimate and approval to proceed with tender for construction.
