RELOCATION OF THE NIAGARA CATHOLIC LAUNCH CENTRE

BACKGROUND INFORMATION

To support student learning and innovation, the Niagara Catholic Launch Centre located at the Seaway Mall, Welland, was officially opened in the fall of 2017 with an official ribbon cutting ceremony attended by former Premier Kathleen Wynne on October 17, 2017.

The concept of the Launch Centre is to provide authentic innovative learning opportunities to all students in all pathways including University, College, Apprenticeship, World of Work and Community Living. These opportunities are provided in partnership with business, industry, and local agencies. The Launch Centre also works closely with local Economic Development Offices as well as municipal and regional governments and agencies.

The Launch Centre currently hosts Aviation, Construction, Manufacturing, Transportation, Robotics, and Dual Credit Courses with Niagara College in Math and Blueprint Reading as well as Grade 9 Math classes combined with technology and umbrellas our live hair salon located within the Seaway Mall.

In the summer of 2020, the Seaway Mall in partnership with Toth Group embarked on a journey in redeveloping portions of the Seaway Mall to residential development. This proposal included the demolition of the former Target Store which included the location of the Launch Centre. This project was recently approved through Welland City Council. As a result, with the support of the Seaway Mall and our community partners, the Niagara Catholic Launch Centre is currently in the process of relocating behind the Winners Store in the Seaway Mall. This move although cumbersome, is an amazing learning experience for our students and has created further opportunities in expanding our partnerships.

FLAG PROTOCOL

BACKGROUND INFORMATION

At the February 2022 regular meeting of the Board. Discussion took place with respect to issues of governance and operational decisions of the board; in particular to requests received from organizations or individuals outside of the Niagara Catholic District School Board to raise flags at the Catholic Education Centre or any other building or school of the Board. After discussion, it was determined by consensus of the Board that these types of decisions rested solely with the Director of Education and senior staff as operational matters. It was requested by the Board that the current Flag Protocol, first adopted in 2015 be updated to reflect requests from outside agencies and responses to such requests.

The Niagara Catholic District School Board Flag Protocol is attached as Appendix A as information. The Protocol is housed publicly on the Niagara Catholic District School Board website.

Niagara Catholic Flag Protocol

Adopted January 2015

Revised March 2022

Reference: [Rules for Flying the National Flag of Canada](#)

The following protocol is to be followed with respect to flags flying at Niagara Catholic schools and sites:

1. All flags are removed daily at sunset from exterior flag poles, stored respectfully inside the building and returned to full mast position at sunrise the following school day;
2. Flags are flown at half-mast position in accordance with the durations prescribed in the Government's [Rules for Half-masting the National Flag of Canada](#). This includes the following occasions:
 - The death of the Sovereign, Prime Minister or Governor General of Canada
 - The death of the spouse of the Sovereign, the heir to the throne or the heir to the heir of the throne
 - The death of a former Governor General
 - The death of a former Prime Minister
 - The death of a Chief Justice of Canada and members of the Canadian Ministry
 - The death of a Lieutenant Governor
 - The death of a member of the Privy Council or a Canadian Senator
 - The death of a member of the House of Commons
 - The death of a High Commissioner or Ambassador to Canada (while in Canada)
 - When half-masting is initiated by a province or territory

On "special" days recognized by the federal government, including:

- Day of Mourning for Persons Killed or Injured in the Workplace (April 28)
- National Day of Remembrance for Victims of Terrorism (June 23)
- Police and Peace Officers' National Memorial Day (observed on the last Sunday in September)
- National Day for Truth and Reconciliation (September 30)
- Remembrance Day (November 11)
- National Day of Remembrance and Action for Violence Against Women (December 6)

Flags may also be flown at half mast at the discretion of the Director of Education in response to:

- The death of a current student, staff member, or trustee
- The death of an individual or any other individual with a close connection to the Board (e.g. the bishop, a retired bishop or a parish priest or a retired Director of Chair, with the prior approval of that individual's next of kin),
- A community tragedy

1. At schools with one flag pole, the flags are positioned, in accordance with the [Rules for Flying the National Flag of Canada](#), with the Canadian flag placed in the highest position on the flag pole.
2. At schools with two flag poles, the flags are positioned, in accordance with the [Rules for Flying the National Flag of Canada](#), with the Canadian flag to the left, from the point of view of the observer facing the two flag poles;
3. At schools with three flag poles, the flags are positioned, in accordance with the [Rules for Flying the National Flag of Canada](#), with the flag of Canada in the centre, the provincial flag to the left, and the board flag to the right, from the point of view of the observer facing the three flag poles;
4. The three interior presentation flag sets (federal, provincial, and board flags) are positioned in a prominent location in the main entrance of each Niagara Catholic site in accordance with the [Rules for Flying the National Flag of Canada](#);
5. When a flag becomes tattered and is no longer in a suitable condition for use, it is to be sent to Facilities Services to be destroyed in a dignified way and a new flag is to be ordered, in accordance with the [Rules for Flying the National Flag of Canada](#).
6. Any request to fly a flag other than the Canadian , Ontario or Niagara Catholic flag must be made in writing (email is acceptable) to the Director of Education, including the type of flag, the reason(s) for the request, and the duration of the request. Requests will be granted at the discretion of the Director.

NIAGARA CATHOLIC 2022 RECRUITMENT CAMPAIGN

BACKGROUND INFORMATION

Every year, the Communications Department undertakes a marketing campaign to recruit students to Niagara Catholic elementary and secondary schools. This is beyond what we spend each year to ensure a strong presence online through Google Analytics.

This year, Niagara Catholic's campaign ran from January 14 through March 15 (part 1) and included the following:

- Facebook, Instagram, and Snapchat advertising for secondary schools (January 14-February 3) – Schools provided updated videos
- Facebook and Instagram for elementary schools (January 14-February 25) – Updated 2018 video due to Omicron
- Sponsored content (article run through the National Post, February 16-March 15 (Appendix A))

We have two more campaigns that will run in the late spring into the summer to promote registration:

- A video campaign focused on myths and misconceptions of Catholic education
- a photo campaign that will showcase students, staff, and other stakeholders as Faces of God

This year, we noted close to 1,200 pre-registration emails received between November 10 and March 15 (these are received when individuals do a preliminary registration but have not completed the process). This includes students from all grades. Of those, more than 900 were received during the two-month campaign.

As of March 11, we noted close to 900 elementary registrations; the majority of which are registered as Year 1 students for next year in Maplewood.

It is interesting to note that we continue to receive pre-registrations for the 2021-2022 school year. During that same period (January 14 to March 15) we received close to 300 pre-registrations for this year. Some of these, particularly for the Year 1 and 2 students, could be entered in error for this year instead of next, but many are for grades outside of kindergarten.

A brief Powerpoint presentation will showcase the 2022 campaign.
