FOCUS ON THE SCIENCE OF READING: NIAGARA CATHOLIC'S APPROACH TO READING ASSESSMENT AND INSTRUCTION

BACKGROUND INFORMATION

The Ontario Human Rights Commission (OHRC) has published a public report in response to the two yearlong *Right to Read Inquiry* that focused on students with reading disabilities in Ontario's public education system. The report was prepared in response to the number of children in classrooms across Ontario who are not learning to read. According to the Education Quality and Accountability Office (EQAO) results in 2019, more than one-quarter of Grade 3 students, 53% of Grade 3 students with special education needs and 32% of multilingual learners did not meet the provincial standard for reading.

Students who cannot read will struggle in all aspects of school and are more vulnerable to mental health needs, behavioural issues, bullying and not graduating with a high school diploma. Life-long consequences can include under-employment, homelessness, involvement with the criminal justice system and even suicide. The Chief Commissioner of the OHRC report, Renu Mandane states, "Learning to read... is not a privilege. It is a basic and essential right. Learning to read is a human right."

As part of its inquiry, the OHRC listened to parents, students and educators across the province. The OHRC assessed a number of school boards with respect to the use of scientific evidence-based approaches to meet students' right to read. The OHRC assessed the school boards against five benchmarks that are deemed part of an effective systematic approach to teaching all students to read:

- Universal Design for Learning (UDL)/Differentiated Instruction (DI)
- Mandatory Early Screening
- Reading Intervention Programs
- Effective Accommodations
- Psycho-Educational Assessments (if required)

The Niagara Catholic District School Board believes that equity and inclusive education policies and practices must support positive and safe learning environments where all students feel engaged and empowered by what they are learning. Students need to feel supported by the educators and staff from whom they are learning and that they are in an environment where they feel welcomed and included.

To this end, the Niagara Catholic District School Board is developing a plan to respond to the *Effective Implementation of Reading Instruction Intervention Programs Ministry Grant* to support the effective implementation of reading intervention programs within a Tiered Approach to Reading. The Science of Reading informs the Niagara Catholic District School Board's approach to tiered interventions. The Program and Innovation Department and Student Support are working in collaboration as part of the Ministry direction.

2021-2024 Multi-Year Reading Plan

In order to foster a learning environment where all learners can become skilled readers, a multi-year reading plan, based upon the *Science of Reading*, will be developed and implemented. By the end of the four-year period, a structured literacy framework will be implemented in Tier 1 with effective supports and interventions for Tier 2 and 3. The goal for students is to ensure the majority of them have mastered the foundational aspects of word level reading and are strategic in their language comprehension by the end of Grade 2. Beyond Grade 2, the goal will to be continue to strengthen students' ability to comprehend language in a variety of contexts and improve student achievement in reading.

In this first year, twelve schools have been chosen to directly receive support by members from Program and Innovation and Student Support, who will work alongside school staff on the implementation of the Heggerty Resource. The selected schools are listed below. These pilot schools have begun engaging in instructional approaches at the Tier 1 Level. Pending the results and outcomes for reading in these pilot schools this year, a roll out plan for reading instruction will continue to be developed and refined for the 2022-2023 school year and beyond.

PERIOD POVERTY UPDATE

BACKGROUND INFORMATION

At the May 25, 2021 meeting of the Board of Trustees, the following motion was adopted.

Whereas, lack of access due to economic factors - often referred to as "period poverty" - impacts girls and women around the world and can be especially damaging at puberty, when school interactions are crucial to a girl's development; and

Whereas, nearly one in seven Canadian girls have either left school early or missed school entirely because they did not have access to the feminine care products they needed to manage their periods; and

Whereas, menstrual hygiene products are not optional and are necessary and essential to women's and girls' health, comfort and participation in work, school and society; and

Whereas, other Ontario school boards, municipal, provincial, and federal governments have already taken steps to provide free menstrual hygiene products to students and staff; and

Whereas, the Board honours student voice and recognizes the many secondary students, notably OSTA-AECO, who have petitioned various Board of Trustees to ask for "free, quality period products in all schools" and further stated, "that this relatively small act would immensely improve the health and well-being of students all over the region who cannot afford the essential products they so desperately need while menstruating."; and

Whereas, this matter also affects most students before they enter secondary school; and

Therefore, be it resolved: That the Director be authorized to explore a partnership with an appropriate organization(s) to secure access to quality menstrual products and education materials at no cost or minimal cost to the Board; (b) That a report be provided to the Board no later than September 21, 2021 with a timeline to implement in all 8 Secondary Schools, Pope Francis Centre and Adult Education Centres initially followed by all Elementary School sites.

This information report is to provide the Trustees with an update of the work completed to date on the provision of menstrual products within our schools including an update of the anticipated costs and plan for implementation of this important initiative.

PROGRESS TO DATE

On October 8, 2021, the Ministry of Education announced the provision of menstrual products to all students across Ontario. Niagara Catholic received 13 stainless steel sanitary napkin dispensers from the Ministry in March of 2022 along with 580 cases of bulk sanitary napkins for distribution to our schools.

Since the last report to the Board in September of 2022, Facilities Services, in conjunction with the Purchasing Department have sourced and procured an additional 57 feminine product dispensers beyond

those received from the Ministry. These dispensers offer two types of product (napkins and tampons) to permit more flexibility for the students of Niagara Catholic. We have also procured ample supply of the feminine products to get the schools started. Once installed, further replenishments of product will be done by the school caretaking team. The breakdown of dispensers being provided to our facilities is as follows:

The cost of each unit is \$229 plus HST with installation by the Niagara Catholic Facilities Services team. Therefore, the total cost of the supply of these 57 units is \$25,572 plus HST.

Supply of the products is as follows:

Napkins \$55/case Tampons \$109/case

Our team has estimated that each school receive 2 cases of each product per dispenser. Therefore, we have ordered 114 cases of sanitary napkins at a cost of \$6,270 plus HST; and 114 cases of tampons at \$12,426 plus HST.

In summary, the total cost of this initiative to the Board is as follows:

Supply/Install of 57 dispensers \$25,572 Supply of 114 cases napkins \$6,270 Supply of 114 cases tampons \$12,426

Total Cost to Board \$44,268 plus HST

IMPLEMENTATION PLAN

Niagara Catholic is currently in possession of the Ministry funded napkin dispensers plus product. Our team have identified 13 of the larger elementary schools that are to receive these units. The reason behind this decision is that the Ministry is providing the product refills for these dispensers and thus will reduce the overall cost of the initiative to the Board. These 13 dispensers are being installed by the Facilities Services team and will be completed by mid-May.

The remainder of the 57 dispensers have been ordered along with the products. We are anticipating delivery prior to the end of the school year and are planning on having them all installed and ready by September 6, 2022.

LETTER FROM CHAIR AND VICE-CHAIR OF SEAC

To the Board of Trustees,

Niagara Catholic SEAC unanimously carried a motion to write a letter to you, the Board of Trustees, seeking your support to ask the Ministry of Education to reexamine the term "disability" in the Education Act. This act governs the use of the term "disability" within all publicly funded schools across the province.

The Niagara Catholic SEAC regularly receives letters from other SEACs in support or disagreement with various educational practices and/or policies. Recently, we received a letter from the Durham District School Board (DDSB) SEAC requesting that the Ministry of Education revisit the use of the term disability and its' definition within the Education Act, which we would also like to voice our support for. Currently, The Education Act presents the term disability from the lens of the medical model which suggests that very specific challenges associated with a particular disability are things to be fixed or are things that are 'wrong' with the student themselves. What this translates to is frequent changes to the legislation (such as with the recent Bill 172 regarding Fetal Alcohol Syndrome Disorder) to meet these stringent disability guidelines, requiring more money and more man-power, and further perpetuating the deficits based view of our students that is systemic in The Education Act's view of disabilities.

This scenario and the definition of the term disability is in contrast to the rights-based or social lens that we, alongside the DDSB, believe should be used, where disability related challenges are characterized as a functional limitation. This means that instead of trying to 'fix' a specific set of disability criteria in our students, we examine how their social and physical environment is providing barriers to accessibility, thus limiting their functioning. In both scenarios, the student will likely present the same difficulties in a school environment, but the trouble in the latter scenario is put onto the environment instead of on the student themselves. Acknowledging these barriers instead of specific difficulties the child may exhibit because of a specific disability would result in less ad hoc legislation changes as many different types of disabilities may present similar functional limitations.

Niagara Catholic SEAC posits that from a humanistic perspective, the medical definition of disability and the "piecemeal" approach to defining support for students with special education needs also fails to acknowledge students whose disability may be invisible, or who may satisfy some but not all of the criteria outlined in the Education Act's definition. Despite best intentions in recognizing various disabilities, it is difficult to adequately support the whole student when we are bound, by law, to 'fix' specific disability criteria instead of focusing on the student's own unique needs in relation to the environment they are placed in.

We also choose to support the DDSB's letter as they so aptly noted that the Education Act is essentially a historical document that was drafted prior to the development of the Human Rights Code and well before the creation of the Accessibility for Ontarians Disability Act (AODA), highlighting the less-inclusive and outdated framework in which the contents is based on (the Ministry of Education has not even conducted a thorough overview since before these two monumental documents). Reviewing the definition of disability in this document to be more

in line with AODA and the Human Rights Code, as well as various organizations such as The World Health Organization (WHO) who view disability from a social lens, could impact the programming outcomes for students in Niagara Catholic and across the province.

The call to action initially put forth by the Honourable David C. Onley and supported by the DDSB, to review the special-education plan and to adopt a more inclusive definition of disability, would mean that the Education Act is more inclusive and ensures that we are supporting all students, but especially students with complex educational needs. The definition we are further recommending the Ministry of Education adopts, which is from AODA, is:

"[A]ny impairment, including a physical, mental, intellectual, cognitive, learning, communication or sensory impairment – or a functional limitation – whether permanent, temporary or episodic in nature, or evident or not, that, in interaction with a barrier, hinders a person's full and equal participation in society."

As representatives from the community supporting those with disabilities, Niagara Catholic SEAC, urges you, the trustees, to support our effort to hold the Ministry of Education accountable. We ask for your support, specifically, to ask the Ministry to conduct a full-scale review and revise the Education Act through an accessibility lens, and to specifically review the definition of and context in which the term disability is used. Since Niagara Catholic is bound to uphold the Education Act, making the necessary changes would allow Niagara Catholic to better support its students and still uphold its duties.
