# **PRESENTATION BACKGROUND**

# ST. PATRICK CATHOLIC ELEMENTARY SCHOOL PLAYSPACE AND THE RECESS PROJECT COLLABORATION

St. Patrick Catholic Elementary School in Niagara Falls collaborated with The Recess Project to create an engaging and climate-friendly playspace for students. This work began as a research collaboration between Dr. Lauren McNamara, Founder and Director of The Recess Project and the Research Department of the Niagara Catholic District School Board over five years ago. This research involves gathering student and staff voice, in schools across the board, about experiences of recess, followed by university student support for recess planning and the implementation of the Changemaker's Guide to promote student leadership and improve a sense of belonging for all students at recess.

From the research, we targeted St. Patrick Catholic Elementary School as the site of a pilot project to design and build a new, natural playspace.

The schoolyard was a relatively barren space until this past fall, when community partners and school board staff worked together to design, build and install natural and upcycled materials to transform the schoolyard at St. Patrick School. The build was supported through cash funding from the BCM (Bertie & Clinton Mutual) Community Grants Program and included partners, like Walker Industries, which provided materials and labour, donations from Canadian Tire Jumpstart Charities and Gauld Nurseries, as well as many engaged volunteers. On November 10, 2021 there was an outdoor event at St. Patrick to give thanks to all those involved in the realization of this innovative project that supports our students and their wellbeing, including architect Grace Wang (hired by Niagara Catholic). The schoolyard now features a healing garden, complete with wood planters, shrubs and seating, a cedar-lined fence with upcycled composite railway ties, a large wooden stage, upcycled giant tires and various seating areas with tree trunk stools and tables topped with wood from electrical spools. Furthermore, chalkboards now adorn the outside brick walls of the Kindergarten playspace and new bright-coloured games have been painted on the blacktop areas of the yard.

The Recess Project and the new playspace has begun to impact the school and broader community in so many positive ways. Students are thoroughly enjoying the space for recess and play, which supports our collective work to provide safe and accepting schools where children feel that they are included and belong. Teachers are leveraging the space for outdoor learning, including curricular and co-curricular activities. Families appreciate the aesthetic addition to the school and neighbourhood, as the yard is visible from the street, and can be seen enjoying the space after the school day is over. There is anticipation that the parishioners of St. Patrick Parish, which shares the schoolyard with the school, using the healing garden for prayer and contemplation.

This collaborative, research-based project has proved that many hands do make light work. There are so many people that made this possible, so many that volunteered their time and shared their expertise to ensure that the children of St. Patrick would have a beautiful, functional and fun schoolyard.

Both the past and present Principals of St. Patrick, Mr. Gus Marchio and Mrs. Irene Ricci, have been instrumental in ensuring the realization of this project, as well as staff from Facilities Services who engaged with community partners to align their plans and work with the appropriate requirements for the additions and changes to the schoolyard grounds. Dr. Lauren McNamara and Research Chair Christine Battagli have been working together for years alongside Dave Thompson and his team at Walker Environmental to see this project to fruition. All of this has been made possible with the support of the Director of Education, Controller of Facilities Services, Clark Euale and Superintendents Lee Ann Forsyth-Sells, Pat Rocca and Gino Pizzoferrato.

If you can witness the children engaging in their new yard, you will understand the positive impact that The Recess Project, with all of our partners, is having on the St. Patrick community. All of the partners are continuing to work together to plan for similar projects at other Niagara Catholic elementary schools beginning as early as Spring 2022.

# **eLEARNING REPORT**

#### **BACKGROUND INFORMATION**

e-Learning is one of the projects the Ministry of Education has implemented to help students succeed in school. In May 2021 new legislation was introduced to make changes to the Ontario Education Act to implement a requirement that secondary students who started Grade 9 in 2020/2021 must earn two of their credits online to graduate.

Niagara Catholic recognizes that learners excel when given tools that support their diverse learning styles. eLearning provides students with more choices to customize their education based on their strengths, needs and interests, while earning Ontario high school credits. eLearning teachers are certified, experienced and committed to student success by providing a quality digital learning experience.

Online courses engage students with content delivered through innovative tools that build digital literacy skills and reflect the world students live in. eLearning provides a convenient alternative to the traditional classroom and expands the scope of course offerings available to students. Students choosing courses for the 2022/2023 school year will have access to an online catalogue with course selections.

The presentation will illustrate the growth in eLearning around the province, outline Niagara Catholic's delivery model for eLearning courses and course options for the 2022/2023 school year.
