2022-2023 PARENTS REACHING OUT (PRO) GRANTS

BACKGROUND INFORMATION

The Ministry of Education continues to support parental involvement in Ontario schools by funding Parents Reaching Out (PRO) Grants. The Parents Reaching Out (PRO) Grants program provides funding to district school boards and school authorities to lead projects with a focus on the identification and removal of barriers that prevent parents and families from participating and engaging fully in their children's learning.

This funding supports projects that are initiated by parents through communication with the Niagara Catholic Parent Involvement Committee and Catholic School Councils. For the 2022-2023 this funding will be transferred from Priorities and Partnerships Funding (PPF) into a new component of the Parent Engagement Allocation within the School Foundation Grant.

With this change, the Parent Engagement Allocation has three components – PIC (\$8,300), School Councils (\$29,000), and PRO (\$30,500) – each with its own funding calculation. School boards are expected to comply with Ontario Regulation 612/00: *School Councils and Parent Involvement Committees*.

This new PRO component, funded through a combined amount of \$1,500 per school board and \$500 per school committee, supports school boards to work with their Parent Involvement Committees (PICs) in order to lead initiatives that address local parent needs and/or remove barriers that prevent parents from participating and engaging fully in their children's learning and educational progress.

The Niagara Catholic Parent Involvement Committee welcomes new parent and community representatives yearly. For the 2021-2022 school year, we welcomed new parent members: Alexandria Attree, Olivia O'Reilly-Romanoff, Luciano Robazza, Lindsay Spanik, and Diana Zlomislic as well as Kevin Timmins, Secondary Vice-Principal Representative and Jane Farah-Smith-Elementary Teacher Representative.

Chris Kouroushis and Carrie Vernelli were re-elected as the Co-Chairs for the 2021-2022 school year and Diana Zlomislic was appointed as the Niagara Catholic OAPCE Regional Director for a two year term. In January 2022, Trustee Dan Moody replaced Trustee Dino Sicoli as the Trustee representative on the committee. Special thanks to Trustee Sicoli for his many years of commitment, dedication and support of the Niagara Catholic Parent Involvement Committee.

Following the guidelines from the Ministry of Education and Niagara Public Health parents/guardians were once again provided with two options to support their children's learning: in-person learning or remote learning through the Niagara Catholic Virtual School for the 2021-2022 school year. After the March Break, it was good to get back to a somewhat normal year. Students were happy to participate in co-curricular activities, Mass celebrations, end of year trips, graduations and fun fairs.

PRO Grant funding from the Ministry of Education allowed us to provide three virtual learning Math session for parents/guardians with Dr. Marian Small on March 29, May 12 and June 1, as well as a Family Games Night on April 27. Parents/Guardian who participated in the virtual webinars with Dr. Marian Small received PowerPoint Presentations to continue to support their student learning at home. Prior to the Family Games Night, Math kits were sent to all registered participants that included various grade level games that would be introduced to engage families during the Family Games Night. Over 200 families participated and positive feedback was received including how parents/guardians enjoyed engaging in math games with their children. Special thanks and appreciation to Niagara Catholic staff for their support of the NCPIC PRO Grant initiative.

To support Faith Formation, the NCPIC also hosted a Virtual Parent Synod Listening Session held on April 25, 2022 to engage parents/guardians and hear their voice on how the church can be strengthened and supported. Although a small number parents/guardians participated, the session was informative and some strong voices opened wonderful conversations. The feedback collected during this session will be included as part of the Diocese of St. Catharines Synod responses being forwarded to Pope Francis.
