In response to Partisan, Political and Social Advocacy Activities Policy

Through you, Chair, Mr. Di Lorenzo and Vice Chair, Ms. Burkholder and to you Director of the Board Mr. Cipriano, thank you,

I am honored to be here as a delegate, however I am more honored to kneel at the foot of the cross. Saint Benedict says a Latin phrase *Cum honore et tremore* - means "with honor and trembling".

The school board has representatives and role models within its walls and a flag represents the ideologies promoted within. It's a logical question then to ask...what is the history and philosophy behind the Pride flag flown in front of Niagara Catholic District schools during the month of June?

The original pride flag was designed by Gilbert Baker at the request of Harvey Milk. Look up Gilbert Baker and his past. Gilbert Baker was a member of the drag queen group called the "Sisters of Perpetual Indulgence". What is the "Sisters of Perpetual Indulgence"? His flag made its first debut in 1978 in San Francisco on Gay Freedom Day. Baker himself said "We are a people, a tribe if you will. And flags are about proclaiming power, so it's very appropriate" to have this flag. Forty-five years later, the political power has been maximized to a point that it flies during the month of the Sacred Heart of Jesus. As a parent, I ask the Catholic school board, what have we ended the academic year with? I would hope that it has NOT been a year of endorsing and re-educating my child to a life of perpetual indulgence.

In 2018, the Progress Pride flag was designed by Daniel Quasar who describes himself as a "queer, non-binary celestial object having a human experience." It blended the classic pride flag of old and the trans pride flag designed by Monika Helms in '99. Amber Hikes also designed a trans pride flag in 2017. The underlying theme? "More colors, more pride." Does this focus on the pride flag disrupt the academic year by suddenly shifting eyes off Christ onto a new and better love. Is the concept of love suddenly more accurately described by these flags than by the cross? Is this a new religion? Saint Faustina says in her diaries in the words of Jesus "where there is pride, I am not there." Have we cancelled Jesus?

The Bible was created before the creation of the rainbow flag and Jesus loves everyone and includes everyone. Love, however, comes with responsibility. True freedom is only protected when we make a choice to "live not by lies" especially in front of children. The current state of things in this country is that if I am caught counselling someone to accept their biological gender, there is a risk of jail time. The reality is, that this is no longer a marginalized group but a group that has incredible money, a high level of prestige and power to silence those around into a deafening political correctness. What has happened to the freedom of religion once protected in the Bill of Rights and the Canadian Charter of Rights and Freedoms? I would like to tell the truth in this country without fear of being persecuted by large institutions. The silencing, firing and persecutions that I am witnessing are age-old techniques used before.

Is pride really something we want Catholic schools to celebrate? Does this flag really represent the heart of what Catholic schools are about? I would say no. Pride undermines the Catholic teachings of virtue which includes humility, temperance, chastity and self-control. Tolerance is not a virtue. Humility includes fear of God, self-denial, obedience, perseverance, serenity, self-abasement, prudence, silence, dignity, discretion and reverence. These provide genuine self-esteem in the form of holiness. It's not about self-love but self-abandonment. These are the Rules of Humility that are in the Saint Benedicts Guide to Genuine Self Esteem. Step one is the hardest, overcome pride and admit I'm wrong. Why? Because I fear God. Positive mental health includes holding back on

perpetual indulgences. Decisions about flag flying CAN be changed and I think they should be. This is a distraction from the Catholic student's true focus.

The heart and the cross are symbols that are important to children's health. Currently, if I go into a Children's hospital, I will see the rainbow flag in the main foyer, the booking room, the clinic room, AND in the large room where a multi-disciplined team meet. The rainbow flag isn't only present in June but all year long, 365 days a year. There is no cross. HOW suddenly does the rainbow flag become central to children's health? Let's stop this invasiveness and get the government out. Dignity matters and it is not reduced to some color on a flag. The rainbow flag is not perfect inclusiveness and never will be. Our Canadian national flag already includes everyone.

This ideology divides rather than unites in many ways.

Number 1-By removing parental rights over the child's health care at the age of 13, a team of health professionals who have way more power and status can pressure children into taking hormones, NOT thoroughly tested drugs, and surgical procedures to mutilate and modify their bodies. Understand that our doctors MUST follow orders from their Association and no longer have conscience protection in this country. There is no regard for long-term side effects on these potentially permanent decisions.

Number 2- To use the judicial system to change a child's legal documents with a new plethora of choices to label a person -for a profit.

Number 3-The education system which continuously creates more expensive and privacy invading inventories and teaching techniques to unnecessarily have children question their identity. This is an incredible waste of bureaucratic money and time to promote confusion and self-doubt by the systems at large.

And that is why I have taken time to exert my civil rights to speak out and defend our children from a system that I no longer trust. I thought holiness and servanthood and true love for our neighbors was the core identity of the Catholic student. These need not be redefined by a flag.

Our current government lies waiting to take away the rights of families, teachers, principals and trustees and truly take over the system in a totalitarian way if we don't wake up.

Unless.

Unless people like you and I start to take back our civil rights and freedoms, protect our religion and our children and make the Sacred Heart of Jesus the focus of June which clearly illustrates a broken heart... a broken heart and a love which surpasses all human understanding.

If people within the health, judicial and re-education systems conducted a proper examination of conscience to increase virtue, I think society would change. This partisan, political and social activity on school property breaks families and if left for a long time will last in divisiveness in its impact of social reengineering.

I really pray for good leadership. Please trustees vote in favor of this motion tonight which will prevent our children being taken over by an ideology that is foreign to what Catholic schools are truly about- the cross and the heart. Viva Cristo Rei!

Good evening Trustees, Student Trustees, Director, Senior Administrators, OECTA Colleagues, Niagara Catholic District School Board staff and our NCDSB Community.

My name is Jennifer McArthur and I am the president of the Niagara Elementary Unit of the Ontario English Catholic Teachers' Association.

While I am here in that official capacity, I cannot separate myself from my deep involvement with this board. I am a third generation Catholic teacher in Niagara. As a student, I attended St. Christopher and St. Teresa in St. Catharines from JK to Grade 8. I am a proud graduate of Denis Morris Catholic Secondary School. My own children attended our schools until graduation. Not only do I work in this region but I continue to live here as well. What happens in the board is professionally and personally relevant for my family and me.

I am taking this opportunity – in fact, feel compelled to do so – to address the Partisan, Political, or Social Advocacy Activities Policy that was put forth as a Notice of Motion at the May Board meeting and appears on tonight's agenda.

This policy is garnering much attention due to its restriction to flying the Pride Flag; however I think it important to acknowledge that the board currently has policies and/or procedures in place to address other aspects of the motion. Those include, but are not limited to the Employee Code of Conduct and Ethics Policy, the Municipal, Provincial and Federal Election Policy and the Equity and Inclusive Education Policy. Many board policies also reference the Ontario Human Rights Code, which focusses on ensuring that no individual is discriminated against, either intentionally or unintentionally.

Also, I wish to note that the policy printed in the Notice of Motion in May's board meeting refers to curriculum. To be clear, in Ontario, and in our publicly funded Catholic Education system, the Ministry of Education outlines the curriculum that must be taught and that includes any discussions about sexuality, gender and gender identity.

The mission statement of our board is quote "We are a Christ-centred Catholic faith community that celebrates diversity and fosters spiritual growth, inspiring all to reach their full potential in mind, body and spirit." End quote.

Currently our board is putting those words into action by Flying the Pride Flag and stating on the board website that quote "We believe in creating a culture of equity and inclusiveness in our schools by celebrating the richness and diversity of our students, staff, and our families. This is embodied in our Strategic Plan which speaks to the power of empathy, equity, inclusivity, and belonging. With these guiding principles in mind, and recognizing and respecting that many of our students, staff, and families are part of the LGBTQ2S+ community, Niagara Catholic will once again fly the Progress Pride flag at all schools and sites June 1-30, 2023, in accordance with Niagara Catholic's Flag Flying Protocol." End quote.

Now, the teachers' union and the board do not always find themselves completely aligned; however there are three topics on which we have not wavered in our agreement over the past couple of years. One is the boasting that we do about the teachers, educators and students at Niagara Catholic, the second is our commitment to equity, diversity, accessibility and inclusivity; and the third has been the importance of flying the Pride Flag to convey the respect, dignity and welcomeness imbued within our faith-filled schools.

After two years of seeing the Pride Flag displayed in and in front of our schools and worksites, the policy being contemplated tonight would detrimentally affect students and staff – and their families, their friends and their allies - who see the Pride Flag as an affirmation from the school board that the people in this community are committed to supporting our 2SLGBTQIA+ and equity-deserving communities – right here in our Catholic education system – a place where they should never feel afraid, a place where they should never ponder the value of their life.

Students and staff work best in an environment that is welcoming, respectful and supportive; not in an atmosphere of intolerance, hate, and phobia. Students and staff in our publicly funded Catholic education system deserve to be welcomed, loved, cared for and protected – no matter who they are and who they love.

Recently our OECTA Provincial President stated quote “that displaying the Pride flag outside our schools is a visual representation and indication to students, educators, families - everyone - of our commitment to promoting respect, human rights and a culture in our schools that celebrates diversity and contributes to creating a more inclusive society.” End quote

Acceptance goes beyond tolerance. The symbols of our faith are no longer enough to convey our commitment to a more inclusive society. Unfortunately, people in the 2SLGBTQIA+ community have been subject to hateful remarks and actions where perpetrators have misused our faith as the basis for their positions. As a result, we need to do more to protect students and staff who may afraid to be their authentic selves. We need to make sure that students and staff who identify as 2SLGBTQIA+ know they are better here than not here, that they are not mistreated and stigmatized.

Each and every day teachers strive to create this safe and welcoming environment for all, in keeping with our faith and with the belief that everyone is deserving of God’s love and compassion. Teachers choose acceptance.

On Sunday, I celebrated one of my goddaughter’s First Holy Communion and at mass at my church on the previous Sunday, the congregation celebrated a baby’s baptism. The families were filled with light, joy, hope and overflowing love. I thought to myself, “there is nothing that these families would not do to ensure these children grow up feeling valued and safe.”

I urge you to strike down this motion, to champion the Flying of the Pride Flag, to send the message to all members in our community that you,

the real you, the emerging you, the authentic you, the questioning you is accepted,

that our 2SLGBTQIA+ students and staff are valued and

that their human rights matter.

The visibility of the Pride Flag has a positive impact. I know that as a Catholic teacher, I know that as a leader, I know that as an ally.

Good evening. My name is Charlotte Johnstone, this is my co - trustee Steffen Zylstra. We are here tonight to discuss why flying the pride flag makes such a positive impact on Niagara Catholic's student body.

What is pride? The feeling of satisfaction, being proud of something one has achieved. Accepting who you are. The month of June is named "Pride Month " to celebrate the 2slgbt+ community and crush the shame and stigmas they face everyday. As 2 students who spend every day within our secondary schools, we are here to be the student voice. Stef and I are always told that we are equals at this table. Tonight we feel our power and worth more than ever. It is important to note that when Steffen and I speak, it is not coming from just the two of us, we have a job of representing the thousands of voices within Niagara Catholic, a job we hope to complete tonight.

Pride month is an opportunity to celebrate our members of the 2slgbt+ community and unite our student population allowing students who are members of the community to feel supported, loved and welcome. Diversity brings new views, opportunities and opens doors we did not know existed. We can only see that celebrating the diversity of students within our board will bring positivity and create an inclusive learning environment.

Tonight we would like to share why we believe the Pride Flag is key in embracing the differences that make our community what it is, and we have received help from students within our board. When Steffen and I asked for "a few" testimonials on what the pride flag meant to students within our secondary schools, we were flooded with endless inspiring messages from fearless students all across our board. Students who are members of the 2slgbt+ community, students who are supporters, students who understand that this issue does not involve them personally, but see the value in celebrating everyone.

We are honored to be here tonight joined by our very own Senate members, who I call upon now to share the messages they have collected from the students they represent.

## Students at Saint Francis said:

I believe it is important that we continue flying the pride flag as it represents love, community, peace, and equality. By flying the pride flag it shows that this school board cares about every student within it, and we openly welcome them to express who they are, and how they present themselves. By flying the flag and supporting the LGBTQIA2S+ community we are showing that we care and are trying to create a welcoming, safe space for everyone to thrive no matter how they identify.

The student body of St.Francis is in support of continuing to fly the pride flag.

“To me flying the pride flag at our school shows support of peace & equality. It represents the safe space that our school is, that we support all of our students as an equal community. To fly this flag shows the progress we are continuously making towards a future where no one is left behind. Each color on the pride flag has a different important meaning; life, healing, radiance, nature, serenity, & spirit. The colors also include different kinds of people; men, women, nonbinary, transgender, people of color, people with indigenous background & many more. When you see the students of our school smiling, holding up the flag & looking up in joy as the flag flies, do you see us trying to spread hatred & violence? The ability to spread such a positive message should not be a debated topic.”

### Students at Notre Dame said:

As a person who identifies as part of the 2sLGBTQIA+ community it saddens me to hear that an important symbol of identity, acceptance, diversity and overall love, is being so ignorantly compared to such a horrific event in human history. To me the statement made by Natalia Benoit is not only damaging to the LGBT community but in turn mocks the events of the holocaust by comparing a symbol of unity to such a disgusting display of division. Being a student under the niagara catholic district school board, I not only feel attacked by this hurtful statement but it requires me to question Mrs. Benoit's capacity to be in such an important role. I do not feel it is wrong to want the leaders of my education to be compassionate and accepting of all communities. I hope Mrs. Benoit recognizes her actions as wrong and hurtful and can properly issue an apology to both communities affected by her words.

The pride flag is super important to me as an lgbt student, and seeing it raised at our school meant a great deal. The pride flag represents the fact that all individuals should be proud of who they love and who they are. I think it's super important to raise the pride flags at schools, specifically Catholic schools, to show solidarity with the community and to fight against any homophobes.

### Students at Holy Cross said:

“To me the pride flag is a symbol of who I am. It is a symbol of individuality and love. It is a way to unite people across the world. Whenever I see the pride flag I know I am not alone and that I am supported by many people whether I know them or not”

As a member of the lgbtq+ community I think the pride flag means inclusivity and a safe space for people of any background to come together and not be discriminated against for being themselves. I think it also means showing your support to the community because at the end of the day we're all just regular people.

A student at Saint Michaels submitted the following letter:

Let us be celebrated and cherished, let us be loved and kind, let us be ourselves, let us embrace everyone. Nothing can separate us from the love of God. (Rom 8:38) that includes our sexuality and our gender, we are all one with him so do not let this hate consume you. As well as the fact the progress flag should be the one flying, to commemorate the black trans women that lead our fights to freedom, they are a big part of that history and mustn't be forgotten. All of this is our hope and our salvation just like yours was before with church, please see the error of your ways trying to take something so innocent and turn it into something evil. God didn't fill you with this hate, you chose this hate but we did not choose who we love. So I ask of you, will you do the right thing? Will you make the right choice? Will you let hate consume you or will you choose and fight for love? Fight for all of God's creations. The choice is yours, but don't make it the wrong one.

Thank you for reading my letter, it is essential to me that the community I'm a part of is heard and seen and fought for. Please take my thoughts into consideration and please keep the pride flag up.

Students at Saint Paul said:

I think having the Pride Flag up is important because it is acknowledging all of those in our community. Even though it doesn't affect me personally. It is important to embrace everyone in our school and celebrate who they are.

Having the Pride Flag up creates a safe environment for all LGBTQ students in our schools. To some students, they do not feel safe in their own homes and having that symbol present creates a warm and safe environment for students. Just seeing that flag present for a couple seconds when students are entering the building makes such a huge impact on one's self esteem.

Ayva Solar, Gr. 12 Student at LCHS

The pride flag is a symbol of inclusion. Especially for young kids, it's important that they can see this flag and know that it's okay to feel a certain way. Heterosexual relationships are so widely promoted in both the media and everyday life, many individuals who may identify as part of the 2SLGBTQIA+ could possibly feel as though they are an outcast or that the way they feel is somehow wrong. The pride flag is a way of telling people that their feelings and who they are is nothing to be ashamed of but rather something worth embracing and celebrating.

Ava Venzon, Student Senate member from LCHS

As an educational board, our top priority should be the students. The students should come before everything else, including politics. I've seen with my own eyes what a simple flag can do for even a single student. It's such an easy thing to do, and it does so much good. Politics and bias aside, the pride flag represents acceptance. Showing a kid that they are accepted for who they are will never not be the absolute best thing for the kids that attend our schools every day. There will never be a good enough reason to stop spreading this positivity.

In closing, we want to show how flying the pride flag and supporting 2SLGBT+ students in every way we can is not only in our best interest from a student perspective, but is a need and a must from a Catholic one.

I suspect that the bible will be held up as a shield for intolerant beliefs, but it is not the be-all-end-all for us as a Catholic community, it is the community itself that is core.

Leviticus 19:19 states "You shall not sow your field with two kinds of seed, nor shall you wear a garment of cloth made of two kinds of material."

Now, crop diversity is vital in farming, and if we're sinners for wearing more than one material then we're all going to hell.

No, it is the people with us and the love we share that bring us together. And when I see people close to my heart leaving our schools because they no longer feel welcome, which I have, and it hurts, it strikes me that we have left sorely behind the one value that makes our community worth being a part of: love.

And if anyone listening to me now cannot remove their personal bias and agree that the pride flag and everything it symbolizes is the only way forward in our schools, then I strongly encourage you to re-examine your own beliefs as Catholic rate-payers and as members of this community. And if you stand for any comparison between one of the greatest symbols of love and acceptance, and one of the most hateful and vitriolic flags ever flown, then examine the consequences of your actions before you are left behind by a forthcoming generation of youth who you left when they needed your support.

The golden rule reads: treat others the way you want to be treated; love your neighbor, as yourself. Just as everyone here today is in support of their own community in one way or another, support the 2SLGBT+ students in our Niagara Catholic community, and support the flying of the pride flag. We were democratically elected to speak for all 22 000+ students in our school board, and that is what they have to say.

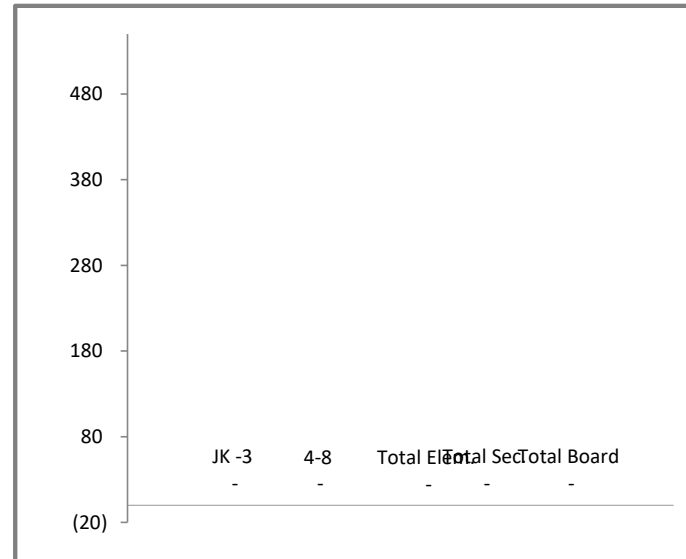

**Changes in Enrolment: Budget v. Forecast**



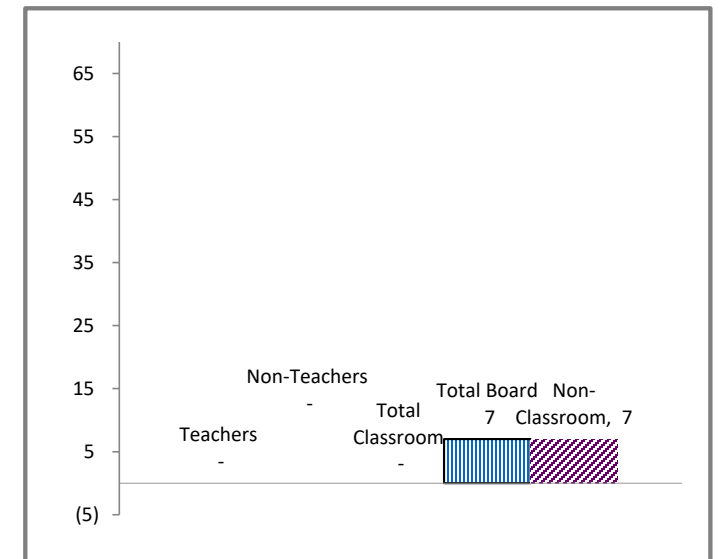

## Partisan, Political, or Social Policy Advocacy Activities

All employees of the Niagara Catholic District School Board occupy positions of public trust and confidence and, as such, are expected to discharge their duties and responsibilities with integrity and professionalism in keeping with their mission of transmitting the morals and teachings of the Catholic Church.

### Purpose

This policy is designed to promote education instead of indoctrination, defined as the endorsement of partisan, political or social policy matters.

Neutrality and balance in classroom instruction are desired to create an optimal learning environment and atmosphere of inclusiveness, where all students are welcome. Because views and beliefs about partisan, political, or social policy matters are often deeply personal, employees should not, during assigned work hours, advocate to students concerning their views or beliefs on these matters. Such advocacy does not contribute to a positive learning climate and may be disruptive, divisive, and distracting. Rather, classroom instruction should relate to approved curriculum. The district's role is to teach students how to think, not what to think, thereby keeping classrooms as places of education, not indoctrination.

### Definitions

For purposes of this policy, advocacy and advocate are defined as the use of speech, conduct, or symbols to support or oppose a particular point of view or belief about partisan, political, or social policy issues or matters.

**Guidelines:**

The Board adopts the following guidelines to clarify which activities are not appropriate during assigned work hours and on all district-owned or leased property, within all school buildings, and at all district-sponsored activities:

Employees shall not advocate to students concerning any partisan, political, or social policy issue nor engage in partisan, political or social policy electioneering or campaigning related to employee representative elections.

Employees shall not display any flag, banner, poster, sign, sticker, pin, button, insignia, paraphernalia, photograph, or other similar material that advocates concerning any partisan, political, or social policy issue.

Employees shall not distribute, circulate, or display circulars, leaflets, petitions, or similar material that advocates concerning any partisan, political, or social policy issue.

Employees shall not collect or solicit funds or volunteers for any partisan, political, or social policy campaign or activity.

Employees shall not direct or encourage students to write, address, or distribute advocacy materials

related to any partisan, political, or social policy issue.

Any district employee who holds elective, appointive, or partisan office is not entitled to time off from his district duties for reasons related to such office, except as such time may qualify under the leave policies of the Board or the pertinent collective bargaining agreement.

This policy specifically exempts the following from the above prohibitions:

- Instruction and study concerning partisan, political, or social policy issues when directly relevant to the curriculum and appropriate to classroom studies given the students' age and class year, ; provided, however, that such instruction or study is not for the purpose of advocating concerning a partisan, political, or social policy issue.

Instruction on the Catholic faith in our curriculum, as long as such teaching reinforces the teachings of the Catholic faith.

- The display of Canadian Flags, the Ontario Flag, any Catholic flag or Vatican Flag; and flags of foreign countries or other Canadian provinces or territories when directly relevant to a course of study in a social studies or foreign language class.

- Wearing small pieces of jewelry, consistent with the professional dress code, that symbolically represent an individual's Catholic faith.

#### Delegation of Responsibility

When implementing and enforcing this policy, district employees, the Superintendent and principals should keep all flags that have not been mentioned as permitted by the board off school property.

Whatever is done in the school or on the board must be consistent with the Catholic faith as expressed in the Catechism.
