## Special Education Advisory Committee (SEAC) Report

### Ministry of Children, Community, and Social Services

- Recommendations of the Ontario Autism Advisory Panel

In the Spring of 2019, the Ontario government engaged in a province-wide public consultation process and appointed a new 20-member *Ontario Autism Program (OAP)* Advisory Panel.

This Panel was comprised of parents with lived experience, autistic adults and experts from a range of disciplines like psychology, behaviour analysis, rehabilitation services, education, developmental pediatrics and research. The Panel met for 18 full days over the summer months and was tasked with providing the government on the design of a needs-based, sustainable OAP that serves as many children as possible within the increase \$600 million funding envelope.

There has been a tremendous amount of work completed by the Panel to date. Furthermore, the
