## STUDENT ACHIEVEMENT PLAN 2024-2027

#### **BACKGROUND INFORMATION**

During the 2023-2024 school year the Ministry of Education introduced a new Student Achievement Plan which replaces the Board Improvement plan. The Student Achievement Plan is intended to support school boards in adopting the provincial priorities into their multi-year plans, with goals and indicators to focus their improvement planning process.

The provincial priorities in the Student Achievement Plan reflect the priorities in Ontario Regulation 224/23:

- 1. Achievement of learning outcomes in core academic skills.
- 2. Preparation of students for future success.
- 3. Student engagement and well-being.

The Student Achievement Plan is an accountability strategy to drive and assess progress on improving student outcomes and experiences in the education sector.

Key Objectives:

- 1. Common system-wide set of provincial priorities, goals and performance indicators for quality improvement.
- 2. Data-driven action planning process that leverages quantitative and qualitative data as well as community engagement.
- 3. Transparency to parents, students and local communities.

School Boards have been provided with a standardized framework to guide boards' improvement planning.

#### **Student Achievement Planning Process**

The Student Achievement Plan process and action plans will span a three-year cycle. The process is iterative and each year school boards will be:



To enhance accountability and transparency, school boards will be asked to report annually on their commitments and progress made on student achievement outcomes.

The Ministry states that the purpose of the Student Achievement Action Plan is to level up achievement outcomes and experiences for every student. The framework outlines three priority areas and corresponding goals:

- 1. Priority: Achievement of Learning Outcomes in Core Academic Skills
  - a. Goal: Improve students' literacy earning and achievement
  - b. Goal: Improve students' math learning and achievement
- 2. Priority: Preparation of Students for Future Success
  - a. Goal: Improve students' graduation rates and preparedness for future success
- 3. Priority: Student Engagement & Well-being
  - a. Goal: Improve students' participation in class time and learning
  - b. Goal: Improve student well-being

#### **Ontario Autism Program - Entry to School Program**

Bethesda and the Niagara Children's Centre serve 90 children across five classrooms through the Ontario Autism Program's Entry to School Program (ETS). Three of the locations were in NCDSB schools, including:

- St. Anthony St. Catharines
- St. Gabriel Lalemant Niagara Falls
- St. Augustine Welland

The current program started March 4, 2024 and ran through to the end of August. Children received up to 15 hours a week of interdisciplinary group service. The team prepared Integrated Transition to School Reports that were shared with caregivers and school staff. The ETS Program also includes consultations to families and educators to help support the child's transition to school throughout the first term. Consultations from members of the Interdisciplinary team are still available. Educators can request consultations by emailing entrytoschool@bethesdaservices.com.

**Niagara Childrens Centre** - Transition to School period for students starting the 2024/2025 school year is in its last phase, with the last large batch of our transition reports making their ways to the school boards, including our ETS summaries.

ETS continues in partnership with Bethesda and will be collaborating on a fall cohort to support another group of students.

The Extensive Needs Program continues with our many community partners. We are at 57 clients receiving extensive needs services so far which really speaks to the need in our community. Many are simultaneously involved with our SBRS services so we have been able to streamline and use our SBRS clinicians to support the ENS needs.

Tiered OT Services under our School-Based Rehabilitation Service program continue to roll out across the elementary schools in Niagara Catholic. We also continue to add to complement with Occupational/Physiotherapy Assistants providing services under the supervision of our OTs and PTs supporting classrooms and students. Our Fall event guide has been published and shared with the community and we continue to encourage our community partners to share these opportunities with families. <u>https://www.niagarachildrenscentre.com/calendar</u>

Our Superhero Run is our signature fundraising event and includes a silent auction. This event not only raises essential funds for our programs but also fosters a strong sense of community support for the Centre where our centre families and the community can come together to participate in both a 5km walk/run and a 1km activity circuit.
