SEAC – Student Support Update Sept. 2024

1. IEPS

Teachers and ERTs have been continuing their work with IEP development using the new RISE

platform. We have been working closely with school staff to guide and support this new initiative.

2. GIFTED PROGRAMS

We have our first Gifted module scheduled for the beginning of October. This outdoor education module will be held at St. Johns Valley Centre. Students will engage in an orienteering and compass reading hike to learn the various parts of a compass and how to use it properly. They must then use specific directions to find checkpoints throughout the property. Students will work together in teams, drafting a design and creating a raft that will be tested in the creek! Our PRTs and MDTs both create and deliver these unique experiences for our students.

3. MUSIC WITH MENDELT

We are pleased to offer the opportunity for our secondary Special Educations classroom students and staff to participate in virtual sessions with *Niagara Catholic ROCKS with Mendelt* for the 2024-2025 school year. Mendelt Hoekstra is a Music Therapist and Executive/Artistic Director of the Momentum Choir. Mendelt will be providing weekly music sessions. Thank you to the Student Support Facilitators for supporting this initiative.

4. SEPTEMBER PD DAY

Student Support staff, alongside NSTS staff offered an information session that focused on supporting students on the bus with their communication needs. For students who are neurodiverse, the bus ride to and from school can be a trigger to their dysregulation systems and can lead to behaviours that are unsafe for the student as well as others on the bus. This workshop focused on strategies used by many of Niagara Catholic's Support Staff across the system to keep our students safe on the bus. Each participant will be provided with visuals, a tip sheet, resources, and a trauma-informed lens to support the homeschool-NSTS partnership in keeping children happy, safe and engaged on the bus.

5. Pryor Linder and Associate Psycho-Educational Assessments

We are continuing with providing Psycho-educational assessments to students who warrant this support. Pryor Linder and Associates is our partner agency that is providing the examiner and resources to conduct the assessment. Parents, student and staff are then invited to a feedback meeting that is meant to highlight the details of the report and recommendations that will support the students educational program.

6. Niagara Student Transportation Services

Student Support Coordinators, principals, vice-principals and other department members work very closely with NSTS staff to provide seamless, effective and enjoyable transportation to and from school under the guidelines of our policy. Our team communicates quite often with NSTS staff concerning new transportation plans and updating current transportation plans. Our busiest months are typically September and June. We also celebrate situations when students have learned new skills and have gained further independence to elevate to a less intrusive form of transportation. We do thank our colleagues at NSTS for the work they do to support students and families with their transportation needs.
