ELEMENTARY AND SECONDARY SCHOOL YEAR CALENDARS: 2025-2026

BACKGROUND INFORMATION

The Education Act, Regulation 304 - School Year Calendar, Professional Activity Days outlines the requirements and timelines for preparing and submission of school year calendars to the Ministry of Education for approval.

For the 2025-2026 school year calendars, there are 195 possible school days between September 1, 2025 and June 30, 2026. Within this total, elementary and secondary schools must have a minimum of 194 school days, of which seven (7) days must be designated as professional activity days. Secondary schools may have a maximum of ten (10) instructional days set as examination days. The remaining school days shall be instructional days.

The 2025-2026 School Year Calendar Committee met to discuss and review the draft calendar and the consultation process.

MATH ACHIEVEMENT ACTION PLAN 2024-2025 MID-YEAR REPORT

BACKGROUND INFORMATION

The Ministry of Education launched Ontario's Math Achievement Action Plan during the 2023-2024 school year to support student achievement and results in math across the province. The ministry brought together experts in mathematics education to better understand next steps for math improvement in Ontario. Through this work, the ministry developed *Taking Action in Mathematics* (Appendix A), an iterative framework to capture areas of focus and guide improvement actions.

Math Achievement Action Plan

Informed by the ministry's *Taking Action in Mathematics* framework, the Board Math Lead, along with the Math Facilitators developed a board Math Achievement Action Plan, which included three sections:

- All schools report to provide board-wide improvement efforts and results in mathematics
- Priority Schools report to provide intensive improvement efforts
- Priority Schools Provincial KPI (Key Performance Indicators) report to provide intentional monitoring of student achievement KPI's common to all priority schools across the province.

The Math Achievement Action Plan outlines the board's concrete, visible, and measurable strategies as well as key performance indicators at the board, school, and classroom level under the four areas of focus:

- 1. Curriculum Fidelity
- 2. Math Content Knowledge for Teaching
- 3. Knowing Your Student
- 4. Measurable Results: Improvements in Math Achievement

The Math Achievement Action Plan is to be endorsed by the Director and trustees of the board and will be submitted to the ministry under the following timelines:

November 15, 2024 (Initial): Initial strategies and KPI's March 15, 2025 (Progress): Incorporate data from Term 1/Semester 1 July 15, 2025 (Final): Incorporate data from Term 2/Semester 2

All schools continue to engage in the work of their Math Achievement Action Plans.

• All staff Kindergarten – Grade 8 continue to receive job-embedded Literacy and Numeracy Professional Learning during Chaplaincy Visits through the year targeting the three priority actions identified by the Ministry

- Grade 3 and 6 staff at Priority schools receive additional support and professional development from the Board Math Facilitators (Math Consultant and Math Coaches)
- Professional learning related to the Ministry's Priority Actions are included in Elementary and Secondary PA Days
- Principals continue to participate in Principal Learning Teams concentrating on leading math learning in their schools.
- Positive feedback from the Ministry of Education on the submitted Math Achievement Action Plan and data, specifically the progress that has been identified in relation to the Key Performance Indicators which link observable student outcomes /progress to the educator knowledge and actions.
- Some changes were made to Priority schools, recognizing the measurable improvements in student achievement at those schools. Through a gradual release of support, schools initially named Priority Schools make way for other schools to benefit from additional support from Math Facilitators (Consultant and Coaches).
- First Term Report Cards will soon be complete and provide a data source to measure impact.

Taking action in mathematics | Look-fors by provincial action

Math achievement efforts across the province should include multiple proven evidenceinformed strategies and approaches to address local learning needs in schools.

The ministry has worked with researchers, math specialists, and school boards to identify three interwoven math actions to be prioritized in the 2023-24 school year. Board Math Leads, as they determine board and school priorities in mathematics achievement, will develop, implement, and monitor a Math Achievement Action Plan that includes meaningful and measurable key performance indicators (KPIs) aligned with each of the priority actions below.

A mathematics community of excellence: In order to promote effective math instruction, it is important for educators to foster mathematics communities in classrooms and schools, and to recognize that not all students learn math in the same way or within the same time frames. Effective math instruction is supported by an inclusive, positive, and safe learning environment where all students feel valued and engaged, and in which educators clearly communicate expectations and establish norms and routines with their students at the beginning of instruction. Educators at all levels of the school system have a role to play in establishing a culture of excellence in mathematics and setting conditions for success. This includes leaders reviewing practices to determine barriers to success, creating accountability, and attending to mathematics attitudes and mindsets in school and system improvement plans.

B. PRESENTATIONS

1. Michael Jacques – The Power of Community

Michael's Introduction:

-Michael shared that he has autism and works at Sobeys. He is also a public speaker and participates in basketball and baseball through the Special Olympics.

-He relies on technology to assist with tasks he finds challenging.

Rings of Influence:

-Michael discussed the key influences in his life: **Himself, Family, Friends, Education, and Community**, and how these groups impact him and vice versa.

ReAction4Inclusion Program:

-Michael joined the **ReAction4Inclusion** program in grade 10, where he initially participated as a student. He later became an organizer and is now a presenter for the program.

-The program is a weekend conference featuring workshops developed by high school students for students both with and without challenges.

-The focus of the program is on leadership and authentic inclusion. Students learn strategies to make their schools and communities more inclusive and were encouraged to bring these strategies back to their schools.

Education and Achievements:

-Michael graduated with a diploma after 7 years at Notre Dame College, with the support of staff and appropriate accommodations.

-Key takeaways for educators:

- Get to know your students.
- Ask questions and allow space.
- Think outside the box and ensure inclusivity.
- Encourage open discussion.
- Set achievable goals and find ways to make learning fun.
- Focus on what students can do, rather than what they can't.

Professional Accomplishments:

-Michael works at Sobeys, which employs individuals with disabilities and sponsors Special Olympics Canada.

-He managed to get his book distributed to stores across Canada.

-He served as a board member for **Community Living Ontario** and was President for two years.

-He was a member of the **Fonthill Rotary Club** for four years and received the **Paul Harris Award**.

-Michael was appointed by the **Minister of Education** to join the **Minister's Advisory Council on Special Education**. He is the only member with lived experience.

Inspiring Impact:

-Michael has made significant contributions despite challenges in reading and writing, including becoming an author. He presents to universities, colleges, and agencies to share his story and advocate for individuals like himself across Ontario.

-Through his work, Michael has raised over **\$12,000** in donations for various organizations he supports.

3. Letter to Ministry of Education on behalf of all SEACs in Ontario

Seeking support for Call to Action from other SEAC. The focus on insufficient funding for special education programs and services in combination with the critical shortage of Educational Assistants. The province is facing a severe shortage of qualified Education Assistants. A lack of appropriate staff and support can also result to keep students at home. 72% of elementary schools and 67% of secondary schools that have daily shortages are recommending students that require EA support stay home. Some strategies were provided: Free tuition for EA Programs, Retention Bonuses, Living wage and benefits, Enhanced Professional Development, Improved working conditions, Stable Employment, In crease and improve all special education resources. They are asking us to consider as Niagara Catholic SEAC to support this letter.

-How could "living wage and benefits" be spoken about by SEAC?

-Agreement that a lot of suggested ideas do not have to do with SEAC, very important but more data will be needed to support this.

-We are in the process for planning for the inevitable shortage of EAs. Mohawk college has already shut down their program due to lack of interest. We re preparing in schools for worst case senecios already. We have onboarded 22 new EAs in December. There are concerns on supporting this letter because we have the MACSE survey. Would like to support the cause and include it in our submission for MACSE. Paige will send it to everyone to review.

-start a small committee to meet before the deadline and work though the MACSE form. Paige will make it a shared document for everyone to share on it. Follow up with a brief meeting to discuss what is contributed to the shared form.

Learning Disabilities Association of Niagara Region - Madeline

Niagara Children's Centre – Michelle

-Thank Niagara Catholic for support and partnerships in the roll out of the tiered model. - Extensive needs service continues this is the ENS that is co-led by Niagara Children's Centre in Contact Niagara. Receiving positive feedback regarding the impact of the program regarding children's participation at school and engagement and routines.

- Transition to school season has begun. Functional checklists have been utilized and getting prepared meetings with board staff have already been booked for end of January and early February. Specifically the entry to school program in the fall with Bethesda done with children born in 2020 or earlier.

-New Winter event guide is out for January to March. Wo new "Tween" group for age 8 – 13; working on tabletop games, crafts, conflict resolution and general social interaction. Another program is Prepared Pals that also has a focus on tweens and they develop skills such as baking, environmental safety, money management and basic personal care.

Pathstone Mental Health - vacant

Down Syndrome Niagara – Looking for responses from interested community members for a survey to assist in planning next DSAO conference in the fall, this is poste on their FaceBook page. -World Down Syndrome is on March 21st, theme is "we call on all Governments to *Improve Our Support Systems*"

Bethesda Service – Ramping up Spring program with 90 children that will start the program in March and will run through until the end of August, this is in partnership with the Niagara Children's Centre. At this time there have been 70 intakes and plans in place. They have been using space in Niagara Catholic Schools – St. Gabriel Lalemant, St. Augustine and St. Teresa of Calcutta, it is a wonderful opportunity to offer the program in kindergarten classes and the school support teams have been great to work with. The launch of the winter service guide is on the Bethesda website. They run recreational and clinical groups during the week; the groups are from two years up to adults.

SECONDARY PRINCIPAL - Preparing for IPRC meetings

STUDENT SUPPORT DEPARTMENT – Snack and Chat, this is system wide and it involves the Early Years Lead, the Behaviour and communication services Lead, the behaviour Analysts and Speech and Language pathologists. This aims for foster communication skills, turn taking, active listening and peer interactions during both snack and lunchtimes in our kindergarten classrooms, while reducing screen time. – Gifted modules are taking place January 21st and 22nd this upcoming module will be on wood construction and aim to teach students about the art and science of carpentry. Students will explore the different types of wood, their properties and how they are used in construction they will also be gaining valuable skills in safety, design, measuring and cutting. The day will begin with Dr. Jody Carrington who is renowned for her expertise in solving complex human-centre problems, as well as promoting authentic human connection. The secondary EAs, CYWs and student support department and Social workers will have the same session on the January 29th PA Day.

Julia Nemcko and her team have been working on a proposal that has been supported through the finance department to offer 21 different initiatives between January and August for the Behavioural Analysts.
