Senior Staff highlights included:

Superintendent Forsyth-Sells

Assumption Catholic Elementary School students from the Grades 6 and 7 classes participated in and received awards at the Niagara Regional Science and Engineering Fair on April 1, 2026. This regional event has many sponsors supporting science and engineering projects, including Niagara Catholic as a Platinum Event Sponsor.

Emilio participated in the Juvenile division for Grades 5 and 6 students, and won the Outstanding Achievement Rotary Club of Niagara-on-the-Lake Award for his "Jolly Eggs" project, a project about braces and how long a time period should be for someone to brush their teeth. Marlowe and Adelaide participated in the Junior Division for Grades 7 and 8 students, and were the recipients of the Brock University Chemistry Award for their Makeup Removers' experiment. Maelle also participated in the Junior Division and won the Structural and Civil Engineering Award for her project, "It's Getting Hot Here", a project about what type of roof shingles retain heat the best.

Congratulations to Assumption Catholic Elementary school students and their teachers, Mr. Ciocca and Mrs. Hitchcock, for their scientific and engineering achievements representing Niagara Catholic.

Superintendent Kinney

Superintendent Kinney highlighted participants and winners that had participated at the Regional Science and Engineering Fair. 40% of the projects this year within the fair were from Niagara Catholic, which is an increase from previous years.

St. Martin Catholic Elementary School, Madeleine Chliszczyk and Audrey Romansky, who won the Brock University Earth Science Award for their "Stars and Constellations and Why They Matter".

St. Ann Catholic Elementary School in Fonthill, Brock University Social Sciences Award went to Leela Tupman for "Insight or Indoctrination".

Canadian Martyrs Catholic Elementary School, Nehal Amini and Miracle Asingya, “Teeth versus Beverages” won the Chemistry Award from Brock University.

Notre Dame Catholic Elementary School, “The Eggsperiment” The Mancuso Chemicals Award went to Brandon Alexsiejuk.

Dennis Morris Catholic High School, the Innovation Science Award that went to Amaya Sahota for her project on “Plant-derived Vascular Scaffolds for Postmastectomy Lactation Restoration, a Regenerative Approach to Mammary Duct Reconstruction. Amaya received a Brock University entrance scholarship for the same project. Amaya also received the Muslim Medical Association of Canada Niagara Chapter Award.

St. Martin Catholic Elementary School, the Ontario Power Generation Award went to Matthew Sourdos for “Proof the Hydrogen is the Next Super Fuel.”

Certificates from OPG went to Giorgia Cagnelli, from St. Ann Catholic Elementary School in Fonthill, and that was the silver medal for “Too Fat to Foam.” A school awards from Juvenile Studio T3 Engineering Award went to St. Ann Catholic Elementary School. It was a very robust participation this year and very successful students.

This past weekend, April 10th to 12th, Niagara College buzzed with energy as it hosted the First Robotics competition, welcoming young innovators and their custom-built machines from across Ontario. Dennis Morris Catholic High School High Voltage Team 2852 competed and showcased their incredible teamwork and determination while successfully advancing to the third round of eliminations. Their impressive performance has secured them a spot at the Ontario FIRST Robotics Provincial Championships, held April 16th to 19th at the Niagara Falls Convention Centre. Over these four days, the team will join the province's best to compete, connect with peers, and celebrate the future of technology.

STATEMENT OF GOVERNANCE POLICY

100 – Board

Policy No 100.4

Adopted Date: March 28, 1998

In keeping with the Mission, Vision and Values of the Niagara Catholic District School Board, the Board of Trustees values the leadership, perspectives and participation of Student Trustees at Board meetings, Board committee meetings, and Board activities and events. Student Trustees represent the interest of all students of the Board, promoting a student-focused voice to support Catholic education, equity, and student achievement and well-being.

In accordance with legislation, the Niagara Catholic District School Board shall have two Student Trustees on the Board.

To be eligible to serve as a Niagara Catholic Student Trustee, student nominees will hold the following qualifications:

- be actively supportive of the distinctive character, philosophy and goals of Catholic education, respect the faith and traditions of the Catholic Church, and support the Mission, Vision and Values of the Niagara Catholic District School Board.
- be enrolled as a full-time student, in a Niagara Catholic secondary school for the duration of their term.
- be a member of the Secondary Student Senate;
- provide a signed parental permission to be a Student Trustee if under 18 years of age.
- be endorsed by the principal of their Catholic secondary school.
- conduct themselves with proper demeanour at all times upholding the Mission, Vision, Values and Policies and Administrative Operational Procedures of the Niagara Catholic District School Board.

Terms of Office

Student Trustees will serve for a term from August 1 during the year of their election to July 31 during the final year of their term. Student Trustees shall be elected by the Niagara Catholic Student Senate. In the event that an incoming Senate representative is not available to vote on the date of election, the Student Council President representing that school may vote in their place.

One of the two Student Trustees must be enrolled in Grade 10 at a Niagara Catholic secondary school at the time of the election and must be eligible to serve a two-year term.

This same Student Trustee will have one year of experience as a Student Trustee when they continue in office the following school year.

The Board shall provide the Ministry of Education with the names of the Student Trustees elected, no later than 30 days after the date of the election or by-election as required by legislation.

The Director of Education will issue *Administrative Operational Procedures* for the implementation of this policy.

On March 2, 2026 the Board was notified by the Ministry of Education that the “electronic school year calendar submission meets the requirements of Sections 2, 3, and 4 of Regulation 304 – School Year Calendar, Professional Activity Days and is deemed compliant for posting”.

Annually, staff utilizes the approved Board and Ministry of Education school year calendar to design the Board School Year Calendar and Meeting Dates along with a calendar of dates for school and system activities, celebrations, events, faith formation, meetings and professional development.

B. PRESENTATIONS

1. **Susy Walsh – Resource Centre Update**

Susy Walsh presented:

- The pilot aims to provide students with a small, quiet setting to develop essential life skills, including social-emotional regulation, leadership, and communication with the goal of transferring these skills back into the regular classroom and home life.
- Students have shown significant growth in managing their behavior and interactions:

- Moving from physical outbursts to using words, deep breathing and waiting turns.
 - Better cooperation, sharing, and problem-solving among peers.
- The program bridges the gap between school and home:
 - Students are learning the neuroscience of their own brains, helping them understand why they feel certain emotions.
 - Parents report a reduction in “shutting down” during homework and an increased ability for students to step away and refresh rather than reacting aggressively.
- The pilot is successfully creating a “circle of support” that empowers students to move from frustration and silence to independence and active participation in their communities.

2. **Jim Di Gioia – Annual Special Education Plan Review**

Jim Di Gioia presented:

- An outline of the mandatory annual review of the Special Education Plan for Niagara Catholic, ensuring it remains compliant with the Education Act.
 - This is a retrospective review – it encapsulates the actions of the current school year rather than planning for the next.
 - The Education Act requires all school boards to maintain and annually update a special education plan.
 - SEAC is a central part of this process, providing consultation and reviewing all proposed amendments.
 - Updates include statistical data, staffing, committee logistics and annual progress

Susy Walsh reported:

- Great success with the new Boccia sets each school received, and the in-school training by the para-athletes.

2. Secondary Principal – Nicole Royer and Roxanne Rees

Nicole Royer and Roxanne Rees reported:

- March 13th is the deadline for option sheets for numbers and to get account receptions.
- Special education students are given a broad-based grading system in class based on socialization, skills, independence and organization.
- Planning for the “Time to Shine Formal” is underway, including a photobooth, meal planning and group planning

3. Student Support – Jim Di Gioia

Jim Di Gioia presented:

- S.L.A.M. Summer Camp – Ages 6-11 In-Person Summer Camp
 - The Student Support Department has provided funding to the Learning Disabilities Association of Niagara Region (LDANR) to support student participation in a one-week fully funded S.L.A.M. Camp. The program provides engaging literacy activities that build phonics skills, sight word recognition, and reading fluency. Elementary schools were able to submit names of students who meet the criteria to participate in the program.
 - S.L.A.M. Camp is a full-day summer camp designed for children aged 6-11 who are one or more years behind in literacy due to a diagnosed, suspected, or identified reading disability (like dyslexia). Campers participate in engaging literacy activities that build phonics skills, sight word recognition, and reading fluency. Our approach is hands-on and playful, helping kids feel confident and capable as they strengthen their reading abilities.
- Rick Hansen Foundation Accessibility and Inclusion Training
 - Niagara Catholic District School Board’s Accessibility Committee and The Rick Hansen Foundation (RHF) are working towards a system-wide goal of educating our youth, staff and community members about accessibility, disability, and inclusion.
 - Principals, VPs, and ERTs have been invited to participate in the Rick Hansen Foundation’s Educator Inclusion and Accessibility Training Course, a module-based course focused on disability inclusion, accessibility, and equitable practices, with an emphasis on understanding the lived experiences of youth with disabilities. The course is available as of April 13th.
- Gifted Module
 - The next elementary Gifted Education module is planned for April 15th and will be a faith-centered day of engaging, hands-on learning that connects spirituality with problem-solving, critical thinking, and teamwork. Through collaborative activities focused on faith, guidance, and community, students will reflect and discuss their learning while building a strong sense of connection and belonging.

4. Superintendent Pizzoferrato – Gino Pizzoferrato

Superintendent Pizzoferrato reported:

- Secondary school transition initiatives:
 - Each secondary school is receiving a dedicated budget to fund activities that engage students and parents from feeder elementary schools

- The program now targets students as young as Grade 6 to demystify the high school transition process and build staff capacity regarding various secondary pathways.
- The goal is to provide parents and students with comprehensive information and awareness before they have to make official school program choices in Grade 8
- The department is currently drafting a transparent process and policy regarding EVAC Chairs for students with mobility needs. They are seeking the following from community partners:
 - Any specific operational procedures or policies from community groups that consider the unique needs of the individuals they serve.
 - Community members with relevant documentation or insights on evacuation safety and equipment are encouraged to share them to assist in the drafting phase.
- The board is currently investigating installation requirements and facilities support, the role of vendors in equipment maintenance and training, and funding models and financial responsibility.
