NIAGARA CATHOLIC BUDGET 2010-2011

BACKGROUND INFORMATION

On March 26, 2010, the Ministry of Education, announced the funding allocations for the school year 2010-2011. The announcement indicated that school boards would receive an increase of \$694 Million, which represents an increase of approximately 3.6%, over last year.

The 2010-2011 Grants for Student Needs (GSN) include the funding required to support the staffing provisions and the 3% increase in compensation for all staffing categories under the Provincial Framework Agreements (PFA), as well as some marginal funding enhancements to keep with the cost increases in Plant Operations and in Special Education.

In order to deal with the current Provincial Financial Deficit, the Ontario Government has found it necessary to impose constraint measures on all school boards in the funding envelopes for textbooks and learning materials, computers, professional development and transportation. These constraint measures will result in a funding reduction of approximately \$1 Million for Niagara Catholic, which must be offset by a proportional reduction in expenditures.

It is important to note that average daily enrolment is projected to decrease by approximately 300 students during the 2010-2011 school year. This decrease will result in a reduction of funding, which must be offset by staffing reductions through staff reallocations and through attrition.

Senior Administrative Council has now completed the review and analysis of the 2010-2011 Budget Requests submitted by staff, including the deployment of staff and the allocation of resources to the schools and departments of the Board. After many meetings and deliberations, Senior Administrative Council is now pleased to present to the Board the proposed 2010-2011 Annual Budget, which was prepared in accordance with the Public Sector Accounting Standards, as mandated by the Ministry of Education.

The 2010-2011 Annual Budget amounts to a total of \$240,806,939 and it will be <u>balanced</u> without a transfer from the Reserve for Working Funds. This budget will enable Niagara Catholic to continue to offer excellence in Catholic educational programs and services to all the students in its jurisdiction. This Budget also includes several new initiatives, such as the launching of the Early Learning Kindergarten Program, which will be phased in over a five year period.

Please note that the 2010-2011 Annual Budget was prepared in accordance with the Board Vision 2020 Strategic Plan and the Board approved Niagara Catholic Strategic Directions Priority Indicators 2010-2011.

We take this opportunity to express our appreciation to all Board Staff, who have been involved in the budget process, for their diligence, and focus in preparing the Annual Budget for 2010-2011.

REVISED BOUNDARY DESCRIPTIONS FOR SACRED HEART CATHOLIC ELEMENTARY SCHOOL

BACKGROUND INFORMATION

At the January 26, 2010 Board Meeting the Report of the Niagara Falls Elementary and Secondary Family of Schools/St. George and St. Joseph (Snyder) Catholic Elementary Schools and St. Michael Catholic Elementary School, Niagara-on-the-Lake from the Ad Hoc Attendance Area Review presented new boundary descriptions for elementary and secondary schools in Niagara Falls as a result of a boundary review. The boundary descriptions were based on existing boundary descriptions for the elementary and secondary schools in Niagara Falls.

In consultation with the Niagara Student Transportation Services, (NSTS), in preparation for the 2010-2011 school year, all boundary descriptions for the elementary and secondary schools in Niagara Falls have been revised for clarification and accuracy. At the June 15, 2010 Board Meeting, the boundary descriptions were approved by Board Motion.

Further to this approval, the Niagara Student Transportation Services (NSTS) has since clarified the boundary for Sacred Heart Catholic Elementary School.
