#### **BACKGROUND INFORMATION**

The plan will be guided by the Niagara Catholic District School Board Accessibility Standards Policy and Guidelines No. 800.8.

# 1.0 <u>Objectives</u>

This Plan:

- **1.1** Describes the process by which the Niagara Catholic District School Board will identify, remove and prevent barriers;
- **1.2** Reviews recent efforts of the Niagara Catholic District School Board to remove and prevent barriers;
- **1.3** Describes the measures the Niagara Catholic District School Board will take in the period 2012-2017 to identify, remove and prevent barriers;
- **1.4** Makes a commitment to provide an annual status report on the Board's implementation of the multi-year accessibility plan;
- **1.5** Makes a commitment to review and update the multi-year accessibility plan at least once every 5 years;
- **1.6** Describes how the Niagara Catholic District School Board will make this accessibility plan available to the public.

# 2.0 <u>Commitment to Accessibility Planning</u>

This document has been written with the intent that the recommendations prepared by the Accessibility Planning Committee will be presented to Administrative Council and to the Board of Trustees.

The Niagara Catholic District School Board is committed to:

- **2.1** Maintaining an Accessibility Planning Committee;
- **2.2** Continuing the process of consulting with the Special Education Advisory Committee and with persons with disabilities;
- **2.3** Ensuring, wherever practicable, that Board policies, procedures and practices are consistent with the principles of accessibility and inclusive/universal design. The Accessibility Planning Committee will provide input re: accessibility issues, where appropriate, with regard to new policies and procedures and to those under review;
- **2.4** Improving access to facilities, policies, programs, practices and services for students, staff, parents/guardians, volunteers and members of the community. Consideration of ongoing identification of barriers will be the responsibility of the Accessibility Planning Committee and will, wherever practicable, be incorporated in the multi-year plan.

The Director of Education has authorized the Accessibility Planning Committee to review and update the Multi-Year Accessibility Plan that will enable the Niagara Catholic District School Board to meet these commitments.

# 3.0 Description of the Niagara Catholic District School Board

Following government legislation entitled the "Fewer School Boards Act," the total number of school boards in Ontario was reduced to 72. The aforementioned legislation also impacted the Niagara Catholic District School Board. The Niagara Catholic District School Board was established on January 1, 1998, as a result of the amalgamation of the former Lincoln County Roman Catholic Separate School Board and Welland County Roman Catholic Separate School Board, in compliance with government legislation.

The Niagara Catholic District School Board, consisting of eight secondary schools and forty-nine elementary schools, currently serves 21,640 students and 3,233 employees. The philosophy of the Niagara Catholic District School Board is that learners are called by God to fulfill their potential; all learners are gifted by God and can learn; learning is an interactive process; learning is an enriching experience; and learning is for eternity. Furthermore, students, regardless of special talents or challenging needs can grow and they can grow best by attending schools, which offer accessible programs, in accessible settings, through accessible services.

## NIAGARA CATHOLIC BOARD IMPROVEMENT PLAN FOR STUDENT ACHIEVEMENT AND WELL-BEING (BIPSAW) 2016-2017

#### **BACKGROUND INFORMATION**

The Niagara Catholic Board Improvement Plan for Student Achievement and Well-Being (BIPSAW) 2016-2017 has been developed to support the continuous improvement of achievement and well-being for all students in the Board.

The four pillars of Catholic Faith, Community and Culture, Literacy, Numeracy and Pathways focus on coherence with Ministry of Education goals, the School Effectiveness Framework, the Board's Strategic Directions, and Enabling Strategies. The theories of action within the four pillars align with the needs of the system to improve achievement and well-being of all students.

The System Improvement Learning Cycle (SILC) is a new process of dialogue between the Ministry of Education and school boards. The first initial meeting between Senior Administrative Council and the Ministry of Education Staff occurred on October 3, 2016. The discussion included the BIPSAW, the implementation of the Ministry of Education *Renewed Mathematics Strategy* in Niagara Catholic, and the sharing of effective strategies with schools in the Board and with other school boards with support from the Ministry of Education staff.

The BIPSAW has been provided to all schools to support the School Improvement Planning process and has been posted on the Board website.

The Niagara Catholic Board Improvement Plan for Student Achievement and Well-Being (BIPSAW) 2016-2017 has been included in this report (Appendix A).



## **GOOGLE APPS FOR EDUCATION (GAFE)**

#### **BACKGROUND INFORMATION**

In March 2014, the Ministry of Education entered into an agreement with both Google and Microsoft that supported the use of cloud based digital tools.

In January, 2016 the Niagara Catholic District School Board endorsed the Technology Blueprint 2016-2020 which provides a roadmap for technology infrastructure spending to support student learning and the corporate side of operations.

The Education Technology Services Department, in February 2015, successfully piloted the use of Google Apps for Education (GAFE). Feedback from students and staff was positive in terms of the ease of use, access from home, ability to collaborate and the amount of file storage.

#### WHAT IS GOOGLE APPS FOR EDUCATION?

The Educational Technology Services Department, in moving to cloud based platforms, has created over 25,000 accounts so that both students and staff can use the Google Apps for Education suite of products.

The move to GAFE ensures that staff and students have access to a free suite of digital products that is accessible regardless of the device used both at school and at home. The GAFE tools include a word processor (Docs), presentation tool (Slides), spreadsheet (Sheets), email account (Gmail) and unlimited file storage (Drive).

Each user receives a unique @niagaracatholic.ca account that they use to login to Google. Students and staff experience an advertisement free digital environment that ensures that their bookmarks are available regardless of the device used.

#### WHY USE GAFE?

As the Niagara Catholic District School Board moves to help students master global competencies, students need to be free from the restrictions imposed by having specific software loaded on hardware. Such requirements are labour intensive and expensive. In using GAFE, students have access to their files wherever they are, whenever they want them on whatever device they are using.

One of the advantages of GAFE, for staff, is that teachers also have the ability to use Google Classroom which provides staff with the ability to create online classes that house course syllabi, classroom resources (print/sound/video), and assignments.

A major advantage of GAFE is the ability of Education Technology Services staff to manage the platform from the Network Centre and the platform performs seamlessly on Chromebooks which are available in all Niagara Catholic Schools.

#### PROFESSIONAL DEVELOPMENT SUPPORT

A portion of the 2015-2016 Technology Learning Fund Grant supported professional development. The Niagara Catholic District School Board purchased an online tool, Synergyse, that provides 24/7 technical support using brief videos layered on top of the file being used. Synergyse has been purchased by Google and the tool continues to be available for students and staff, at no charge.

Two Digital Coaches have been added centrally to work more closely with the School Effectiveness – ELKP-12 Department, Special Education Department and the Research, Assessment and Evaluation Department. A recent example of this was at a recent workshop to support the Remedial Mathematics Strategy where staff from the departments worked cooperatively to provide professional development to secondary school Mathematics and Special Education teachers. The two coaches and our TELT (Technology Enabled Learning and Teaching Contact) will support staff as they continue to adopt GAFE in their teaching practice.

As part of this information report, staff will present a slide presentation and video to highlight some of the advantages that GAFE is providing for students and staff across the Niagara Catholic District School Board.

#### Director, Senior Staff, Present 2015-2015 System Priorities Achievement Report





During the September 27 Board Meeting, Director of Education John Crocco presented the 2015-2016 System Priorities Achievement Report to trustees.

The System Priorities Achievement Report is presented to trustees annual in September, so they are aware of the progress made in implementing the System Priorities the previous year.

#### St. John Valley Centre to Become Saint Kateri Tekakwitha Centre



Niagara Catholic will re-name the St. John Valley Centre, an outdoor education centre enjoyed by students for many years, in honour of St. Kateri Tekakwitha.

The request was brought forward by an Ad Hoc Committee, comprised of the Superintendent of Education – Program, the Student Success Lead and students and staff at the Centre.

The Centre is the Board's new Indigenous Alternative Education Site, and the request to re-name the St. John Valley Centre in honour of Kateri Tekakwitha, (known as "Lily of the Mohawks,") who devoted herself to God

throughout her lifetime more than 300 years ago, is supported by the Niagara Peninsula Conservation Authority, which owns the property. The program offered at the Centre exemplifies St. Kateri's conviction to working with those less fortunate as their advocate, and embraces the Board's Outdoor Education Centre, as St. Kateri is the Patroness of ecology and the environment, people in exile and Native Americans.

Prior to renaming the Centre, the Board will consult with Bishop Bergie, local Trustees, the Chair and Vice-Chair of the Board, the Director of Education, Board Chaplaincy Leader, and, when possible, facility staff, local Catholic School Councils and the local Catholic school community.

#### Niagara Catholic Students Exceed Provincial Averages in All EQAO Assessments

The Education Quality and Accountability Office (EQAO) has released the assessment results for Grade 3 and 6 mathematics and literacy assessments, Grade 9 mathematics assessments and the Ontario Secondary School Literacy Test (OSSLT), including results for the Niagara Catholic District School Board. This is the first time that all EQAO assessments have been released at the same time.

Grade 3 and 6 students exceeded the provincial average in reading, writing and mathematics.

Seventy-nine per cent of primary students at Niagara Catholic performed at Level 3 or above on the assessment, compared to 72 per cent of the province-wide cohort. Eighty

per cent of Grade 3 students obtained Level 3 or higher on the writing assessment compared to 74 per cent across Ontario, and 68 per cent of students obtained a Level 3 or higher on the mathematics assessment, five per cent higher than all Ontario Grade 3 students who took the test.

On the Junior panel, 84 per cent of Grade 6 students who participated in the assessments achieved Level 3 or higher on reading, three per cent higher than the provincial figure, 86 per cent of Junior students obtained a Level 3 or higher on writing, compared to 80 per cent in Ontario, and 56 per cent of Grade 6 students obtained Level Three or higher in mathematics, compared to the 50 per cent province-wide figure.

In the Grade 9 mathematics, 83 per cent of students in the academic stream performed at or above the provincial standard, on par with the provincial figure, and 47 per cent of students in Applied mathematics met or exceeded the provincial standard, two per cent higher than the provincial figure.

The Ministry of Education requires students to successfully complete the Ontario Secondary School Literacy Test in order to graduate from secondary school. In 2016, 86 per cent of the students who wrote the test for the first time were successful. In Ontario, that figure was 81 per cent.

Mathematics will be a key focus for Niagara Catholic throughout 2016-2017, as Board and school administrators and school staff continue to work together to improve student achievement in mathematics through the Ministry of Education's Renewed Mathematics Strategy.

"Niagara Catholic is fortunate to have a strong team of committed partners committed to student success," said Board Chair Father Paul MacNeil. "Students work hard every day to learn new concepts and are guided by teachers and support staff who provide support and encouragement. These lessons are reinforced at home. We recognize the value of the results of these assessments, but we believe that each student has unique gifts and talents that are far more meaningful than an assessment score. We will continue to balance student achievement with the need to build up student confidence and acceptance."

Director of Education John Crocco said the Board will continue to work toward areas of strength continue to move forward, and to focus on areas where improvement is needed. *"We are extremely proud of the exemplary Catholic leadership of our school and system administrators, the dedication and skills of our talented staff and the commitment of our students to academic excellence"* said Director Crocco. *"EQAO assessments are one of the many pieces of evidence that the Board and schools use to measure student achievement. Combined with other data, assessments, and the important ongoing conversations held with students, parents and staff throughout the school year, this provides consistent opportunities for feedback and planning to design and provide* 

programs and services for the success of all students in all schools throughout Niagara Catholic."



# 2017 OCSTA Trustee Award of Merit: Guidelines

## NOMINATION ELIGIBILITY

- Only Ontario Catholic school trustees are eligible to receive this award.
- Nominations may be made by OCSTA member boards or individual trustees.
- A trustee may nominate another trustee who is not from his or her own board.
- Current members of the OCSTA Board of Directors are not eligible to receive this award.

## **EVALUATION CRITERIA**

This award is given to trustees who have demonstrated one or more of the following three criteria, given a weighted value in points totalling 100:

- The nominee has made a significant contribution to the Catholic education community while serving as a Catholic trustee. (50 points)
- The nominee has strong Catholic leadership qualities and gives witness to their faith commitment. (30 points)
- The nominee has served as a Catholic trustee for a significant period of time. Although this award is not a reward for long-term service, length of service will be taken into account. (20 points)

## REGULATIONS

- Nominations are reviewed at the February Board of Directors' meeting.
- The Board of Directors makes the selection from among all nominations.
- Up to three awards may be presented in any given year.

## NOMINATION FORMAT

- Nominations must be preceded by the Nomination Cover Sheet.
- The response for each of the criteria must **not** exceed one 8.5 x 11 double-spaced page or 400 words. Only information within the prescribed length will be considered.
- Within the prescribed length, please provide sufficient information about the nominee to permit the Board of Directors to make an informed choice.
- Submissions must be clearly legible.

## SUBMISSION METHOD AND DEADLINE

- Nominations may be submitted by email to Camille Martin at <u>cmartin@ocsta.on.ca</u>, or by mail, courier, or fax (416-932-9459).
- The deadline for the receipt of nominations in the provincial office is **12:00 p.m. EST**, **Friday**, **January 20**, **2017**. The deadline is firm and will not be extended.

The OCSTA Student Trustee Alumnus Award recognizes exceptional achievement in any field vocational or voluntary—and positive Catholic values reflective of the characteristics described in the Ontario Catholic School Graduate Expectations.

This provincial recognition is given to no more than one former Student Trustee each year and need not be awarded on an annual basis. In establishing this award, OCSTA seeks to celebrate the positive impact of Catholic Education on the lives of student trustees and the communities they reach after graduation.

### Eligibility

- The nominee must be a former Catholic school Student Trustee.
- The nominee must have graduated from a Catholic secondary school in Ontario at least five years prior to his/her nomination.
- Nominations must be submitted using the OCSTA Student Trustee Alumnus Award Nomination Form and be received by 12:00 p.m. EST, Friday, January 20, 2017.

### Process

- Any OCSTA member trustee or Ontario Catholic school board can submit nominations to help recognize the impact made by distinguished Catholic school Student Trustee alumni.
- Only one person will be honoured in any given year. The Board of Directors is not required to present an OCSTA Student Trustee Alumnus Award each year.
- Each evaluation criterion (see below) is given a numerical weight. After the nominations deadline and prior to the February Board of Directors' Meeting, each Director on the Catholic Education & Trustee Enrichment Committee will assign a numerical score for each criterion of a nominee and total the scores. The Award will be given to the nominee with the highest total number of points from these Directors.
- The winner of the Award will be announced at the February 2017 Board of Directors' Meeting.
- The presentation of the Award will take place at OCSTA's 2017 AGM and Conference.

# **Evaluation Criteria**

- The nominee has distinguished himself/herself through service to their community and/or serving as a positive, inspiring role model to others. (40 points)
- The nominee has demonstrated outstanding leadership, philanthropic and/or service capabilities and orchestrated exceptional and meaningful change as leaders in their profession or community. (30 points)
- The nominee has reflected the characteristics of the Ontario Catholic School Graduate Expectations: (30 points)
  - a discerning believer formed in the Catholic faith community
  - $\circ$  an effective communicator
  - a reflective and creative thinker
- $\circ$  a lifelong learner
- $\circ$  a collaborative contributor
