#### STATEMENT OF POLICY

In keeping with the Mission, Vision and Values of the Niagara Catholic District School Board, the Niagara Catholic District School Board recognizes that playground equipment on its school sites has been provided through the participation of school and community groups in raising funds for its purchase, installation, inspection and maintenance in accordance with the guidelines on playground equipment.

The Board also encourages the formation of community partnerships to assist in the purchase, installation and maintenance of playground equipment and surfaces in accordance with the guidelines on playground equipment.

The Board recognizes the appropriate use of playground equipment and adult supervision, as well as the fact that that playground equipment will be utilized by the community outside of the normal school day.

The Director of Education will issue Administrative Guidelines for the implementation of this Policy.

## PLAYGROUND EQUIPMENT POLICY

Adopted: April 28, 1998 Policy No. 702.1

Revised: October 21, 2004

#### **ADMINISTRATIVE GUIDELINES**

#### **Definition**

For the purpose of this document, "Playground Equipment" is defined as a play structure, anchored to the ground, or two or more play structures that are attached or functionally linked that provide one or more play activity, and are for approved use in the play areas of Niagara Catholic Elementary Schools.

#### **New Playground Equipment**

- 1. All new installations of playground equipment must be reviewed and approved by the Controller of Plant in accordance with this Policy and Administrative Guidelines. The Controller of Plant and Plant Services staff will review items such as the age appropriateness of the proposed play structure, location, drainage, underground utilities (gas, water, telephone, cable, hydro, drainage pipes) and compliance with standards and regulations. As well, the resources allocated to the lifecycle maintenance of the equipment will be reviewed.
- 2. All equipment must comply with current working Standard: CAN/CSA Z614-07.
- 3. All playground equipment and installation must be purchased through Niagara Catholic Purchasing Services.
- 4. The Accessibility for Ontarians with Disabilities Act (AODA) compels School Boards to have their buildings, premises and structures accessible. Playgrounds are included in the Act. All new playground equipment installations must be AODA compliant (site to be accessible and equipment to include ground level accessible equipment for student enjoyment).
- 5. Effective September 2012, for all new playground installations, protective ground surfacing must be poured-in-place seamless chemical- binder/rubber-filler synthetic surface to a sufficient depth to achieve critical height protection per CAN/CSA Z614-2007. Loose fill surfacing is not acceptable.
- 6. Location of the equipment and construction/installation will take place under the direction and supervision of Plant Services.
- 7. All installed equipment becomes the property of the Board.
- 8. No equipment shall be installed without there being sufficient school generated funds for the ongoing inspection and maintenance of the equipment and grounds. (\$4,000 or more should be available every year for maintenance of the equipment or protective surfacing).

#### **Existing Playground Equipment**

1. Equipment that is deemed unsafe shall be put out of bounds to students pending repairs or removal. Equipment is to be removed from a school upon direction of the Controller of Plant, after consultation with the Principal, where repairs to the equipment to make it safe cannot be cost effectively implemented. Where playground equipment is removed or not installed at elementary schools, it will be the responsibility of the Board to provide active playground areas painted on the asphalt playground.

- 2. It is recommended that whenever possible preschool play facilities be separated from school-aged play facilities and the entire play area to be contained within a fenced perimeter. The inspection of such fenced play space for small children will be done by a qualified Playground Inspector appointed by the Daycare Provider. Any actions arising from the inspection report, renovations, repairs or replacements of equipment or surfacing material within this area will be the responsibility of the Daycare Provider.
- 3. To avoid skin contact on existing wood borders built with CCA pressure treated lumber, a cedar top cap must be secured to the existing border.
- 4. Principals shall maintain sufficient funds as determined by the Controller of Plant for the ongoing inspection and maintenance of the playground equipment and surfacing. (\$4,000 or more should be available every year for maintenance of the equipment or protective surfacing).

#### **Playground Equipment Near Facilities Under Construction**

- 1. Equipment that is within the construction site of a renovation or addition to the existing facility shall be put out of bounds to students until the construction is completed.
- 2. The playground equipment shall not be used until any disturbed protective surfacing has been restored according to the requirements of the current Standard and cleared for student use by Plant Services.

#### **Playground Safety**

Proper supervision is a key component to student safety on the playground.

The following steps, while not all encompassing, will assist staff in supervising students using playground equipment:

- ensure the equipment is used properly
- monitor and control the number of students who have access to the equipment
- enforce safety rules and sanction students not following the rules

#### Winter Use

The playground equipment is NOT safe for use if there is/are:

- 1. Freezing temperatures at temperatures below 0 C, very few types of protective ground surfacing remain resilient enough to offer any degree of protection to a falling child regardless of depth. Snow build-up snow can cause two problems on a play structure firstly, it can make play surfaces very slippery; secondly, it can create suffocation hazards if the openings at the end of tube slides or similar structures become closed in by drifting snow.
- 2. Ice or freezing rain ice or freezing rain can make play surfaces, hand grips and stairways very slippery, increasing the risk of slip and fall injuries.

Playground equipment cannot be operated safely under the winter conditions as described above, schools should place this equipment "off limits" during these conditions.

#### **Playground Risk Management Strategy**

In determining what is the best course of action to maintain playground equipment, a prioritization system will be introduced. The three priority levels that are applied to each piece of equipment are:

Priority #1 – Hazards which are life threatening or permanently disabling;

Priority #2 – Hazards which are serious and may cause non-disabling injury;

Priority #3 – Hazards that may cause slight injury, or equipment not in compliance with CSA Z614-07

The Risk Management Strategy shall be completed yearly by a playground inspector appointed by Plant Services.

#### **Playground Monitoring and Maintenance**

Monitoring should consist of retaining documentation of daily/weekly inspection reports by the custodian, with noted deficiencies and copies of completed work orders to validate that the deficiencies have been corrected. Custodians must maintain accurate logs to verify inspections of play equipment.

#### DAILY INSPECTION

A walk-through inspection must take place, each morning, prior to the students' arrival. The custodian must inspect for overnight vandalism to the structure itself, or harmful debris on and under the structure. This walk-through must be logged, and any action taken documented.

#### WEEKLY INSPECTION

A weekly inspection must be conducted by the custodian to check for loose bolts, wear, and the general security of the structure. Weekly inspections must be logged, and any action taken documented.

If a weakness is identified in a structure and it cannot be immediately repaired, the equipment must be removed from service until repairs can be made.

#### YEARLY INSPECTIONS

Every year a comprehensive written report must be prepared by a certified playground inspector appointed by Plant Services. These reports will be made available to the Principal in order to implement the necessary repairs.

Reported injuries that have occurred on the playground equipment must be recorded and immediately reported to the Principal, Family of School Superintendent and the Superintendent of Business & Finance with a copy to Plant Services

#### LARKIN ESTATE ADMISSION AWARDS 2012-2013

#### **BACKGROUND INFORMATION**

The Larkin Estate Admission Awards are administered by the Board of Trustees of the Niagara Catholic District School Board. Funding for the awards comes from a bequest from the estate of Maria Eveleen Larkin and Aimee Theresa Larkin. These awards have been administered annually since 1969 by the Board of Trustees of the former Lincoln County Roman Catholic District School Board.

The Larkin Estate Admission Award is available to graduates of a Catholic high school situated in the jurisdiction of the Niagara Catholic District School Board. Candidates must be enrolled in St. Michael's College, University of Toronto, or a school of nursing, social service work or a college or university offering such course.

The applicants have been made aware that they must provide proof that they have registered in the eligible courses and/or school in order to receive the award. This proof is in the form of an official letter from the registrar of either St. Michael's College or a school of nursing, social service work or a college or university offering such course. Candidates are also obliged to submit evidence of successful completion of their year's study in order to qualify for a renewal of the award.

According to the terms of the bequest, the undistributed earnings may be paid to eligible students who are approved by the Board. The Larkin Estate Admission Award is a four-year renewal program.

Based on the current account balance of \$6.001.41 and the projected interest revenue, we recommend that the Board approve the payment of the following scholarships on a go forward basis:

- 1) \$1,000 8 scholarships of \$125 for year 1 applicants
- \$2,250 9\$ scholarships of \$250\$ for year 2 applicants
- 3) \$1,000 7 scholarships of \$500 for year 3 applicants
- 4) \$500 1 scholarship of \$500 for a year 4 applicant

### NIAGARA CATHOLIC STRATEGIC DIRECTIONS SYSTEM PRIORITIES 2012-2013

#### **BACKGROUND INFORMATION**

In compliance with the April 24<sup>th</sup>, 2012 Board Motion approving the timeline for the submission of the Niagara Catholic Strategic Directions System Priorities for 2012-2013 and the Niagara Catholic Vision 2020 Strategic Plan, the Niagara Catholic Strategic Directions System Priorities 2012-2013 are presented for the Board's consideration. A poster size copy of the 2012-2013 Strategic Directions System Priorities will be placed in a public location in all schools, Board sites and the Catholic Education Centre for review by students, staff, parents and guests to Niagara Catholic. A copy will also be placed on the Board web and Facebook sites.

A Mid-Year Progress Review Report of the 2012-2013 System Priorities will be presented at the January 2013 Board Meeting with a Niagara Catholic System Priorities 2012-2013 Achievement Report presented at the September 2013 Board Meeting.

#### F. STAFF REPORTS

#### 1. <u>Dean Stunt-Principal, Elementary</u> ST. MARTIN CATHOLIC

- At St. Martin we are very proud of our processes to identify (through teacher, parent, student) areas in learning that are not progressing to their intended target. Through the use of the Niagara Catholic District School Board Problem Solving Model, analysis of data, observation and parent contact we have been successful in many areas but are especially pleased with the results from tackling issues with student mental health.
- We have participated with the SNAP program for the past three years. This joint initiative with The John Howard Society, Pathstone Mental Health, school and Board personnel we have successfully run SNAP programs for approximately a third of the student body. With the great collaboration of all stakeholders (Classroom Teacher, Educational Resource Teacher, Behaviour Resource Teacher, Principal, John Howard Society, Pathstone Mental Health, Big Brothers Big Sisters) we have been able to refer 22 students for individual and intense in-school therapy. As a result we are observing students making positive strides towards academic, social and emotional welfare. We are currently in the process of referring 5 more students and have had positive feedback from parents, students and staff of all organizations.

- The OSSLT has been completed, with Special Education students attempting the test to the best of their ability. We were impressed with the focus and determination the students exhibited during the test, indicating that they recognize the importance of the test and giving it their all. One of our resource teachers is currently scoring the OSSLT and his first hand insight into the test will be welcome upon his return.
- We are proud to report on the accomplishments of Andrew McClory, a student in the Special Education Class. He won a gold medal at SOSSA for swimming (the only sport that allows special education students to participate against all students). Andrew won the Athlete of the Month award at Blessed Trinity. He was also featured in a full page write-up in West Niagara News, our local paper. Andrew's interview conveyed how much he loves swimming and is enjoying his Grade 9 year at Blessed Trinity!
- Transition and IPRC meetings have begun. Resource staff are pleased to be part these
  crucial information sharing sessions with the feeder schools. The information shared at
  these sessions enables us to match all students with a kind, caring adult which makes the
  transition to secondary school very smooth, helping to alleviate initial anxiety of students
  and parents.
- The Special Education Cheerleading Team, the Thundercats and Coach Laura Sgambato (EA) will be recognized by the Town of Grimsby on April 18<sup>th</sup> when they will receive a *Grimsby Civic Recognition Certificate* for winning the **Spirit and Sportsmanship Awarded** at the Cheer Evolution National Championship.
- Thanks to amazing community spirit and the relationships that have been developed, Co-Op placements for students in the Special Education class have already been lined up for next year. We will continue working with Giant Tiger; the goal is to have next year's graduates' transition into post-secondary placements there. Thank you for your letter about special education training for teachers in Ontario's publicly funded school system. I am pleased to respond.

I appreciate your concerns about the very real challenges facing Ontario's teachers in their day-to-day work with students of differing ages and abilities. Our government recognizes teachers as the single most important factor in improving student achievement. We are committed to supporting teachers in every way possible.

The Ministry of Education continues to focus on improving the achievement of all students, including those with special education needs. Almost 81 percent of the students in Ontario's publicly funded schools who receive special education programs and services are placed in regular classrooms for more than half the instruction day. My ministry supports school boards' efforts to enhance the skills and knowledge of classroom teachers in topics such as assessing achievement in alternative areas, differentiated instruction, the development and implementation of effective Individual Education Plans and communicating effectively with parents.

The ministry has also developed resource documents to support classroom teachers. Examples include:

- Education for All: The Report of the Expert Panel on Literacy and Numeracy Instruction for Students With Special Education Needs, Kindergarten to Grade 6
- Draft Learning for All, K-12
- Effective Educational Practices for Students with Autism Spectrum Disorder
- Caring and Safe Schools in Ontario: Supporting Students with Special Education Needs Through Progressive Discipline, Kindergarten to Grade 12.

These resources recommend research-based practices that allow Ontario teachers, using an inclusive approach, to manage students with varying abilities in their classrooms, including students with special education needs. These documents may be accessed through the ministry's website at www.edu.gov.on.ca/eng/parents/speced.html or www.edu.gov.on.ca/eng/teachers/buildingfutures/resources.html

The ministry supports district school boards in their implementation of dedicated professional activity days to help assist classroom teachers working with students with special education needs. These resources are found on the Council of Ontario Directors of Education website at www.ontariodirectors.ca. Many challenges remain, but my ministry continues to work closely with school-boards, teachers-and-parents to provide the relevant information and practices to help students with special education needs.

The ministry also collaborates with the Ontario College of Teachers to set guidelines for the provision of special education training at the various faculties of education in the province. Training is offered through pre-service teacher training programs, as well as Additional Qualification Courses for teachers employed in school boards. In 2006, as part of *Preparing Teachers for Tomorrow*, the Ontario College of Teachers consulted with stakeholders regarding its teacher qualifications regulations. The College made a number of recommendations, including identifying special education as a required component within the program of professional education. The ministry continues to work with the College on these recommendations.

I trust that you will find this information helpful. Thank you again for your ongoing work to support the teaching profession.

Dear Minister Dombrowsky,

Halton District School Board's Special Education Advisory Committee has determined through consultation with our community and our member associations that one of the major deficits in our education system is professional development in the area of Special Education for Teachers, SERTS and Administrators. These professionals, who work daily with students with special education needs, are labouring without some basic tools. These tools would enhance the students' ability to access the curriculum as well as the ability of teachers to effectively deliver their services to the students.

Our SEAC participated in the O.C.T. review for Special Education A.Q s and we look forward to the result of that extensive survey as implemented changes filter down into meaningful experiences for special education students across the province.

We would like to ask the Ministry to change the necessary regulations to require new teachers to complete Special Education Part I as a mandatory qualification for receiving their Certificate of Qualification and Registration (in this we also support Niagara Catholic District School Board's letter of May 3rd). Indeed, Part I should be contained in the main body of the certification.

We also believe that Administrators and SERTS set the tone for the entire school in their service to students with special education needs. Many of our members were shocked to learn that administrators currently have no requirement for Special Education AQs. We believe that new Administrators should have at least Part I and that SERTS and teachers of self-contained classrooms should have Part I as a minimum with the intent to receive "Specialist" over a period of five years.



#### RE: SPECIAL EDUCATION SURVEY FOR CAREGIVERS

Dear Madame Minister,

The Peterborough Victoria Northumberland and Clarington Catholic District School Board's Special Education Advisory Committee (SEAC) believes in providing a voice for our parents/caregivers regarding special education services. The purpose of this letter is to formally request that the Ministry of Education create a province-wide special education survey for use by parents, students and other stakeholders.

It is a goal for the Ministry to enable parents and other caregivers to have their voices heard regarding special education; to be part of the team. Special education services in Ontario have seen many changes and reforms over the past ten years. We believe that the time has come to implement a consistent process which allows parents to provide detailed feedback regarding the special education services being delivered to children in their school board. An online survey tool would be an effective way to accomplish that goal.

In 2009 your Ministry made an important step forward in developing the online School Climate Survey which allows parents and other stakeholders to provide input toward the goal of creating safer schools and communities. We believe that an equally successful survey can be developed for the parents, guardians and educators of special needs students. Like the School Climate Survey, a version of the special education survey could also be developed which would allow students to have a voice regarding the programming they receive.

Once completed, school boards, educators and SEAC's would be able to review survey results in order to assist with planning new initiatives, validating existing best practices, and finding out about the issues and concerns of parents, caregivers and students.

A standard survey developed by the Ministry would have several important benefits: a consistent format used across the province, individual survey items could be easily revised and updated to reflect current issues and Ministry initiatives and, it would be far more cost effective to have one survey developed by the Ministry rather than to have individual school boards attempt to take on this challenging task. The result would be a high quality, state-of-the-art web-based tool which would allow for parent engagement and the opportunity for student voices to be heard while avoiding needless expenditure of precious education funding on a task which would be beyond the capacity of many small to medium sized school boards.

It is our sincere hope that you will consider this request and provide the province with an online survey tool to assist parents and educators in more effectively working together to improve the achievement outcomes for all our special needs students.

#### Dear Chair,

I am writing to invite all school board Chairs and Directors of Education to participate in a conference call to begin a consultation on school boards restructuring and amalgamation with a view to the long-term sustainability of our publicly funded education system. As you know, the 2012 Ontario Budget indicated that following consultation, the Ministry of Education will work with boards and their communities to ensure that student needs are put first in any amalgamation.

I will be chairing this teleconference with Deputy Minister George Zegarac on Tuesday, May 29 at 3:30 p.m.

In light of our shared fiscal reality, the Ministry of Education, like all other ministries, has had to find areas of significant savings. Our choice is to protect the gains we have made together in student achievement and in the classroom experience. This includes the rollout of full-day kindergarten, smaller class sizes and preserving 20,000 teaching and support staff jobs.

Finding greater efficiencies in how we deliver education will help to achieve our fiscal targets. We have an opportunity to be creative and innovative as we work together to ensure that student needs are met.

Before I outline the process moving forward, I want to make it clear that at no point are we looking to merge separate and public boards or French and English boards. Also, it is important that this approach be different from the last time the Ministry of Education amalgamated boards in the late 1990s. On our teleconference, I welcome the opportunity to discuss the lessons learned from previous amalgamation efforts, and talk about how we can work together to develop our plan moving forward.

Some of you may know that in my previous role as Minister of Children and Youth Services, I worked closely with Deputy Zegarac and our partners in the child welfare sector to find opportunities and efficiencies. Children's Aid Societies worked to find creative partnerships and innovative approaches that not only saved money, but meant better care for kids. That is the approach we would like to take here.

The 2012 Ontario Budget included a target of \$10.5 million in system savings for fiscal 2013-14 and \$16.7 million for fiscal 2014-15. By working together, we can develop a plan that meets these savings while considering ideas and sharing insights on best practice for the future sustainability of our education system.

We need to move quickly to meet the 2013-14 target but it is equally important to involve you in the process and to get it right. As such, I have asked Deputy Zegarac and ministry staff to begin sector consultations with your board staff in June. Your staff will receive more information regarding these discussions under a separate cover. As well, more detailed discussions with board chairs, trustees, teacher federations and other partners will follow throughout the summer.

Our intent is to develop a strategy based on what we learn through consultation and bring the strategy back to you for your consideration before the end of September 2012. The goal is to finalize the restructuring plans no later than early in 2013.

While I have been clear that we have no intention of restructuring across the existing boundaries of faith or language, I still encourage you to continue the work you have been doing to find efficiencies in consolidating back-office activities. This work is also critical because it helps ensure the best value for every dollar spent in education.

I know that by working together in the same spirit of partnership that has served us well in the past we can find the efficiencies we need for the long term, while continuing to meet student needs and strengthen publicly funded education in Ontario. We owe it to the students to continue to put their interests first as we work together.

### **Trustees Review Strategic Directions**


